**The Legal Aid and Advice and Assistance  
(Solicitors' Travel Fees) (Scotland) Regulations 2011**

<i>Coming into force</i>	- -	<i>28th February 2011</i>

The Scottish Ministers make these Regulations in exercise of the powers conferred by section 33(2) and (3) of the Legal Aid (Scotland) Act 1986(1) and all other powers enabling them to do so.

**Citation and commencement**

1. These Regulations may be cited as the Legal Aid and Advice and Assistance (Solicitors' Travel Fees) (Scotland) Regulations 2011 and come into force on 28th February 2011.

**Application**

2. These Regulations apply only in respect of travel commenced on or after 28th February 2011.

**Amendment of the Civil Legal Aid (Scotland) (Fees) Regulations 1989**

3. In the Civil Legal Aid (Scotland) (Fees) Regulations 1989(2)—

(a) in Schedule 3(3), after paragraph 5 insert—

“5A. The fee for each quarter hour (or part thereof) spent travelling—	
(a) by a solicitor	£5.45
(b) by a solicitor's clerk	£2.70”;

#### **Amendment of the Criminal Legal Aid (Scotland) (Fees) Regulations 1989**

4. In Schedule 1 to the Criminal Legal Aid (Scotland) (Fees) Regulations 1989(6), in Part 1 of the Table of Fees, after paragraph 5 insert—

“5A. The fee for each quarter of an hour spent travelling—	
(a) by a solicitor	£5.28      £6.34
(b) by a solicitor’s clerk	£2.63      £3.17”

#### **Amendment of the Legal Aid in Contempt of Court Proceedings (Scotland) (Fees) Regulations 1992**

5. In Schedule 1 to the Legal Aid in Contempt of Court Proceedings (Scotland) (Fees) Regulations 1992(7), after paragraph 4 insert—

- “4A. The fee for each quarter of an hour (or part thereof) spent travelling—
- (a) by a solicitor is £5.28;
  - (b) by a solicitor’s clerk is £2.63.”.

#### **Amendment of the Advice and Assistance (Scotland) Regulations 1996**

6. In Schedule 3 to the Advice and Assistance (Scotland) Regulations 1996(8)—

- (a) in Part I, after paragraph 4 in the table of fees insert—

---

“4A. The fee for each quarter of an hour (or part thereof) spent travelling—	
(a) by a solicitor	£5.28      £6.38
(b) by a solicitor’s clerk	£2.63      £3.18”;

- (b) in Part II, after paragraph D in the table of fees insert—

---

“DA. The fee for each quarter of an hour (or part thereof) spent travelling—	
(a) by a solicitor	£5.80      £6.38      £6.38

## EXPLANATORY NOTE

*(This note is not part of the Regulations)*

These Regulations amend the fees payable to solicitors, and their clerks, for travelling in connection with the provision of advice and assistance (including assistance by way of representation) and legal aid.
