Uprating and miscellaneous amendments

25. In Schedule 3 (sums to be disregarded in the calculation of income other than earnings), after paragraph 18 insert—

"18A.—(1) Any payment made in respect of a person who is a member of the applicant's family—

- (a) in accordance with an adoption allowance scheme made under section 71 of the Adoption and Children (Scotland) Act 2007(1) (adoption allowances schemes) or pursuant to regulations under section 2(6)(b), 3 or 4 of the Adoption and Children Act 2002(2);
- (b) which is a payment made by a local authority in pursuance of section 50 of the Children Act 1975(3) (payments towards maintenance of children) or section 15(1) of, and paragraph 15 of Schedule 1 to, the Children Act 1989(4) (local authority contribution to a child's maintenance where the child is living with a person as a result of a residence order);
- (c) which is a payment made by an authority, as defined in article 2 of the Children (Northern Ireland) Order 1995(5), in pursuance of article 15 of, and paragraph 17 of Schedule 1 to, that Order (contribution by an authority to child's maintenance); or
- (d) in accordance with regulations made pursuant to section 14F of the Children Act 1989(6) (special guardianship support services).
