**The Genetically Modified Organisms (Deliberate Release etc.)  
(Miscellaneous Amendments) (Scotland) Regulations 2019**

**Amendment to the Genetically Modified Organisms (Deliberate Release) (Scotland)  
Regulations 2002**

3. In regulation 2(1) (interpretation)—
- (a) in the definition of “approved product”, after “granted” insert “, by a person other than the Scottish Ministers,”,
  - (b) for the definition of “the Contained Use Directive”, substitute—

““the Contained Use Directive” means [Directive 2009/41/EC](#) of the European Parliament and of the Council on the contained use of genetically modified micro-organisms(1),”
  - (c) in the definition of “the Deliberate Release Directive”, for “as amended by” to the end substitute “, as last amended by Commission Directive (EU) 2018/350(2)”,
  - (d) for the definition of “1990 Directive” substitute—

““1990 Directive” means Council [Directive 90/220/EEC](#) on the deliberate release into the environment of genetically modified organisms(3), as it had effect before it was repealed by [Directive 2001/18/EC](#) of the European Parliament and of the Council on the deliberate release into the environment of genetically modified organisms and repealing Council [Directive 90/220/EEC\(4\)](#),”
  - (e) for the definition of “the First Simplified Procedure (crop plants) Decision” substitute—

““the First Simplified Procedure (crop plants) Decision” means Commission [Decision 94/730/EC](#) establishing simplified procedures concerning the deliberate release into the environment of genetically modified plants pursuant to Article 6(5) of Council [Directive 90/220/EEC\(5\)](#),”
  - (f) for the definition of “the Food and Feed Regulation” substitute—

““the Food and Feed Regulation” means Council Regulation ([EC](#)) No 1829/2003 on genetically modified food and feed(6),” and
  - (g) omit the definition of “Regulation 2309/93”.
