POLICY NOTE

THE SCOTTISH ELECTIONS (REFORM) ACT 2020 (COMMENCEMENT NO. 1) REGULATIONS 2020

SSI 2020/278 (C. 23)

The above instrument was made by the Scottish Ministers in exercise of the powers conferred by section 35(2) of the Scottish Elections (Reform) Act 2020. The instrument is not subject to any parliamentary procedure.

Purpose of the instrument.

The Regulations commence a number of provisions in the Scottish Elections (Reform) Act 2020 ("the 2020 Act")¹. The commenced provisions will make changes in relation to the Scottish Parliament (including moving from four to five year terms), voting pilot schemes, attainment, the Electoral Commission and the Electoral Management Board for Scotland (EMB). The rest of the 2020 Act, including Part 4 in relation to Boundaries Scotland, is expected to be commenced in 2021.

Policy Objectives

The 2020 Act sets out a number of changes in respect of Scottish Parliament and local government elections in Scotland. It will change the terms for Scottish Parliament and local government from four to five years; make provision about the role of the Electoral Commission in relation to those elections; confer functions on the Electoral Management Board for Scotland in relation to Scottish parliamentary elections; and makes provision about the Local Government Boundary Commission for Scotland (LGBCS), including renaming it Boundaries Scotland.

These Regulations will commence the following provisions of the 2020 Act on 1 October 2020:

Commencement of the remaining provisions of the 2020 Act is intended to occur in 2021, in discussion with relevant stakeholders, such as the LGBCS in relation to sections 4 and 28 to 33.

Consultation

The policy objectives of the 2020 Act was subject to parliamentary scrutiny as a part of the parliamentary process² for the 2020 Act. The Policy Memorandum³ for the Bill that preceded the 2020 Act outlined the results of the Government consultation exercise conducted in relation to electoral reform held over 2017-18.

Commencement on 1 October 2020 of the provisions identified in these Regulations is a result of discussion on timing with the Electoral Commission and other electoral professionals.
