The Social Security Co-ordination (EU Exit) (Scotland) (Amendments etc.) Regulations 2020

Revocation of [^{F1}assimilated direct] legislation

7. The following [^{F2}assimilated direct] legislation is revoked in so far as it has effect in relation to devolved social security matters—

- (a) Regulation (EC) No 883/2004 of the European Parliament and of the Council of 29 April 2004 on the coordination of social security systems⁽¹⁾,
- (b) Regulation (EC) No 987/2009 of the European Parliament and of the Council of 16 September 2009 laying down the procedure for implementing Regulation (EC) No 883/2004⁽²⁾,
- (c) Regulation (EEC) No 1408/71 of the Council of 14 June 1971 on the application of social security schemes to employed persons, to self-employed persons and to members of their families moving within the Community⁽³⁾,
- (d) Regulation (EEC) No 574/72 of 21 March 1972 fixing the procedure for implementing Regulation (EEC) No 1408/71 on the application of social security schemes to employed persons and their families moving with the community⁽⁴⁾, and
- (e) Council Regulation (EC) No 859/2003 of 14 May 2003 extending the provisions of Regulation (EEC) No 1408/71 to nationals of third countries who are not already covered by those provisions solely on the ground of their nationality⁽⁵⁾.
