Excluded accommodation

1. Excluded accommodation means a dwellinghouse which is, or is part of—

- F1(a)
- F2(b)
- F3(c)
- F4(d)
- (e) residential accommodation where [F5personal care is provided to residents],
- (f) a hospital or nursing home,
- (g) a residential school, college or training centre,
- (h) secure residential accommodation (including a prison, young offenders institution, detention centre, secure training centre, custody centre, short-term holding centre, secure hospital, secure local authority accommodation or accommodation used as military barracks),
- (i) a refuge,
- (j) student accommodation,

- [F7(l) premises in respect of which a premises licence within the meaning of section 17 of the Licensing (Scotland) Act 2005 has effect and where the provision of accommodation is an activity listed in the operating plan as defined in section 20(4) of that Act.]
