### ROAD TRAFFIC

# The A9 Trunk Road (Brora) (Temporary Prohibition On Use of Road) (No. 2) Order 2021

*Made - - - - 20th December 2021* 

Coming into force - - 1st January 2022

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1) and (2), 4(1) and 16A of the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

In accordance with section 16A(2) of that Act, they are satisfied that the traffic on the length of road specified in the schedule should be restricted or prohibited for the purpose of facilitating the holding of a relevant event and enabling members of the public to watch that relevant event.

In accordance with section 16A(3) of that Act, they are satisfied that it is not reasonably practicable for the event to be held otherwise than on a road.

In accordance with section 16A(8) of that Act, they have had regard to the safety and convenience of alternative routes suitable for the traffic which will be affected by this Order.

#### Citation, commencement and cessation

**1.** This Order may be cited as the A9 Trunk Road (Brora) (Temporary Prohibition On Use of Road) (No. 2) Order 2021, comes into force on 1 January 2022 and ceases to have effect on 2 January 2022.

#### Prohibition on use of road

2. No person may use or permit the use of, any vehicle on the length of road, or a part or parts of the length of road, specified in the schedule of this Order when a prohibition is identified as applying to that length of road, or a part or parts of that length of road, by means of a traffic sign of the type described in item 8 (diagram 7105 - position of the barrier to mark length of road closed or to guide traffic past an obstruction) of the sign table in Part 6 of schedule 13 of the Traffic Signs Regulations and General Directions 2016(b).

## **Exemptions**

- 3. No prohibition imposed by this Order applies to—
  - (a) a vehicle being used in an emergency for fire brigade, ambulance, police or coastguard purposes, or
  - (b) a vehicle being used for facilitating the holding of the relevant event.

# **SCHEDULE**

Article 2

# SPECIFIED LENGTH OF ROAD

That length of the M9/A9 Edinburgh – Stirling – Thurso Trunk Road from its junction with Gower Street, Brora in a generally northwards direction to its junction with Academy Street, Brora, a distance of 700 metres or thereby.
