These Regulations amend Commission Decision 2000/572/EC which lays down animal and public health and veterinary certification conditions for imports of meat preparations from third countries. Regulation 2 amends Article 4za of Commission Decision 2000/572/EC which modifies the import conditions for imports of meat preparations from countries and territories subject to special transitional import arrangements (EEA states, the Faroe Islands, Greenland and Switzerland). It amends Article 4za to provide that the import condition that meat preparations have been deep frozen at the production plant or plants of origin does not apply until 1 January 2023, where the
