**ROAD TRAFFIC**

**The A737 Trunk Road (Howwood) (Temporary 30mph Speed  
Restriction) Order 2022**

*Made* - - - - 27th July 2022

*Coming into force* - - 8th August 2022

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1), 4(1) and 14(1)(a) and (4) of the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

In accordance with section 14(1)(a) of that Act, they are satisfied that the traffic on the length of road specified in the schedule should be restricted because works are being or are proposed to be executed on or near that length of road.

In accordance with section 14(3) of that Act, they have had regard to the existence of alternative routes suitable for the traffic which will be affected by this Order.

**Citation, commencement and cessation**

1. This Order may be cited as the A737 Trunk Road (Howwood) (Temporary 30mph Speed Restriction) Order 2022, comes into force on 8 August 2022 and ceases to have effect on 30 September 2022.

**Speed restriction**

2. No person may use, or permit the use of, any vehicle on the length of road, or a part or parts of a length of road, specified in the schedule of this Order at a speed exceeding 30 miles per hour when a restriction is identified as applying to that length of road, or a part or parts of that length of road, by means of a traffic sign of the type described in item 1 (diagram 670 – maximum speed limit in mph) of the sign table in Part 2 of schedule 10 of the Traffic Signs Regulations and General Directions 2016(b).

The functions of the Secretary of State were transferred to the Scottish Ministers by section 53 of the Scotland Act 1998 (c. 46).

### **Exemption**

**3.** No speed restriction imposed by this Order applies to—

- (a) vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011<sup>(a)</sup> when used in accordance with regulation 3(5) of those Regulations, or
- (b) vehicles being used in an emergency for coastguard purposes.

## SCHEDULE

Article 2

### SPECIFIED LENGTH OF ROAD

That length of the A737/A738 St James Interchange – Kilwinning – Hawkhill Trunk Road from a point 100 metres or thereby east of its junction with the B787 at the Elliston Junction near Howwood in a generally south-westwards direction to a point 360 metres or thereby west of its junction with the B787 at the Elliston Junction near Howwood, a distance of 500 metres or thereby.
