1. On an appeal or complaint under section 1(3A) of the Lands Tribunal Act 1949 (valuation for rating)–	
(a) where the net annual value does not exceed £10,000	£100
(b) where the net annual value exceeds £10,000 but not £50,000	£150
(c) where the net annual value exceeds £50,000 but not £100,000	£300
(d) where the net annual value exceeds £100,000	£500
2. On an appeal under section 1(3BA) of the Lands Tribunal Act 1949 (non-referral of valuation appeal or complaint)	£78
<b>Hearing Fees, etc.</b>	
3. On the hearing of a matter referred under section 1(3A) of the Lands Tribunal Act 1949 (valuation for rating)–	
(a) Where the amount is determined in terms of a lump sum–	£50 in respect of every £5,000 or part of £5,000 of such lump sum but not less than £155 for each day on which the Tribunal sits and not exceeding in any case £5,000
(b) Where the amount is determined in terms of rent or other annual payment–	£50 in respect of every £500 or part of £500 of such rent or other annual payment but not less than £155 for each day on which the Tribunal sits and not exceeding in any case £5,000
(c) Where there is a settlement as to amount, for each day on which the Tribunal sits	£155
4. On the hearing of any other application or appeal or reference including the hearing of preliminary pleas-in-law or legal debates in which no fee is payable by reference to an amount determined	£155 for each day on which the Tribunal sits
