The Registration of Births, Still-births, Deaths and Marriages (Prescription of Forms) (Scotland) Amendment Regulations 2023

Made - - - - 10th January 2023

Laid before the Scottish Parliament 12th January 2023

Coming into force - 1st February 2023

The Registrar General makes the following Regulations in exercise of the powers conferred by sections 44(4) and 54(1)(b) of the Registration of Births, Deaths and Marriages (Scotland) Act 1965(a), and all other powers enabling her to do so.

In accordance with section 54(1) of the Registration of Births, Deaths and Marriages (Scotland) Act 1965(b), the Scottish Ministers have approved the making of these Regulations.

Citation and commencement

1. These Regulations may be cited as the Registration of Births, Still-births, Deaths and Marriages (Prescription of Forms) (Scotland) Amendment Regulations 2023 and come into force on 1 February 2023.

Amendment of the Registration of Births, Still-births, Deaths and Marriages (Prescription of Forms) (Scotland) Regulations 1997

2.—(1) The Registration of Births, Still-births, Deaths and Marriages (Prescription of Forms) (Scotland) Regulations 1997(c) are amended as follows.

(2) For the form in schedule 25 (Register of Corrections Etc.), substitute the form in the schedule of these Regulations.
