### MISSION

#### *Mission initiatives*

#### **81 Visitors**

(1) A bishop's mission order shall designate a person, to be known as “the Visitor”, who shall <sup>F1</sup>...—

(a) [<sup>F2</sup>on behalf of the bishop or bishops] exercise oversight of the mission initiative and advise and encourage and, so far as practicable, provide support for it;

(c) report regularly to the bishop or bishops on the discharge of his or her duties and the progress of the mission initiative and send copies of the reports to the leader or leaders;

[<sup>F5</sup>(1A) The Visitor may take such other steps as the Visitor thinks fit for ensuring the proper governance of the mission initiative.]

(2) The leader or leaders shall—

(a) consult the Visitor regularly about the general direction and development of the mission initiative, and

(b) supply the Visitor with a copy of the annual accounts and any other information which the Visitor requires in order to carry out his or her functions.
