Amendments to the Energy Information Regulations 2011

- **9.**—(1) Schedule 1 to the Energy Information Regulations 2011(1) (product-specific measures) is amended as follows.
 - (2) In paragraph 1—
 - (a) in the opening words, omit "from the date in column 3";
 - (b) in the table—
 - (i) omit column 3;
 - (ii) omit the entry relating to "Household electric ovens";
 - (iii) for the entry relating to "Household refrigerators, freezers and their combinations" substitute—
