

**EXPLANATORY MEMORANDUM TO**  
**THE ROSSENDALE (ELECTORAL CHANGES) ORDER 2024**

**2024 No. [XXXX]**

**1. Introduction**

1.1 This explanatory memorandum has been prepared by the Local Government Boundary Commission for England and is laid before Parliament by Command of His Majesty.

**2. Purpose of the instrument**

2.1 The Order provides for new borough wards and numbers of councillors for Rossendale at the borough elections in 2024 and thereafter.

**4. Extent and Territorial Application**

4.1 The territorial extent of this instrument is England and Wales.

4.2 The territorial application of this instrument is England.

**5. European Convention on Human Rights**

5.1 As the instrument is subject to negative resolution procedure and does not amend primary legislation, no statement is required.

**6. Legislative Context**

6.1 The Commission has power under section 59 of the Local Democracy, Economic Development and Construction Act 2009 (the 2009 Act) to make an order giving effect to recommendations contained in a report, prepared under section 58(4) of the 2009 Act, after conducting an electoral review under section 56(1) of that Act. This instrument is being made to give effect to the Commission's recommendations for new electoral arrangements set out in its report prepared following an electoral review of Rossendale Borough Council.

**7. Policy background**

*What is being done and why?*

7.1 The purpose of an electoral review is to decide on the appropriate electoral arrangements including the number of councillors and the names, number and boundaries of wards or divisions for a specific local authority. The Commission began the electoral review of Rossendale Council in September 2022. The Commission decided to conduct the review as it had been more than twenty years since the previous electoral review of the borough and the Commission is required to review all principal local authorities in England 'from time to time'.

- 7.2 An electoral review aims to ensure that the number of electors represented by each councillor is as close to equal as possible, but the recommendations must also have regard to community identities and interests and the need for effective and convenient local government. To achieve these aims, the Commission tries to ensure that the number of electors per councillor in every division or ward is as close as possible to the average for the authority, but is happy to show flexibility in moving away from the average based on the evidence provided during the consultation stages of the review. Following a four-stage review process the Commission published its ‘New electoral arrangements for Rossendale Council - Final Recommendations’<sup>1</sup> on 1 August 2023
- 7.3 The Order provides for changes to the electoral arrangements for Rossendale Council at the borough elections in 2024 as recommended by the Commission. The existing wards of the Council will be replaced by ten new ones, all of which will each return three councillors. The Commission considered that the evidence received justified one ward having an electoral variance of greater than 10% from the authority average by 2028.
- 7.4 Under section 56 of the 2009 Act, whenever the Commission recommends changes to the electoral arrangements for a borough, district or county council it must also recommend whether, in consequence of those changes, any changes should be made to the electoral arrangements for any parish council that is within the authority. Among other things, under Schedule 2 to that Act, recommendations must ensure that no parish ward is split between new borough wards, and under section 56 of that Act, recommendations must be made regarding the number of parish councillors for each parish ward.
- 7.5 In the case of Rossendale Council, the authority contains one parish which is not being divided between more than one ward, so no changes of this nature are being made.

## **8. European Union Withdrawal and Future Relationship**

- 8.1 This instrument does not relate to withdrawal from the European Union.

## **9. Consolidation**

- 9.1 This Instrument does not amend or revoke any legislation.

## **10. Consultation outcome**

- 10.1 The Order gives effect to recommendations that were consulted on during the review of electoral arrangements from September 2022 to May 2023. During the course of the review, the Commission received approximately 90 representations. The consultations involved the Borough Council, parish and town councils, local MPs, local residents and other interested parties. There was an initial ten-week consultation, during which the Commission asked for proposals on the most appropriate ward boundaries for the borough. The Commission considered that a council size of 30 would ensure effective and convenient local government for the authority. Having considered the submissions received, the Commission published its ‘New electoral

arrangements for Rossendale Council – Draft Recommendations’<sup>2</sup> on 7 March 2023. Following a ten-week consultation on the draft recommendations, the Commission considered the further evidence received and published its final recommendations.

- 10.2 In response to the consultation on the draft recommendations, the Commission modified its recommendations for Longholme and Hareholme & Waterfoot wards because of evidence that this would improve electoral equality and better reflect the community identity of these areas. It also recommended that the proposed Haslingden South & Edenfield ward be re-named Greenfield & Eden, and that the proposed Haslingden North ward be renamed Haslingden.
- 10.3 The Commission confirmed its draft recommendations for the remainder of the borough as final.
- 10.4 A detailed analysis of the outcome of the consultation is set out in the report ‘New electoral arrangements for Rossendale Council – Final Recommendations’ dated August 2023. As indicated in the Order, the mapping referred to in the Order is normally accessible at all reasonable times at the Commission’s offices. If any person wishes to view the map and the report, the Commission will consider this and seek to make appropriate arrangements. Moreover, the relevant map, as well as the report are accessible on our website, which is available at <https://www.lgbce.org.uk/all-reviews/rossendale>.

## **11. Guidance**

- 11.1 The Commission does not intend to issue any guidance alongside this instrument. This is not considered necessary as the Order is self-explanatory and gives effect to recommendations following consultation with interested parties as to the changes to electoral arrangements.

## **12. Impact**

- 12.1 There is no, or no significant, impact on business, charities or voluntary bodies.
- 12.2 The impact on the public sector will be limited to the area for which the Order makes provision. The one-off cost of producing the map referred to by the instrument is to be funded by the Commission. The one-off cost of amending the electoral register to reflect the new wards is to be funded by Rossendale Council.
- 12.3 A full Impact Assessment has not been prepared for this instrument because the impact is limited and relates to the specific local authority area under review.

## **13. Regulating small business**

- 13.1 The legislation does not apply to activities that are undertaken by small businesses.

## **14. Monitoring & review**

- 14.1 The Commission will have no role in monitoring the Council’s implementation of the Rossendale (Electoral Changes) Order 2024. The Commission is not required to undertake such monitoring; that is a matter for the relevant officers of Rossendale Council. The Order will be reviewed insofar as the Commission continually monitors local authorities in England to identify any that meet its criteria for electoral reviews.
