An Act to confirm a Provisional Order relating to the
county borough of Rotherham. [5th August 1965]

WHEREAS under the provisions, of the Public Health 1875 c. 55.
Act 1875, the Public Health Act 1936 and the Food and 1936 c. 49.
Drugs Act 1955 the Minister of Housing and Local 1955 c. 16.
Government has made a Provisional Order which needs con-
firmation by Parliament:

Be it therefore enacted by the Queen's most Excellent Majesty,
by and with the advice and consent of the Lords Spiritual and
Temporal, and Commons, in this present Parliament assembled,
and by the authority of the same, as follows:—

1. The order of the Minister of Housing and Local Government Confirmation
which is set out in the schedule to this Act is hereby confirmed of order in
and shall have full validity and force. schedule.

2. This Act may be cited as the Ministry of Housing and Local Short title.

COUNTY BOROUGH OF ROTHERHAM

Provisional Order amending a Local Act

The Minister of Housing and Local Government, on the application of the council of the county borough of Rotherham and in exercise of his powers under section 303 of the Public Health Act 1875, section 317 of the Public Health Act 1936 and section 131 of the Food and Drugs Act 1955, and all other powers enabling him in that behalf, hereby orders as follows:—

Citation

1.—(1) This order may be cited as the Rotherham Order 1965 and shall come into operation on the date of the Act of Parliament confirming it.

(2) In this order, “the Act of 1937” means the Rotherham Corporation Act 1937.

Amendment
 of local Act.

2. The Act of 1937 shall be amended as follows:—

(1) In schedule 5 paragraphs (7) to (13) (which specify charges relating to the use of the abattoir and to lairage) shall be omitted.

(2) In section 70(1) the words “and abattoir” shall be omitted.

(3) After section 70(2) there shall be inserted the two following subsections:—

“ (3) The Corporation may, with the approval of the Minister of Housing and Local Government, from time to time alter or add to the stallages, tolls and charges referred to in the fifth schedule to this Act, and any such altered stallages, tolls or charges shall, as from the date on which they come into operation, be substituted for the corresponding stallages, tolls or charges referred to in the fifth schedule to this Act.

Local inquiries.

(4) (a) The Minister of Housing and Local Government may cause such local inquiry to be held as he may consider necessary for the purpose of any of his functions under this section.

(b) Subsections (2) to (5) of section 290 of the Local Government Act 1933 (which relate to the giving of evidence at inquiries and the payment of costs) shall apply to inquiries held under this section.”
