

CHAPTER lxxvii.

An Act to confirm certain Provisional Orders of the A.D. 1903. Local Government Board relating to Barry Fenton Leeds and Tonbridge and the Ports of Hartlepool and Manchester. [21st July 1903.]

WHEREAS the Local Government Board have made the Provisional Orders set forth in the schedule hereto under the provisions of the Public Health Act 1875:

38 & 39 Vict.

And whereas it is requisite that the said Orders should be c. 55. confirmed by Parliament and that the provisions herein contained should be enacted with reference to certain of such Orders:

Be it therefore enacted by the King's most Excellent Majesty by and with the advice and consent of the Lords Spiritual and Temporal and Commons in this present Parliament assembled and by the authority of the same as follows:-

1. The Orders set out in the schedule hereto shall be and the Orders in same are hereby confirmed and all the provisions thereof shall schedule subject to the provisions of this Act have full validity and force.

2. The authorities mentioned in the Orders relating to Restriction Barry Fenton Leeds and Tonbridge hereby confirmed shall not of power to take houses under the powers of those Orders purchase or acquire ten or more of labouring houses which on the fifteenth day of December last were occupied class. either wholly or partially by persons belonging to the labouring class as tenants or lodgers or except with the consent of the Local Government Board ten or more houses which were not so occupied on the said fifteenth day of December but have been or shall be subsequently so occupied.

The expression "labouring class" means mechanics artizans Definition of labourers and others working for wages hawkers costermongers labouring

- A D. 1903. persons not working for wages but working at some trade or handicraft without employing others except members of their own family and persons other than domestic servants whose income does not exceed an average of thirty shillings a week and the families of any of such persons who may be residing with them.

The Council shall be empowered to put in force with reference to the lands described in the schedule hereto subject to the continuance of existing public rights of highway (if any) and for the purposes aforesaid the powers of the Lands Clauses Acts with respect to the purchase and taking of lands otherwise than by agreement or any of them.

Hartlepools Order.

To the Hartlepool Port Sanitary Authority; -

To the Mayor Aldermen and Burgesses of the Boroughs of Hartlepool and West Hartlepool; ---

And to all others whom it may concern.

WHEREAS by a Provisional Order of the Local Government Board dated the First day of April One thousand eight hundred and eighty-one (hereinafter referred to as "the Order of 1881;") and confirmed by the Local Government Board's Provisional Orders Confirmation (Bath &c.) Act 1881 44 Vict. c. xv. a Joint Board was constituted the Hartlepool Port Sanitary Authority (herein-after referred to as "the Port Sanitary Authority") for the part of the Customs Port of Hartlepool therein described and by virtue of that Order as altered by Section 10 of the Hartlepool Borough Extension Act 1883 that 46 & 47 Vict. Joint Board now consists of representatives of the Town Councils of the Boroughs of Hartlepool and West Hartlepool as Riparian Authorities;

And whereas by another Provisional Order of the Local Government Board dated the Twenty-first day of May One thousand eight hundred and eighty-five (herein-after referred to as "the Order of 1885") and confirmed by the Local Government Board's Provisional Orders Confirmation (No. 6) 48 & 49 Vict. Act 1885 (herein-after referred to as "the Act of 1885") it was provided that in addition to the powers conferred upon them by the Order of 1881 the Port Sanitary Authority should have the powers of a Joint Board under the provisions of the Public Health Act 1875 as if the same were a Joint Board for an United District constituted under Section 279 of that Act for the purpose of the provision maintenance and management of a hospital or hospitals for the reception of cases of infectious diseases occurring in the Urban Sanitary Districts of Hartlepool and West Hartlepool and the Port Sanitary District;

And whereas by virtue of the above-cited Orders the Borough of Hartlepool (Extension) Order 1897 the Borough of West Hartlepool (Extension) Order 1897 (which two last-mentioned Orders were confirmed by the Local Government Board's Provisional Orders Confirmation (No. 11) Act 1897) and the Borough of West Hartlepool Order 1902 (which was confirmed by the Local Government Board's Provisional Orders Confirmation 2 Edw. 7. (No. 12) Act 1902) the Port Sanitary Authority now has and exercises the powers conferred by the Order of 1885 in relation to the Boroughs of Hartlepool and West Hartlepool and the Port Sanitary District;

And whereas it is expedient that in relation to the Boroughs of Hartlepool and West Hartlepool the Port Sanitary Authority should cease

to have or exercise the powers conferred by the Order of 1885 for hospital purposes that the Act of 1885 so far as it relates to the Order of 1885 should be repealed and that provision should be made for the adjustment of liabilities and property affected by the cesser of powers and repeal as aforesaid and for the exercise discharge and regulation of the powers and duties of the Port Sanitary Authority with regard to hospital purposes in relation to the Port Sanitary District:

Now therefore We the Local Government Board in pursuance of the powers given to Us by Section 297 of the Public Health Act 1875 and by any other Statutes in that behalf do hereby order that from and after the Thirtieth day of September One thousand nine hundred and three (hereinafter referred to as "the commencement of this Order") the following provisions shall have effect:—

Cesser of hospital powers under Order of 1885.

Art. I. The Act of 1885 so far as it relates to the Order of 1885 shall be repealed and subject to the provisions of this Order the Port Sanitary Authority shall cease to have or exercise the powers conferred by that Order for the provision maintenance and management of a hospital or hospitals for the reception of cases of infectious diseases occurring in the Boroughs of Hartlepool and West Hartlepool.

Hospitals to vest in Port Sanitary Authority for Port Sanitary purposes. Art. II. Subject to the provisions of this Order and from and after the commencement of this Order all lands and premises and property theretofore provided by vested in or in the possession of or belonging to the Port Sanitary Authority for hospital purposes in pursuance of the Order of 1885 shall subject to the provisions of the Order of 1881 vest in and be held by or be in the possession of or belong to the Port Sanitary Authority exclusively for the benefit and purposes of the Port Sanitary District:

Provision for temporary arrangements with Town Councils. Provided that pending the provision of suitable hospital accommodation by the Town Council of the Borough of Hartlepool and the Town Council of the Borough of West Hartlepool the Order of 1881 shall have effect so as to enable the Port Sanitary Authority by agreement with the Town Council of the Borough of Hartlepool or with the Town Council of the Borough of West Hartlepool to provide for the reception in any hospital vested in or held by the Port Sanitary Authority of any cases of infectious disease occurring in either of the said Boroughs.

Adjustment.

- Art. III.—(1) At any time after the commencement of this Order and subject to the provisions thereof the Local Government Board upon the application of the Town Council of the Borough of Hartlepool the Town Council of the Borough of West Hartlepool or the Port Sanitary Authority may by Order adjust any actual or prospective liability and any property incidental to consequent upon or in connexion with the exercise of the powers of the Port Sanitary Authority in pursuance of the Order of 1885.
- (2) The Local Government Board may in any Order made in pursuance of this Article deal with any matters which may be dealt with by an Order or Provisional Order made under Section 304 of the Public Health Act 1875.

(3) Every Order made by the Local Government Board in pursuance of this Article shall have effect as if the provisions of the said Order were inserted in and formed part of this Order.

Art. IV. Where the Local Government Board cause any local inquiry to be Inquiries and held with reference to any of the purposes of this Order the costs incurred by the Board in relation to that inquiry (including such reasonable sum not exceeding three guineas a day as the Board may determine for the services of any inspector or officer of the Board engaged in the inquiry) shall be paid by the said councils and authority or by such of them and in such proportions as the Board may direct and the Board may certify the amount of the costs so incurred and any sum so certified and directed by the Board to be paid by any such council or authority shall be a debt due to the Crown from that council or authority.

Art. V. The Order of 1881 may be cited as the Hartlepools Order 1881 Short title. and this Order may be cited as the Hartlepools Order 1903.

Provisional Order for altering a Confirming Act.

ManchesterPort Order.

To the Manchester Port Sanitary Authority; —

To the Lord Mayor Aldermen and Citizens of the City of Manchester; -

To the Mayor Aldermen and Burgesses of each of the Boroughs of Eccles

Salford Warrington and Widnes; —

To the District Council of each of the Urban Districts of Ellesmere Port and Whitby Irlam Lymm Runcorn and Stretford; --

To the District Council of each of the Rural Districts of Barton-upon-Irwell Bucklow Chester Runcorn Warrington and Wirral; —

And to all others whom it may concern.

WHEREAS by the Manchester Port Order 1901 which was confirmed by the Local Government Board's Provisional Order Confirmation (Port) Act 1901 (which Order and Act are herein-after respectively referred to as "the Order" and "the Confirming Act") a joint board (herein-after referred to as "the Joint Board") termed the Manchester Port Sanitary Authority was permanently constituted the Port Sanitary Authority for the Port of Manchester (herein-after referred to as "the Port") and provision was made by the Order with regard to the constitution of the Joint Board and with regard to the manner in which the expenses incurred by the Port Sanitary Authority should be defrayed;

And whereas by subdivision (1) of Article IV. of the Order it was provided that of the thirteen members constituting the Joint Board one should be chosen by the Joint Committee appointed in pursuance of that Article by the Town Council of Widnes and the Rural District Councils of Chester and Wirral and as regards the election of a member of the Joint Board to represent that Town Council and those Rural District Councils it was by paragraph (d) of subdivision (3) of that Article provided that a Joint Committee should be appointed by the Town Council of Widnes and the Rural District Councils of Chester and Wirral and should consist of eight members of whom five should be chosen by the Town Council one by the Rural District Council of Chester and two by the Rural District Council of Wirral;

And whereas by subdivision (1) of Article XII. of the Order the proportions in which the Riparian Authorities are to contribute to the common fund of the Port Sanitary Authority were fixed and by paragraph (g) of that subdivision it was provided that the proportion in the case of the Town Council of Widnes and the Rural District Councils of Chester and Wirral should be one-thirteenth;

And whereas in pursuance of the County of Chester (Ellesmere Port and Whitby Urban District) Confirmation Order 1901 which came into operation from and after the Thirty-first day of March One thousand nine hundred and two the Township of Whitby in the Rural District of Wirral was formed into an Urban District known as the Ellesmere Port and Whitby Urban District and such Urban District forms part of or abuts upon the Port and the Urban District Council of Ellesmere Port and Whitby is a Riparian Authority of the Port;

And whereas it is expedient that provision should be made for the representation of the Urban District Council of Ellesmere Port and Whitby on the Joint Board and for the contribution of the Urban District Council towards the expenses of the Port Sanitary Authority:

Now therefore We the Local Government Board in pursuance of the powers given to Us by Section 297 of the Public Health Act 1875 and by any other Statutes in that behalf do hereby order that from and after the date of the Act of Parliament confirming this Order (which date is herein-after referred to as "the commencement of this Order") the Confirming Act shall be altered so that the following provisions shall take effect:—

- Art. I.—(1) Article IV. of the Order shall have effect as if—
 - (a) for the last paragraph of subdivision (1) of that Article there were substituted the paragraph following that is to say,—
 - " One by the Joint Committee appointed in pursuance of " this Article by the Town Council of Widnes the Urban District
 - " Council of Ellesmere Port and Whitby and the Rural District
 - " Councils of Chester and Wirral"; and
 - (b) for paragraph (d) of subdivision (3) of that Article there were substituted the paragraph following that is to say,—
 - " (d) A Joint Committee shall be appointed by the Town Council of Widnes the Urban District Council of Ellesmere

- "District Council and one by each of the Kural Distric

- (2) Notwithstanding anything in subdivision (1) of this Article the member of the Joint Board who at the commencement of this Order represents the Town Council of Widnes and the Rural District Councils of Chester and Wirral shall so long as he continues in office subject to the provisions of Article VI. of the Order be deemed to represent the Town Council of Widnes the Urban District Council of Ellesmere Port and Whitby and the Rural District Councils of Chester and Wirral on the Joint Board as if he had been chosen by a Joint Committee appointed by those Councils.
- Art. II. Article XII. of the Order shall have effect as if in subdivision (1) of that Article for the words "The Town Council of Widnes and the Rural District Councils of Chester and Wirral—One-thirteenth" there were substituted the words "The Town Council of Widnes the Urban District Council " of Ellesmere Port and Whitby and the Rural District Councils of Chester " and Wirral—One-thirteenth."
- Art. III. If at any time any new district is formed including the whole or any part of the district of any Riparian Authority of the Port or the boundaries of the district of any such authority are otherwise altered or the whole of any such last-mentioned district is created or included in a municipal borough or any repeal or alteration is made in the law affecting the Port or the Joint Board or any of the said districts or Riparian Authorities in matters touching their relation to the Port or the Joint Board then and in every such case the Local Government Board may by order to be published as they shall direct make such provision as to them seems fit for adapting the provisions of the Order and of this Order to the alteration so made and to the incidents and consequences thereof and every such order shall have effect as if the terms thereof were inserted in the Order.
- Art. IV. The Local Government Board upon the application of the Urban District Council of Ellesmere Port and Whitby or of the Rural District Council of Wirral or of the Joint Board may by order adjust as between the said Urban District Council and the said Rural District Council or as between those Councils or either of them and the Joint Board any expense or liability incurred by or attaching to the Joint Board before the date of the Act of Parliament confirming this Order or any expense liability or accounts arising out of incidental to connected with or affected by the inclusion of the said Urban District Council among the Riparian Authorities required to contribute to the common fund of the Joint Board or any expense liability or accounts in respect of which doubt or difference may arise after the date of the said Act and the Local Government Board may in such order

deal with any matters which may be dealt with by an order or Provisional Order made under Section 304 of the Public Health Act 1875.

Art. V. This Order may be cited as the Manchester Port Order 1903 and the Order and this Order may be cited together as the Manchester Port Orders 1901 and 1903.
