



And whereas the areas comprised in the original Schemes and the areas comprised in the amending Schemes (which last-mentioned areas include the whole of the areas comprised in the original Schemes and are herein-after respectively referred to as "the Chapel Grove Area" and "the Eastnor Place Area") are each too small to be dealt with under Part I. of the Act;

And whereas notices of the original Schemes and of the amending Schemes have been served in manner provided by the Act and petitions have been presented to Us the Local Government Board for an Order sanctioning the original Schemes and the amending Schemes;

And whereas We are satisfied on the report of local inquiries that the carrying of the original Schemes and of the amending Schemes (all which Schemes are herein-after referred to collectively as "the Schemes") into effect subject to conditions or modifications would be beneficial to the health of the inhabitants of the buildings comprised in the areas described in the Schemes or of the neighbouring dwelling-houses and such provisions as are herein-after set forth for the dwelling accommodation of persons of the working class displaced by the Schemes seem to Us to be required by the circumstances:

Revised Scheme 1901" and so much of the premises numbered 87 on that plan as abuts upon the properties numbered 26 to 37 shall be cleared of buildings as soon as the local authority shall have acquired the same but until such provision as is herein-before mentioned shall have been made on that part of the Chapel Grove Area for the accommodation of four hundred persons of the working class no buildings occupied as dwelling-houses at the date of the Schemes in the remaining portion of the Chapel Grove Area or in the Eastnor Place Area shall be demolished:
  - (b) As soon as accommodation for four hundred persons of the working class shall have been provided on the part of the Chapel Grove Area to be cleared of buildings in pursuance of paragraph (a) the local authority may proceed to demolish the buildings situate in the whole of the Eastnor Place Area but the remaining portion of the Chapel Grove Area shall not be cleared of buildings until provision shall have been made on the Eastnor Place Area for the accommodation of one hundred persons of the working class.
- (3) If within one year from the time when the said part of the Chapel Grove Area or the Eastnor Place Area as the case may be shall have been cleared of buildings as aforesaid such dwellings as are herein-before required to be erected in the said areas for persons of the working class have not been erected the local authority shall unless We shall otherwise order themselves erect the said dwellings and subject to the provisions of this Order the local authority may borrow money for the purpose of defraying the cost of the erection of the dwellings.
- (4) The local authority may for the purposes of defraying the expenses or any part of the expenses incurred or to be incurred by them of and incidental to the Schemes and of carrying into effect the Schemes borrow such sum or sums of money as they may from time to time require.

  - (5) Such of the lands in the areas comprised in the Schemes as shall not A.D. 1906. be required for the purpose of providing accommodation for persons of the working class as aforesaid shall be dedicated as a (Chapel Grove highway or open space unless We shall otherwise direct.

- Art. II.—(1) The provisions of Sections 183 to 191 of the Metropolis Management Act 1855 as applied by sub-section (2) of Section 46 of the Housing of the Working Classes Act 1890 shall apply and have effect so as to enable the local authority to borrow money for any purpose for which borrowing is authorised by this Order as if the said purpose were a purpose for which money may be borrowed under the said sub-section.
- (2) The London County Council may for the purpose of paying or contributing any sum which they may agree to pay or contribute or which they may be ordered pursuant to sub-section (7) of Section 46 of the Housing of the Working Classes Act 1890 to pay or contribute towards the expenses of carrying into effect the Schemes borrow under and subject to the provisions of the Acts for the time being regulating the raising of money by the Council for capital purposes such sum or sums of money as they may from time to time require.
- Art. III. We order that the provisions of the Lands Clauses Acts shall be incorporated with this Order so as to enable the local authority to acquire compulsorily lands within the areas comprised in the Schemes.
