CHAPTER lxxxvi.

An Act to confirm a Provisional Order of the A.D. 1937.

Minister of Health relating to the urban district
of Hornsea.

[20th July 1937.]

WHEREAS under the provisions of the Public 38 & 39 Vict. Health Act 1875 the Minister of Health has c. 55. made a provisional order which needs confirmation by Parliament:

Be it therefore enacted by the King's most Excellent Majesty by and with the advice and consent of the Lords Spiritual and Temporal and Commons in this present Parliament assembled and by the authority of the same as follows:—

- 1. The order of the Minister of Health which is Order in set out in the schedule to this Act is hereby confirmed schedule and shall have full validity and force.
- 2. This Act may be cited as the Ministry of Health Short title. Provisional Order Confirmation (Hornsea) Act 1937.

SCHEDULE.

URBAN DISTRICT OF HORNSEA.

Provisional order partially repealing a local Act.

WHEREAS the urban district council of Hornsea (in this order called "the council") are the local authority within the meaning of the Public Health Act 1875 for the urban district of Hornsea (in this order called "the district") and the Hornsea Urban District Council Act 1911 (in this order called "the local Act") is in force in the district;

And whereas by section 11 of the local Act provision is made with regard to the laying out of intersecting streets within the district;

And whereas the council have applied to the Minister of Health for the issue of a provisional order to repeal section 11 of the local Act:

Now therefore the Minister of Health in pursuance of the powers given to him by section 303 of the Public Health Act 1875 and of all other powers enabling him in that behalf hereby orders as follows:—

Short title and commencement. 1. This order may be cited as the Hornsea Order 1937 and shall come into operation on the date of the Act of Parliament confirming it.

Repeal.

2. Section 11 (Intersecting streets) of the local Act is hereby repealed.
