An Act for further continuing, until the First Day of August One thousand eight hundred and twenty-one, and from thence to the End of the then next Session of Parliament, the Powers granted by an Act of the Forty-sixth Year of His present Majesty, for enabling the Commissioners acting in Execution of an Agreement made between the East India Company and the private Creditors of the Nabobs of the Carnatic, the better to carry the same into Effect.

[19th May 1819.]

HEREAS by an Act of Parliament made in the Forty-fixth

Year of His present Majesty, intituled An Act for enabling 46G.3.c.133. the Commissioners acting in Execution of an Agreement made between the East India Company and the private Creditors of the Nabobs of the Carnatic, the better to carry the same into Effect, certain Powers and Authorities are given to the Commissioners for the Time being, acting in England and India, in Execution of certain Articles of Agreement, bearing Date the Tenth Day of July in the Year One thousand eight hundred and five, between the United Company of Merchants of England trading to the East Indies, of the one Part, and the several Persons whose Names and Seals should be thereto set and affixed, and who respectively were, or claimed to be, Creditors of his Highness the Nabob Wallah Jah, formerly Nabob of Arcot and of the Carnatic, in the East Indies, and now deceased, and of his Highness the Nabob Omdut ul Omrah, late Nabob of Arcot and of the Carnatic, eldest Son and Successor of his said Highness the Nabob Wallah [Local.]

Wallah Jah, and now also deceased, and of his Highness the Ameer ul Omrah, the Second Son of his said Highness the Nabob Wallah Jah, and now also deceased, or of some or one of them, the said several Nabobs and the said Ameer, of the other Part, in the said Act mentioned; and by the faid Act it is enacted, that the Powers and Authorities by that Act given to the said Commissioners then appointed, and to the Person and Persons thereafter to be appointed Commissioners, as well in England as in India, should continue in force until the First Day of August which would be in the Year One thousand eight hundred and ten, and from thence until the End of the then next Session of Parliament: And whereas an Act continue, until the Twenty-fifth Day of March One thousand eight hundred and thirteen, the Powers of the Commissioners appointed in pursuance of an Act of the Forty-fixth Year of His present Majesty, for enabling the Com-

50G.3.c.203. was passed in the Fistieth Year of His present Majesty, intituled An Act to missioners, acting in pursuance of an Agreement between the East India Company, and the private Creditors of the Nabobs of the Carnatic, the better to carry the same into Effect: And whereas an Act was passed in the Fifty-52G.3.c.188. second Year of His present Majesty, intituled An Act for further continuing, until the First Day of August One thousand eight hundred and sixteen, and from thence until the End of the then next Session of Parliament, the Powers of the Commissioners appointed in pursuance of an Act of the Forty-fixth Year of His present Majesty, for enabling the Commissioners acting in pursuance of an Agreement between the East India Company, and the private Greditors of the Nabobs of the Carnatic, to carry the same into Effect: And whereas an Act was passed in the Fifty-seventh Year of His present Majesty, intituled An Act for further continuing, until the First Day of August One thousand eight hundred and eighteen, and from thence to the End of the then next Session of Parliament, the Powers given by an Act of the Forty-fixth Year of His present Majesty, for enabling the Commissioners acting in Execution of an Agreement made between the East India Company and the -private Creditors of the Nabobs of the Carnatic, the better to carry the same into Effect: And whereas it is expedient that the Time during which the Powers and Authorities given by the faid first-recited Act were to continue, should be further enlarged: May it therefore please Your Majesty that it may be enacted; and be it enacted by the King's most Excellent Majesty, by and with the Advice and Consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by 46G.3.c.133. the Authority of the same, That the Powers and Authorities given by the faid first-recited Act, to the Commissioners therein mentioned, and to the Person or Persons now acting and hereafter to be appointed Commisfioners, as well in England as in India, shall continue in force until the First Day of August One thousand eight hundred and twenty-one, and from thence to the End of the then next Session of Parliament.

> II. And be it further enacted, That this Act shall be deemed and taken to be a Public Act, and shall be judicially taken Notice of as such by all Judges, Justices, and others, without being specially pleaded.
