An Act for opening certain Streets in the Burgh of *Dundee*, and otherwise improving the said Burgh. [22d June 1825.]

WHEREAS it would be greatly for the Improvement and Advantage of the Burgh of *Dundee* and the Suburbs thereof, if new Streets and Communications were formed and opened in the said Burgh and Suburbs, and if the existing Streets and Passages were widened and altered : And whereas it would also be greatly for the Advantage of the said Burgh and Suburbs, if the Town House and Gaol of the said Burgh were enlarged : But as these Purposes cannot be accomplished without the Aid and Authority of Parliament; May it therefore please Your Majesty that it may be enacted; and be it enacted by the King's most Excellent Majesty, by and with the Advice and Consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the Authority of the same, That for carrying into Effect the several Purposes of this Act, it shall and may be lawful to the Magistrates and Town Council of *Dundee* to treat, contract, and agree for the Purchase of any Lands, Grounds, Houses, or other Buildings, or other Heritable Subjects, to be taken or made use of for the Purposes of this Act, or any of them, or for the Loss or Damage the Owners or Persons interested in any such Lands or other Heritable Subjects may sustain by the Execution of the Powers and Authorities hereby granted.

Power to contract for Houses, &c. necessary.

Street from the Nethergate to the Ferry Harbour.

II. And be it further enacted, That it shall and may be lawful to the Magistrates and Town Council of *Dundee* to open a Street or Communication between the *Nethergate Street* in the said Burgh of *Dundee* and the *Ferry Harbour* at the *Craig of Dundee*; such Street or Communication extending through the Grounds and the Houses and other Buildings described in the Schedule to this Act annexed, or through Part thereof, and such Street or Communication being, as nearly as the said Magistrates and Council find convenient, of the same Breadth throughout, and no Part thereof being less than Forty Feet in Breadth, nor more than One hundred Feet, including in such Breadth a Side Pavement for Foot Passengers on each Side of the said Street or Communication, not less in any Part than Four Feet in Breadth, nor more than Twelve Feet.

Power to use the present Streets leading to the Ferry Harbour.

III. And be it further enacted, That it shall and may be lawful to the said Magistrates and Town Council to include in the said Street or Communication such Part of the Street or Access already existing, leading Southward to the said *Ferry Harbour*, as may be in the Line thereof, and to enclose and appropriate for the Use of the Burgh and the Community thereof, as Part of the Common Good or Property of the said Burgh, or to sell and dispose as Scites for building along the new Street or Communication, and apply the Prices received towards the Use and Benefit of the said Burgh and Community, such Part of the said Street or Access, already existing, as adjoins to the Ground and Houses belonging to the Burgh and Community of *Dundee* on the East Side thereof, and may not be necessary for the Opening of such new Street or Communication.

Existing Access not to be obstructed until the new Access be formed.

Accesses to the East and West to be continued.

IV. Provided always, and be it further enacted, That nothing in this Act contained shall extend or be construed to extend to authorize the said Magistrates and Town Council to encroach upon, or to place any Obstruction upon the said Street or Access already existing, leading Southward to the said *Ferry Harbour*, until the said new Street or Communication hereby authorized to be opened has been opened, and has also been made suitable for an Access to the said *Ferry Harbour*; and nothing herein contained shall extend or be construed to extend to authorize the said Magistrates and Town Council to shut up or obstruct any of the existing Accesses or Communications from the East or from the West, to the said Street or Communication already existing, leading Southward to the *Ferry Harbour*, all which Accesses or Communications shall be continued to the new Street or Communication hereby specially authorized to be opened.

Power to take down Houses, &c. on the West of the public Warehouses and Market Places, and build thereon and Westward to the new Street.

V. And be it further enacted, That it shall and may be lawful to the said Magistrates and Town Council to take down and demolish the Buildings bounded by *Butcher Row* on the North, and the West Wharf of the Harbour of *Dundee* on the South, which lie between the public Warehouses and the public Markets on the East, and the waste Ground or vacant Area, and Street on the East Side of the Access from *Yeaman's Shore* to the *Ferry Harbour*, on the West, and which Buildings are described in the Schedule to this Act annexed; provided the Owner or Owners of such Buildings shall voluntarily sell and convey the same to the said Magistrates and Town Council; and after the before-mentioned Street or Communication, between the *Nethergate Street* and the

Ferry Harbour, by this Act authorized, has been opened, it also shall and may be lawful to the said Magistrates and Town Council to continue the public Warehouses, or to erect and build other Warehouses and Granaries, or other Buildings, on the Scite of the said Buildings so demolished, and on the Ground connected therewith, described in the Schedule to this Act annexed, and also on the before-mentioned waste Ground or vacant Area, and on the Street already existing, as far West as the Line of the East Side of the said Street or Communication from the *Nethergate* to the *Ferry Harbour*, by this Act authorized to be opened; or to sell and dispose of the said Scites, Ground, Area, and Street, as Scites for Buildings.

VI. Provided always, and be it enacted, That nothing herein contained shall extend or be construed to extend to authorize the said Magistrates and Town Council to lessen the Breadth of the Street or Passage called *The Butcher Row*; nor shall any thing herein contained extend or be construed to extend to authorize the said Magistrates and Town Council to encroach on the West Wharf of the Harbour, which shall, as at present, be bounded on the North by the Line of the public Warehouses, and the South Boundary of the Buildings hereby authorized to be erected and built shall be the Line of the said Warehouses extended Westward; and the North Boundary of the said Buildings hereby authorized to be erected and built shall not extend further North than a Line from the South-west Corner of *Butcher Row*, parallel to the South Boundary of the said Buildings.

VII. And be it further enacted, That it shall and may be lawful to the said Magistrates and Town Council to open a Street or Communication between the *Cowgate Street* of *Dundee*, and the Field to the Westward thereof, commonly known by the Name of *The Meadows*; such Street or Communication extending through the Grounds and the Houses and other Buildings described in the Schedule to this Act annexed, or through Part thereof; and such Street or Communication being, as nearly as the said Magistrates and Town Council find to be convenient, of the same Breadth throughout, and no Part thereof being less than Forty Feet in Breadth, nor more than One hundred Feet, including in such Breadth a Side Pavement for Foot Passengers on each Side of the said Street or Communication, not less in any Part than Four Feet in Breadth, nor more than Twelve Feet.

VIII. And be it further enacted, That it shall and may be lawful to the said Magistrates and Town Council of *Dundee* to open a Street or Communication between the West End of the said Street or Communication last mentioned, and the Turnpike Road leading from *Dundee* to *Coupar* in *Angus*; such Street or Communication extending through the Grounds and the Houses and other Buildings described in the Schedule to this Act annexed, or through Part thereof; and such Street or Communication being, as nearly as the said Magistrates and Town Council find convenient, of the same Breadth throughout, and no Part thereof being less than Forty Feet in Breadth, nor more than One hundred Feet, including in such Breadth a Side Pavement for Foot Passengers, not less in any Part than Four Feet in Breadth, nor more than Twelve Feet.

Street between the High Street, opposite to the Town House, and the Meadows.

IX. And be it further enacted, That it shall and may be lawful to the said Magistrates and Town Council of *Dundee* to open a Street or Communication between the *High Street* of *Dundee*, commencing opposite or nearly opposite to the Town House thereof, and the before-mentioned Field commonly known by the Name of *The Meadows*; such Street or Communication extending through the Grounds and the Houses and other Buildings described in the Schedule to this Act annexed, or through Part thereof; and such Street or Communication being, as nearly as the said Magistrates and Town Council find to be convenient, of the same Breadth throughout, and no Part thereof being less than Forty Feet in Breadth, nor more than One hundred Feet, including in such Breadth a Side Pavement for Foot Passengers on each Side of the said Street or Communication, not less in any Part than Four Feet in Breadth, nor more than Twelve Feet.

Street between the East End of the High Street and the Meadows.

X. And be it further enacted, That it shall and may be lawful to the said Magistrates and Town Council of *Dundee* to open a Street or Communication between the *High Street* of *Dundee*, commencing at or near to the East End of the said *High Street*, and the before-mentioned Field commonly known by the Name of *The Meadows*, such Street or Communication extending through the Grounds and the Houses and other Buildings described in the Schedule to this Act annexed, or through Part thereof; and such Street or Communication being, as nearly as the said Magistrates and Town Council find to be convenient, of the same Breadth throughout, and no Part thereof being less than Forty Feet in Breadth, nor more than One hundred Feet, including in such Breadth a Side Pavement for Foot Passengers on each Side of the said Street or Communication, not less in any Part than Four Feet in Breadth, nor more than Twelve Feet.

Meadow Entry to be widened.

XI. And be it further enacted, That it shall and may be lawful to the said Magistrates and Town Council to widen and alter the Street or Passage named *The Broad Close*, or *The Meadow Entry*, extending between the *Murraygate Street* of *Dundee* and the said Field commonly known by the Name of *The Meadows*; so that the said Street or Passage may be, as nearly as the said Magistrates and Town Council find to be convenient, of the same Breadth throughout, and that no Part thereof may be less than Forty Feet in Breadth, nor more than One hundred Feet, including in such Breadth a Side Pavement on each Side, or on one Side only, as the said Magistrates and Town Council think proper, not less in any Part than Four Feet in Breadth, nor more in any Part than Twelve Feet; and for that Purpose, it shall and may be lawful to the said Magistrates and Town Council to take down and demolish the Houses and other Buildings described in the Schedule to this Act annexed, or such Part thereof as may be necessary for widening the said Street or Passage as aforesaid; and it shall and may be lawful to the said Magistrates and Town Council to widen the said Street or Passage by taking away Part of the Grounds and Houses and other Buildings on each Side of the said Street, or by taking what may be necessary from the Grounds and Houses and other Buildings on one Side only, as the said Magistrates and Council may find most suitable and convenient.

XII. And

XII. And be it further enacted, That it shall and may be lawful to the said Magistrates and Town Council to widen or alter the Street or Passage named *The School Wynd*, extending between the *Nethergate* and *Overgate Streets* of *Dundee*; so that the said Street or Passage may be, as nearly as the said Magistrates and Town Council find to be convenient, of the same Breadth throughout, and that no Part thereof may be less than Twenty-five Feet in Breadth, nor more than One hundred Feet, including in such Breadth a Side Pavement on each Side, or on one Side only, as the said Magistrates and Council think proper, not less in any Part than Four Feet in Breadth, nor more in any Part than Twelve Feet; and for that Purpose it shall and may be lawful to the said Magistrates and Town Council to take down the Houses and other Buildings described in the Schedule to this Act annexed, or such Part thereof as may be necessary for widening the said Street or Passage as aforesaid; and it shall and may be lawful to the said Magistrates and Town Council to widen the said Street or Passage by taking away Part of the Grounds and other Buildings on each Side of the said Street or Passage, or by taking what may be necessary from the Grounds and Houses and other Buildings on one Side only, as the said Magistrates and Town Council may find most suitable and convenient.

XIII. And be it further enacted, That it shall and may be lawful to the said Magistrates and Town Council to open a Street or Communication between the *Overgate Street* of *Dundee*, commencing opposite or nearly opposite to the said Street or Passage named *The School Wynd*, and the Field belonging to the Hospital of *Dundee*, and commonly known by the Name of *The Hospital Ward*, such Street or Communication extending through the Grounds and the Houses and other Buildings described in the Schedule to this Act annexed, or through Part thereof; and such Street or Communication being, as nearly as the said Magistrates and Town Council find to be convenient, of the same Breadth throughout, and no Part thereof being less than Forty Feet in Breadth, nor more than One hundred Feet, including in such Breadth a Side Pavement for Foot Passengers on each Side of the said Street or Communication, not less in any Part than Four Feet in Breadth, nor more than Twelve Feet.

XIV. And be it further enacted, That it shall and may be lawful to the said Magistrates and Town Council, and they are hereby authorized and empowered, to treat, contract, and agree for the Purchase to them and their Successors in Office, for Behoof of the said Burgh and the Community thereof, of the before-mentioned Field, known by the Name of *The Hospital Ward*, and also of the Ground known by the Name of *The Little Meadow*, or *Andrew Barrie's Meadow*, either together or separately, or either of them, in order that the said Field and Ground may be applied for the Purposes of this Act.

XV. And be it further enacted, That it shall and may be lawful to the said Magistrates and Town Council to open such Streets, Lanes, Communications, Passages, and Places in the said Field, commonly known by the Name of *The Meadows*, and also (after purchasing and acquiring such Field) in the said Field commonly known by the Name of *The Hospital Ward*, as the said Magistrates and Town Council consider to be suitable and convenient; and also to appropriate and lay out such Parts of the said Fields not re-

quired for the Streets, Communications, Lanes, Passages, and Places; as the said Magistrates and Town Council think proper, for public Gardens, and similar Purposes, for the Use and Enjoyment of the Inhabitants of the adjacent Streets, and such others as it may be resolved by the said Magistrates and Town Council to admit to the Use and Enjoyment thereof, and for the Ornament of the said Town.

Regulations may be made for good Government of Gardens, &c.

XVI. And be it further enacted, That it shall and may be lawful to the said Magistrates and Town Council, or to those having Right to the Use and Enjoyment of the said public Gardens and ornamental Ground, with the Consent of the said Magistrates and Town Council, to establish Regulations from Time to Time for the good Government of such public Gardens and ornamental Grounds, and for the planting, dressing, and keeping in order of the same, and for assessing those having Right thereto for the Expence of such planting, dressing, and keeping in order of the said Gardens and Grounds, and for imposing Penalties for Non-observance of the Regulations which may be made as aforesaid, no one Penalty exceeding Two Pounds in Amount; and the Regulations and Acts of the said Magistrates and Town Council, or of the said Persons enjoying the Rights themselves, assembled at any General Meeting, the Consent of the said Magistrates and Council being first obtained, shall be binding and effectual.

Line of Road between Barrack Street and Bell Street may be altered.

XVII. And be it further enacted, That it shall and may be lawful to the said Magistrates and Town Council to widen and alter the Line of that Part of the Road or Passage which extends from *Barrack Street* to the *Constitution Brae*, lying between *Barrack Street* and the West End of *Bell Street*, according as they find it expedient in the Progress of the Improvements authorized by this Act; and on forming and opening a Road or Passage between *Barrack Street* and the West End of *Bell Street*, of a Breadth at least equal to the existing Road or Passage, it shall be lawful to the said Magistrates and Town Council to enclose the said existing Road or Passage between *Barrack Street* and the West End of *Bell Street*, along with the Ground adjoining, as Part of the Property or Common Good belonging to the said Burgh and Community; and it shall thenceforth be vested in them accordingly, and may be used as Scites for Buildings, or sold, or otherwise disposed of, at the Pleasure of the said Magistrates and Town Council: Provided always, that such new Road or Passage shall not deviate more than One hundred Yards from the Line of the said Road or Passage already existing.

Access from North Tay Street to the Hospital Ward.

XVIII. And be it further enacted, That it shall and may be lawful to the said Magistrates and Town Council to widen and alter the present Access or form a more convenient Access from the North End of the Street called *North Tay Street* into the *Hospital Ward*, through the Grounds and Houses described in the Schedule to this Act annexed, or through Part thereof, the South Line of such Access not being more in any Part than Sixty Feet from the Wall which at present encloses the *Hospital Ward* on the South.

Ground, &c. on the Side of the Streets may be sold.

XIX. And be it further enacted, That it shall and may be lawful to the said Magistrates and Town Council to sell and dispose, to such Person or Persons as may be willing to treat for and purchase the same, of the
Grounds

Grounds and Houses and other Buildings already belonging to the Town and Community of the said Burgh, or which they may acquire hereafter, at the Sides of or adjacent to the said several Streets, Communications, Lanes, Passages, and Places by this Act specially authorized to be opened or widened and altered, or any of them, or which may be opened in the said Field called *The Meadows*, or the said Field called *The Ward*, as Scites for Houses, and as Courts and Back Areas for such Houses, and for other Purposes, under such Conditions and Regulations, and at such Prices as to the said Magistrates and Town Council may appear proper and suitable: Provided always, that nothing shall be done contrary to the Provisions of an Act passed in the Third Year of the Reign of His present Majesty, intituled *An Act for regulating the Mode of accounting for the Common Good and Revenues of the Royal Burghs of Scotland.* 3 G. 4. c. 91.

XX. And be it further enacted, That it shall and may be lawful to the said Magistrates and Town Council of *Dundee* to erect and build upon the Ground, and the Scites of the Houses and other Buildings behind the Town House of the said Burgh, and described in the Schedule to this Act annexed, an Addition to the said Town House, for the Use and Accommodation of the said Magistrates and Town Council, and the public Officers of the Burgh, and for containing an Addition to the Gaol of the said Burgh, which forms Part of the said Town House, and for other Purposes connected with the good Government and the Management of the Affairs of the said Burgh and the Administration of Justice; and also, upon the said Ground and Scites of Houses and other Buildings, to form Courts and Airing Ground for the Improvement of the said Town House and Gaol and the Use of the Prisoners therein; and to erect and build Watch-houses, and other Houses and Offices; and for these Purposes to take down and demolish the said Houses and other Buildings behind the said Town House, and described in the Schedule to this Act annexed. Town House may be enlarged, and Airing Grounds for the Gaol may be formed.

XXI. Provided always, and be it enacted, That the Ground or Houses or other Buildings, or the Scites thereof, which the said Magistrates and Town Council may acquire under the Authority of this Act, shall not be used for any other Purpose than the Purposes of this Act. Ground acquired under this Act not to be applied to any other Purpose.

XXII. And be it further enacted, That it shall and may be lawful to the said Magistrates and Town Council to fix and determine the Line and Breadth of the several Streets, Communications, Lanes, Passages, and Places by this Act authorized to be opened, widened, and altered, from Time to Time as they think it proper, this Breadth not being more nor less in any Case than what is herein-before specially provided: Provided, before the said Magistrates and Town Council shall purchase or take, under the Authority of this Act, any Ground, with or without Buildings thereon, for the Purpose of opening, widening, or altering any Street, Communication, Lane, Passage, or Place, they the said Magistrates and Town Council shall be bound to specify in Writing to the Party or Parties from whom such Ground shall be intended to be so purchased or taken, the exact Line and Breadth of such intended Street, Communication, Lane, Passage, or Place; and every such Purchase shall be made subject to such Specification; and it shall not be competent to the said Magistrates and Town Council, after such Purchase shall have been effected, to depart from or alter the Line or Breadth Magistrates and Council to fix the Line and Breadth of the Streets.

Expences of paving and forming Common Sewers how to be defrayed.

Work how to be executed.

When any Party refuses to pay Proportion of Expences.

XXIII. And be it further enacted, That the Expence of paving the several Streets, Communications, Lanes, Passages, and Places by this Act specially authorized to be opened, widened, and altered, and of constructing Common Sewers under the said several Streets, Communications, Lanes, Passages, and Places, shall be paid and defrayed by the Person or Persons, Body or Bodies, to whom the Ground, Houses, and other Property at the Sides of such Streets, Communications, Lanes, Passages, and Places so opened, widened, and altered, belong, in proportion to the Length of the Front belonging to them respectively along such Streets, Communications, Lanes, Passages, and Places; and all such Pavement and Common Sewers shall be such as the Magistrates of *Dundee*, and the General Commissioners under an Act passed in the Fourth Year of the Reign of His present Majesty, intituled *An Act for the better paving, lighting, watching, and cleansing the Burgh of Dundee, and for building and maintaining a Bridewell there*, shall direct; and such Pavement and Common Sewers shall be laid and constructed under the Orders and Superintendence of some qualified Person to be appointed by the said Magistrates and General Commissioners for that Purpose; and in case any Person or Persons, Body or Bodies, liable in any Part of the Expence of such Pavement and Common Sewers, shall fail or refuse to pay his, her, or their Proportion of such Expence, it shall be lawful for the said Magistrates and Town Council, or to the Person to be appointed to superintend the Work as aforesaid, to pursue and insist against such Person or Persons, Body or Bodies, for Payment thereof; and when there shall be more than One Person or Body, having Property in any Ground or House or other Building having a Front to any Street, Communication, Lane, Passage, or Place which may be opened, widened, or altered as aforesaid, it shall be lawful to any One of such Persons or Bodies voluntarily to pay, or any One of such Persons or Bodies may be compelled to pay the whole Amount corresponding to such Ground, House, or other Building, such Person or Body so paying or compelled to pay having Right to sue and insist for such Relief against his Co-proprietors; and the Proportions of such Expence payable by each of the Co-proprietors of any such Ground or House, or other Buildings, shall be ascertained and determined in a summary Manner by any Two or more of the Judges officiating in the Police Court established by the before-mentioned Act passed in the Fourth Year of the Reign of His present Majesty, intituled *An Act for the better paving, lighting, watching, and cleansing the Burgh of Dundee, and for building and maintaining a Bridewell there*, or by any Person or Persons to be appointed for that Purpose by any One or more of the said Judges officiating as aforesaid, upon the Application of the said Magistrates and Town Council, or the Person to be appointed to superintend the Work as aforesaid, or of any Person having Interest.

Magistrates to provide bleaching Ground instead of Meadows;

XXIV. And be it further enacted, That it shall and may be lawful to the said Magistrates and Town Council, and they are hereby required, before using or applying the before-mentioned Field called *The Meadows* for the Purposes of this Act, or any of them, to enclose and lay out in Grass Part, at least Five Acres in Extent, of the Field or Grounds
 belonging

belonging to the Town and Community lying on the West Side of the *Constitution Brae* Road, and on the North Side of the Road leading to the East Gate of *Dudhope* Barracks, or some other Field or Ground conveniently situate, and not being less than Five Acres in Extent, nor at a greater Distance than the said Field or the Ground on the West Side of the *Constitution Brae* Road from the Town House, for the Use of the Inhabitants of the said Burgh of *Dundee* and the Suburbs thereof, in bleaching and drying Clothes for the Use of their Families.

XXV. And be it further enacted, That it shall and may be lawful to the said Magistrates and Town Council, and they are by this Act required, to build and construct Wells and Water Channels in the said Field or Ground, so to be laid out and enclosed for the Use of the said Inhabitants, and otherwise to do what is necessary for rendering such Field or Ground suitable and convenient for the Purpose intended; and likewise to build, erect, and provide on such Field or Ground, one or more Washing Houses, with such Utensils as may be thought necessary, and one or more Watch-houses, and to appoint such Keepers, Watchmen, or other Officers, as they may think proper.

and to supply the same with Water:

XXVI. And be it further enacted, That it shall and may be lawful to the said Magistrates and Town Council to establish Regulations for the Management and good Government of such Field or Ground, and the Wells, Water Channels, and Washing Houses to be erected thereon, and the Keepers, Watchmen, and other Officers to be appointed; and to impose Penalties for Non-observance of such Regulations, not exceeding Two Pounds in Amount for each Offence; and also to establish Tables of Dues and Rates to be levied from all Persons using such Washing Houses, or who may have Clothes on the Ground before Sunrise or after Sunset; and to levy such Dues and Rates, and appoint Officers for that Purpose; and to apply the Produce of such Dues and Rates in defraying the Expence of keeping such Ground in order, of upholding the Washing Houses, Utensils, and Watch-houses, of keeping and watching the Ground and Houses, and paying the legal Interest annually of the Sum expended in building, erecting, and providing such Washing Houses, Utensils, and Watch-houses.

and to make Rules and Regulations regarding same, and take Rates.

XXVII. And be it further enacted, That all Penalties which may be incurred for the Breach of any Rules and Regulations made and established under the Authority of this Act shall be recovered by summary Complaint in the Police Court of the Burgh of *Dundee*, at the Instance of the Superintendent of Police of the Burgh, or any Person whom the said Magistrates and Town Council may appoint, and all such Penalties shall be applied for the Purposes of this Act.

Penalties how to be recovered.

XXVIII. Provided always, and be it enacted, That the said Magistrates and Town Council shall revise and amend such Table of Dues and Rates from Time to Time as may be necessary; so that no more may be levied than is necessary for defraying the Expences and Interest aforesaid; and the said Magistrates and Town Council shall cause regular Accounts to be kept, shewing the Sums received and the Sums expended as aforesaid; and these Accounts shall be lodged in the Town Clerk's Office of the Burgh annually, and remain there, open to the Inspection of the Burgesses of

Rates not to be more than adequate to defray Expence laid out.

Dundee, at the same Time, during the same Period, and under the same Provisions and Regulations as the General Accounts appointed to be made up and lodged under the before-mentioned Act, for regulating the Mode of accounting for the Common Good and Revenues of the Royal Burghs of *Scotland*.

The several Purposes of the Act to be executed separately.

XXIX. And be it further enacted, That it shall and may be lawful to the said Magistrates and Town Council to execute the several Purposes of this Act separately, and in such Order from Time to Time as they find to be convenient; and the said Magistrates and Council, though they open One or more Streets or Communications, or execute any other separate Purpose or Purposes of this Act, shall not thereby be liable to be required to execute the other Powers by this Act conferred upon them, any thing contained in this Act to the contrary notwithstanding.

Houses, &c. belonging to the Corporation may be used for the Purposes of this Act.

XXX. And be it further enacted, That it shall and may be lawful to the said Magistrates and Town Council to take down and demolish the Houses and other Buildings belonging to or which may be acquired by the Town and Community of *Dundee*, or belonging to or which may be acquired by the said Magistrates and Town Council, or any of them, for behoof of the said Town and Community, necessary to be taken down and demolished for the Purposes of this Act, or any of them, and to use and apply the Scites of such Houses and other Buildings, and the Grounds and other heritable Subjects belonging to or which may be acquired by the said Town and Community, or the said Magistrates and Town Council, or any of them, for behoof of the said Town and Community, for the Purposes of this Act or any of them.

Bodies Politic and others empowered to sell.

XXXI. And be it further enacted, That it shall and may be lawful to and for all Bodies Politic, Corporate, or Collegiate, Trustees, or other Guardians for any Person or Persons, or for Public or Private Foundation or Establishment, Heirs of Entail, Tutors or Curators for Infants, Minors, Idiots, fatuous or furious Persons, for Persons absent from *Scotland*, and others, and to and for all and every other Person or Persons whomsoever, under any other Disability or Incapacity whatsoever, who are or shall be seised, possessed of, interested in, or entitled to any of the Grounds, Houses, or other Property required for the Purposes of this Act, to sell and convey the same to the said Magistrates and Town Council; and all Contracts, Agreements, Sales, or other Conveyances that shall be made, shall be valid to all Intents and Purposes, any Law, Statute, Usage, or other Matter or Thing whatsoever to the contrary notwithstanding.

Houses, &c. may be valued by a Jury.

XXXII. Provided always, and be it enacted, That if any Person or Persons, Bodies Politic, Corporate or Collegiate, Trustee or Trustees, Guardian or Guardians, Heir of Entail, Tutor or Tutors, Curator or Curators, or other Person or Persons aforesaid, Owners or Occupiers of any Grounds, Houses, or other Property required for the Purposes of this Act, specified in the Schedule hereto annexed, seised or possessed of, interested in, or entitled to the same respectively, shall refuse to treat, contract, or agree to sell the same as aforesaid, or to allow the said Magistrates and Town Council to enter upon, use, or take the same for the Purposes of this Act, they shall be bound and obliged to state in Writing, within Forty Days after being required

required by a Writing delivered to him or them personally, or in case of his or their Absence, to his or their known or reputed Agent or Representative, to do so, the Line and Breadth of the intended Street (in the Case of Streets) being specified in the Requisition, the Sum or Sums which they demand, as Damage or Recompence for the Ground or other Subjects taken or to be taken for the Purposes of this Act; and if the said Magistrates and Town Council at any Time within Two Calendar Months after the Sum or Sums demanded are stated, shall declare their Agreement to pay such Sum or Sums, then the Party so demanding shall be bound to accept thereof, as in full, and the said Magistrates and Town Council shall be bound to pay; and if the said Magistrates and Town Council shall decline to pay the Sum or Sums so demanded, the said Magistrates and Town Council shall also be bound and obliged to state in Writing the Sum or Sums of Money which they are willing and offer to pay, whereupon it shall and may be lawful to and for the Sheriff Depute of the County of *Forfar*, or his Substitute, and they or either of them are and is hereby authorized and required, upon Application from the said Magistrates and Town Council, to summon and return Thirty substantial and disinterested Persons, resident within the County of *Forfar*; and the said Sheriff Depute or his Substitute shall appoint a Day and Place for proceeding in the said Matter, of which Ten Days previous Notice in Writing shall be given to the Owners and Occupiers of such Grounds, Houses, or other Property, personally, or left at his, her, or their usual Place or Places of Abode, or with some Tenant or Occupier of the Premises as aforesaid; and the said Thirty Persons are hereby required to appear within the Town Hall of *Dundee*, at such Time as may be appointed by the said Sheriff Depute or his Substitute for proceeding in the said Matter, and as shall be appointed in his Warrant or Warrants, Precept or Precepts, to that Effect; and at the Time and Place so appointed, the Sheriff Clerk of the County of *Forfar*, or his Deputy or Substitute, shall, in the Presence of the said Sheriff Depute or his Substitute, and the Party or Parties interested, if he, she, or they shall attend, put into a Box or Glass the Names of the whole Thirty Persons so summoned and returned, or such of them as shall be present, and shall out of such Box or Glass draw out the Names of Fifteen Persons, and the Fifteen Persons whose Names shall be thus drawn shall form a Jury for the Purposes aforesaid; and the said Sheriff Depute or his Substitute is hereby authorized and empowered, by Warrant or Warrants under his Hand, from Time to Time, as occasion shall require, to call before him such Person or Persons as shall be thought by the Parties proper or necessary to be examined as a Witness or Witnesses before him and the said Jury, touching or concerning the Premises, and to send his Precept or Precepts for all and every such Person or Persons, who is and are hereby required to appear before the said Sheriff Depute or his Substitute, and to produce such Books, Papers, Deeds, and Writings, as the said Sheriff Depute or his Substitute shall judge necessary for his Information, or for the Information of the Jury so to be formed as aforesaid, in any Matter or Thing relating to this Act; and the said Sheriff Depute or his Substitute shall and may administer Oaths for the better Discovery of the Truth in regard to the Inquiry to be made, to any Person or Persons therein concerned, or to any other Person or Persons whomsoever, and shall and may authorize the said Jury to view the Place or Places and Matters in question; and the

the said Jury, upon their Oaths, (which Oaths the said Sheriff Depute or his Substitute shall and may administer), shall inquire of and give their Verdict for such Price or Prices, Damage or Recompence, as they shall judge fit to be awarded to such Owners and Occupiers as aforesaid, or any of them, for such Grounds, Houses, or other Property, or any Part thereof, for their respective Estates or Interests in the same; and the Sheriff Depute or his Substitute shall and may give Judgment for the Sum or Sums of Money specified in the Verdict or Verdicts of such Jury or Juries respectively; which said Verdict or Verdicts, and the Judgment, Decree, or Determination thereupon declared and pronounced by the said Sheriff Depute or his Substitute, and the Value or Recompence, Price or Prices so to be awarded and declared, shall be binding and conclusive to all Intents and Purposes whatsoever; against the said Magistrates and Town Council, and against such Persons, Bodies Politic, Corporate, or Collegiate, and all and every other Person or Persons whatsoever, having or claiming any Right, Title, Trust, or Interest of, in, to, or out of such Premises as aforesaid; and the Verdicts, Judgments, Orders, Sentences, and Decrees, and other Proceedings of the said Sheriff Depute or his Substitute, so to be made, given, and pronounced as aforesaid, shall be fairly written upon Paper or Parchment, and signed by the Sheriff Depute or his Substitute, at the making or pronouncing of the same, and shall be recorded in the Sheriff Court Books of *Forfar*, and the same, or certified Copies thereof, shall be deemed and taken as good and effectual Proof and Evidence in any Court of Law or Equity whatsoever; and if any Person so summoned to serve on such Jury shall not appear, or appearing shall refuse to be sworn, or to give his Verdict, or shall in any other Manner wilfully neglect his Duty, contrary to the true Intent and Meaning of this Act, or if any Person so summoned to give Evidence shall not appear, after having been paid or tendered a reasonable Sum for his or her Costs, Charges, and Expences, if demanded, or appearing shall refuse to be sworn and examined, or give Evidence, every Person so offending, having no reasonable Excuse, to be allowed by the said Sheriff Depute or his Substitute, shall for every such Offence forfeit and pay any Sum not exceeding Five Pounds.

Provision as
to Expences.

XXXIII. And be it further enacted, That in every Case where a Verdict shall be given by any such Jury for more Money than shall have been previously offered for or on behalf of the said Magistrates and Council, as a Recompence or Satisfaction for any such Lands, Tenements, or Heritages as aforesaid, or for any such Estate, Right, or Interest therein, or for any Damages that may have been sustained by any Person or Persons as aforesaid, all the Costs and Charges incurred in summoning, empanelling, and returning such Jury, taking such Inquisition, and the Attendance of Witnesses, and recording the Verdict or Judgment thereon, shall be borne by the said Magistrates and Council, out of the Monies to be raised by virtue of this Act; and in case such Costs and Expences shall not be paid to the Party or Person entitled to receive the same, within Fourteen Days after Demand thereof made from the said Magistrates and Council, then the same shall and may be levied and recovered by Distress and Sale of any Goods or Chattels vested in the said Magistrates and Council, or of any Goods or Chattels of the Treasurer or Treasurers of the said Magistrates and Council (unless such Treasurer or Treasurers shall pay such Costs and Charges out of any Monies by virtue of

of his Office received by him, or in his Hands or keeping, which he is hereby authorized to do), under a Warrant to be issued for that Purpose by any Justice of the Peace for the County of *Forfar*, which Warrant any such Justice is hereby authorized and required to issue under his Hand and Seal, on Application made to him for the Purpose by the Party or Person entitled to receive such Costs and Expences; and in every Case where a Verdict shall be given by any such Jury for no more or for less Money than shall have been previously offered by or on behalf of the said Magistrates and Council, as such Recompence or Satisfaction as aforesaid, all the Costs and Charges incurred as aforesaid shall be borne in equal Proportions by the Party or Parties refusing or neglecting to treat or agree as before mentioned, and by the said Magistrates and Council; but in Cases where any Person or Persons, Party or Parties, shall have been prevented by Absence from entering into any Treaty with the said Magistrates and Council, the Costs and Charges so incurred shall be borne by the said Magistrates and Council in manner aforesaid; and in all Cases where any Difference shall arise touching the Amount of the said Costs and Charges, the same shall be settled and ascertained by any Justice of the Peace for the said County of *Forfar*, not interested in the Matter in question, who is hereby authorized and required to examine into and settle the same, and to appoint a Time and Place for Payment thereof; and where the Costs shall be payable by the Party or Parties having had any such Disagreement or Dispute with the said Magistrates and Council as aforesaid, the Amount thereof, having been first paid by the said Magistrates and Council, may be deducted by them out of the Monies awarded to be paid to such Party or Parties, as so much Money advanced for his, her, or their Use; and the Payment or Tender of the Balance of such Money shall be deemed and taken to all Intents and Purposes whatsoever to be a Payment or Tender of the whole Money awarded and adjudged to such Party or Parties; or otherwise, if such Costs or Charges be not paid upon Demand, after being so ascertained as aforesaid, the same may be recovered by the said Magistrates and Council from the Party or Parties liable to the Payment thereof, by Action in any competent Court in *Scotland*, together with full Costs of Suit.

XXXIV. Provided always, and be it enacted, That the Price or Compensation to be paid by the said Magistrates and Town Council for the before-mentioned Ground known by the Name of *The Hospital Ward*, or any Part thereof, or for the before-mentioned Field, known by the Name of *The Little Meadow* or *Andrew Barrie's Meadow*, or any Part thereof, shall be fixed and determined by the Valuation of a Jury in manner aforesaid; and all the Expences, Costs, and Charges which may be incurred in relation thereto shall be paid and defrayed by the said Magistrates and Town Council; any thing herein contained to the contrary notwithstanding.

XXXV. And be it further enacted, That upon Payment of such Sum or Sums of Money so to be awarded and adjudged to the Party or Parties concerned, or legal Tender made to him, her, or them respectively, either personally, or at his, her, or their usual Place or Places of Abode, or upon Payment thereof into the Bank of *Scotland*, into the Royal Bank of *Scotland*, or the Bank of the *British Linen Company* of *Scotland*, in manner herein-after directed, it shall then, and not before or otherwise, be lawful to and for the said Magistrates and Town Council, and to and for

their Agents and Workmen, to take Possession and dispose of such Ground, Houses, or other Property for the Purposes of this Act, in such Manner as the said Magistrates and Town Council shall see fit and expedient; and the said Magistrates and Town Council shall be indemnified therein, and be entitled to take such Possession of the Premises so required and to be disposed of under the Authority of this Act, and eject all others therefrom, without the Warrant of any Judge, provided that Notice shall be given to the Tenants and Occupiers Forty Days at least before the Term of *Martinmas* or *Whitsunday* at which they are to be removed therefrom, by serving the same upon such Tenants or Occupiers, or leaving the same at his, her, or their usual Place or Places of Abode.

No Premises to be taken not mentioned in the Schedule, without the Owners Consent.

XXXVI. Provided always, and be it enacted, That no Ground, House, or other Building or other Property shall be taken or used by the said Magistrates and Town Council for the Purposes of this Act, except such as are mentioned in the Schedule hereto annexed, or belong to or shall be acquired by the Town and Community of *Dundee* or others for their behoof, without the Consent in Writing of the Owner or Owners thereof being first had and obtained for that Purpose.

Misnomers, &c. not to prevent Execution of this Act.

XXXVII. Provided always, and be it enacted, That if any Grounds, Houses, or other Property required for the Purposes of this Act, or the Persons to whom they belong, or by whom they are occupied, shall happen to be omitted, misnamed, or improperly described in the Schedule hereto annexed, such Omission, Misnomer, or inaccurate Description shall not retard the Execution of this Act; but the same shall and may be taken and used for the Purposes of this Act in such and the same Manner in all respects as if the Owners and Occupiers thereof had been therein properly named and described, in case it shall appear to Two or more Justices of the Peace for the County of *Forfar*, to be named at a Meeting of the Quarter Sessions of the said County, and be certified by a Writing under their Hands, that such Omission, Misnomer, or inaccurate Description proceeded from Mistake.

Property must be purchased within Five Years.

XXXVIII. And be it further enacted, That all the Powers and Authorities hereby granted for enabling the said Magistrates and Town Council to take and use, for the Purposes of this Act, the Grounds, Houses, and other Buildings, and other Property mentioned in the Schedule to this Act annexed, shall cease and determine at the Expiration of the Space of Five Years from the passing of this Act, except only as to such Grounds, Houses, and other Buildings, and other Property, as the said Magistrates and Town Council may have purchased and acquired, or as may be in progress of being valued, in manner herein mentioned, before the Expiration of the said Term of Five Years, except with the Consent in Writing of the Owner or Owners thereof.

If Part of a House be required, the Owner may cause the Whole to be taken.

XXXIX. And be it further enacted, That in case a Part only of any House or other Building be required for the Purposes of this Act, it shall and may be lawful to the Owner or Owners thereof to require the said Magistrates and Town Council to purchase from such Owner or Owners the Whole of such House or other Building, instead of the Part only which is required; but such Owner or Owners shall be bound to declare his, her, or their Choice in this respect within One Calendar Month after being

being required in Writing to do so; and if such Owner or Owners fail to do so, the said Magistrates and Town Council shall no longer be bound to purchase more of such House or other Building than they find to be necessary for the Purposes of this Act.

XL. And be it further enacted, That if any Money shall be agreed or awarded to be paid for any Grounds, Houses, or other Property purchased or taken or used by virtue of this Act, for the Purposes thereof, which are held under Entail, or are subject to Life Rents, Annuities, or other Incumbrances, or shall belong to any Corporation, Married Woman, Infant, Lunatic, or Person or Persons under any Disability or Incapacity, such Money shall, in case the same shall amount to Two-hundred Pounds, under the Direction and by the Authority of the Court of Session, be with all convenient Speed paid into the Bank of *Scotland*, Royal Bank of *Scotland*, or Bank of the *British* Linen Company of *Scotland*, to the Intent that such Money shall be applied, under the Direction and with the Approbation of the said Court, to be signified by an Order made upon a Petition to be preferred in a summary Way by the Person or Persons who would have been entitled to the Rents and Profits of the said Lands, Tenements, or Heritages, in the Purchase or Redemption of the Land Tax, or Discharge of any Debt or Debts, or such other Incumbrances, or Part thereof, as the said Court shall authorize to be paid, affecting the said Lands, Tenements, or Heritages standing settled therewith to the same or the like Uses, Intents, or Purposes; or where such Money shall not be so applied, then the same shall be laid out and invested, under the like Direction and Approbation of the said Court, in the Purchase of other Lands, Tenements, or Heritages, which shall be conveyed and settled to, for, and upon such of the like Uses, Trusts, Intents, and Purposes, and in the same Manner as the Lands, Tenements, or Heritages, which shall be so purchased, taken, or used as aforesaid, stood settled or limited, or such of them as at the Time of making such Conveyance and Settlement shall be existing undetermined and capable of taking Effect; and in the meantime and until such Purchase shall be made, the Interest or Annual Produce of such Money shall from Time to Time be paid, by Order of the said Court, to the Person or Persons who would for the Time have been entitled to the Rents and Profits of the Lands, Tenements, and Heritages so hereby directed to be purchased, in case such Purchase or Settlement were made:

XLI. Provided always, and be it further enacted, That if any Money so agreed or awarded to be paid for any Lands, Tenements, or Heritages purchased, taken, or used for the Purposes aforesaid, and belonging to any Incorporation, or to any Persons under any Disability or Incapacity as aforesaid, shall be less than the Sum of Two hundred Pounds, and shall exceed the Sum of Twenty Pounds, then and in all such Cases the same shall, at the Option of the Person or Persons for the Time being entitled to the Rents and Profits of the Lands, Tenements, and Heritages so purchased, taken, or used, or of his or their Tutors or Curators, in case of Infancy or Lunacy, to be signified in Writing under their respective Hands, under the like Direction and Authority, be paid into any of the said Banks, and be placed to his, her, or their Accounts as aforesaid, in order to be applied in manner herein-before directed; or otherwise the same shall be paid at the like Option to Two Trustees, to be nominated by the Person or Persons making such Option, and approved of by the Provost and

XLII. Provided also, and be it further enacted, That where such Money so agreed or awarded to be paid as last before mentioned shall be less than Twenty Pounds, then and in all such Cases the same shall be applied to the Use of the Person or Persons who would for the Time being have been entitled to the Rents and Profits of the Lands, Tenements, or Heritages so purchased, taken, or used for the Purposes of this Act, in such Manner as the said Provost and Bailies, or any Three or more of them, shall think fit; or in case of Infancy or Lunacy, then to his, her, or their Tutors and Curators, to and for the Use and Benefit of such Person or Persons so entitled respectively.

Not to be held as Admission of Rights.

XLIII. Provided always, and be it further enacted, That nothing contained herein, or in the Schedule to this Act annexed, shall extend or be construed to extend to be a Declaration or Acknowledgment that any Body or Bodies Corporate or Collegiate, or Person or Persons, from whom the said Magistrates and Town Council are by this Act authorized to purchase or acquire any Grounds, Houses, or other heritable Subjects, or any Interest in any Grounds, Houses, or other heritable Subjects, have a Right or Title thereto; and all such Body or Bodies, Person or Persons, shall be bound, and are hereby required to shew a good and sufficient Title before demanding Indemnification or interrupting the Execution of this Act.

In case of not making out Title.

XLIV. And be it further enacted, That in case any Person or Persons, to whom any Sum or Sums of Money shall be awarded for the Purchase of any Lands, Tenements, or Heritages by virtue of this Act, shall refuse to accept the same, or shall not be able to make out a good Title to the Premises to the Satisfaction of the said Magistrates and Town Council, or in case they are dissatisfied, to the Satisfaction of the Sheriff Depute of *Forfarshire* for the Time, or in case such Person or Persons, to whom such Sum or Sums of Money shall be so awarded as aforesaid, cannot be found, or if the Person or Persons entitled to such Lands, Tenements, or Heritages be not known or discovered, then and in every such Case it shall and may be lawful to and for the said Magistrates and Town Council to order the said Sum of Money so awarded as aforesaid to be paid into the Bank of *Scotland*, or Royal Bank of *Scotland*, or Bank of the *British* Linen Company of *Scotland*, to the Credit of the Parties interested in the said Lands, Tenements, or Heritages (describing them), subject to the Order, Controul, and Disposition of the Court of Session; which said Court, on the Application of any Person or Persons making claim to such Sum or Sums of Money, or any Part thereof, by Petition, shall be and is hereby empowered, in a summary Way of Proceeding or otherwise, as to the said Court shall seem meet, to order the same to be laid out and invested in the Public Funds, and to order Distribution thereof, or Payment of the Dividends thereof, according to the respective Estate or Estates, Title or Interest of the Person or Persons making such Claim thereunto, and to make such other Order
in

in the Premises as to the said Court shall seem just and reasonable; and the Cashier or Cashiers of the Bank of *Scotland*, or Royal Bank of *Scotland*, or Bank of the *British Linen Company of Scotland*, who shall receive such Sum or Sums of Money, is and are hereby required to give a Receipt or Receipts for such Sum or Sums of Money, mentioning and specifying for what and for whose Use the same is or are received, to such Person or Persons as shall pay any such Sum or Sums of Money into the Bank aforesaid.

XLV. Provided always, and be it further enacted, That where any Question shall arise touching the Title of any Person to any Money to be paid into the Bank of *Scotland*, Royal Bank of *Scotland*, or Bank of the *British Linen Company of Scotland*, under the Direction and by the Authority of the Court of Session in pursuance of this Act, for the Purchase of any Lands, Tenements, or Heritages, or any Estate, Right, or Interest in any Lands, Tenements, or Heritages to be purchased with any such Money, or to the Rents or Profits thereof, the Person or Persons who shall have been in possession of such Lands, Tenements, or Heritages at the Time of such Purchase, and all Persons claiming under such Person or Persons, shall be deemed and taken to have been lawfully entitled to such Lands, Tenements, or Heritages according to such Possession, until the contrary shall be shewn to the Satisfaction of the said Court; and the Rents and Profits of the Lands, Tenements, and Heritages to be purchased with such Money, and also the Lands, Tenements, and Heritages so purchased, shall be paid, applied, and disposed of accordingly, unless it shall be made to appear to the said Court that such Possession was a wrongful Possession, and that some other Person or Persons was or were lawfully entitled to such Lands, Tenements, or Heritages, or to some Estate or Interest therein.

Where Question shall arise as to the Right to Money.

XLVI. Provided also, and be it further enacted, That where by reason of any Disability and Incapacity of the Person or Persons, or Corporation, entitled to any Lands, Tenements, or Heritages, to be purchased under the Authority of this Act, the Purchase Money for the same shall be required to be paid into the said Court, and to be applied to the Purchase of other Lands, Tenements, or Heritages, to be settled to the like Uses in pursuance of this Act, it shall be lawful for the said Court to order the Prices and other Expences of all Purchases to be made from Time to Time in pursuance of this Act, or of so much of such Prices or other Expences as the Court shall deem reasonable, to be paid by the said Magistrates and Town Council, who shall from Time to Time pay such Sums of Money for such Purchases as the said Court shall direct.

Court may order Payment of Expences of Purchases in Cases of Incapacity.

XLVII. And be it further enacted, That the said Magistrates and Town Council shall have Power to appoint Committees of their Number for executing the Purposes of this Act, or any of them; and the Acts of such Committee, provided they are not beyond the Powers conferred on such Committee, or inconsistent with the Provisions of this Act, shall be as good and sufficient as the Act of the whole Body; any thing herein contained to the contrary notwithstanding: Provided always, that such Committees shall be subject at all Times to the Controul of the said Magistrates and Council, and shall be bound to report their Proceedings to the said Magistrates and Town Council from Time to Time when required.

Provided always, and be it enacted, That nothing in this Act contained shall extend or be construed to extend to abridge any of the Rights and Privileges of the Deacons of Trades of *Dundee*, in regard to the alienating of the Common Good or Property of the Burgh, or to authorize the said Magistrates and Council to do any thing inconsistent with the Rights and Privileges of the said Deacons.

XLIX. And be it enacted, That the Charges and Expences of obtaining and passing this Act shall be defrayed by the said Magistrates and Town Council out of the ordinary Revenue and Common Good of the said Burgh.

Public Act.

L. And be it enacted, That this Act shall be deemed and taken to be a Public Act, and shall be judicially taken Notice of as such by all Judges, Justices, and others, without being specially pleaded.
