CHAPTER cv.

An Act to confirm a Provisional Order under A.D. 1922. the Salmon and Freshwater Fisheries Act 1907 extending and modifying the Norfolk Fisheries Provisional Order 1912. [4th August 1922.]

WHEREAS the Minister of Agriculture and Fisheries has made the Provisional Order set forth in the schedule hereto under the provisions of the Salmon and 7 Edw. 7. Freshwater Fisheries Act 1907:

And whereas it is requisite that the said Order should be confirmed by Parliament:

Be it therefore enacted by the King's most Excellent Majesty by and with the advice and consent of the Lords Spiritual and Temporal and Commons in this present Parliament assembled and by the authority of the same as follows:—

- 1. The Order as set out in the schedule hereto shall Order in be and the same is hereby confirmed and all the provisions confirmed. thereof shall have full validity and force.
- 2. This Act may be cited as the Norfolk Fisheries Short title. Provisional Order Confirmation Act 1922.

SCHEDULE.

NORFOLK FISHERIES PROVISIONAL ORDER 1922.

The Minister of Agriculture and Fisheries by virtue and in exercise of the powers vested in him under the Salmon and Freshwater Fisheries Act 1907 and the Norfolk Fisheries Provisional Order 1912 (herein referred to as "the Order of 1912") with a view to the improvement and development of the freshwater fisheries in the area as defined by the Order of 1912 and extended by this Order hereby makes the following Provisional Order:

Extension of operation of Order of 1912.

1. Section nineteen of the Order of 1912 is hereby repealed and the operation of the provisions of that Order is hereby extended accordingly with such modifications of those provisions as are contained in this Order.

Application of Order to Oulton Broad.

2. The Order of 1912 as hereby modified shall after the thirty-first day of December nineteen hundred and twenty-two apply to Oulton Broad.

Fishery Board to include members appointed by Lowestoft Borough Council.

3. Section two of the Order of 1912 shall be modified so as to provide that after the said date the members appointed under paragraph (A) of that section shall include four members appointed by the council of the borough of Lowestoft.

Extension of Order of 1912 to certain fisheries in River Wensum.

4. The Order of 1912 as hereby modified shall after the said date apply to the freshwater fisheries in the River Wensum between Hellesden Mill dam and Taverham Mill in the parish of Taverham in the county of Norfolk.

Application of existing scales of licence duties and byelaws.

- 5. Any scale of licence duties or byelaws in force on the said date in the area to which the Order of 1912 applied shall after the said date be in force in the said area as extended by this Order.
- 6. This Order may be cited as the Norfolk Fisheries Provisional Order 1922.
 - In witness whereof the Minister of Agriculture and Fisheries has caused his Official Seal to be hereunto affixed this nineteenth day of May nineteen hundred and twenty two.
