

CHAPTER xv.

An Act to confirm a Provisional Order under A.D. 1926. the Private Legislation Procedure (Scotland) Act 1899 relating to Ayrshire Electricity.

[16th June 1926.]

HEREAS His Majesty's Secretary for Scotland has made the Provisional Order set forth in the schedule hereunto annexed under the provisions of the Private Legislation Procedure (Scotland) Act 1899 and it 62 & 63 Vict. is requisite that the said Order should be confirmed by c. 47. Parliament:

Be it therefore enacted by the King's most Excellent Majesty by and with the advice and consent of the Lords Spiritual and Temporal and Commons in this present Parliament assembled and by the authority of the same as follows:—

AYRSHIRE ELECTRICITY.

Provisional Order to extend the time for the compulsory purchase of lands authorised by the Ayr Burgh (Electricity) Act 1922.

WHEREAS by the Ayr Burgh Electric Lighting Orders 1890 and 1914 and the Ayr Burgh (Electricity) Act 1922 (in this Order referred to as "the Act of 1922") the provost magistrates and councillors of the burgh of Ayr (hereinafter referred to as "the Ayr Corporation") were authorised to construct a generating station and other works and to supply electricity within the said burgh and other places in the county of Ayr and for those purposes to acquire lands in the counties of Ayr and Kirkcudbright:

And whereas by the Kilmarnock Electricity Orders 1899 to 1922 the provost magistrates and councillors of the burgh of Kilmarnock (hereinafter referred to as "the Kilmarnock Corporation") were authorised to construct a generating station and other works and to supply electricity within that burgh and other places in the said county of Ayr:

And whereas by the Ayrshire Electricity Special Order 1924 the Ayrshire Electricity Board (in this Order referred to as "the Board") were constituted under the Electricity (Supply) Acts 1882 to 1922 and by that Order the electricity undertakings of the Ayr Corporation and the Kilmarnock Corporation were transferred to the Board:

And whereas it is expedient that the time limited by the Act of 1922 for the compulsory purchase of the lands required for the purposes of that Act should be extended as hereinafter provided:

And whereas the purpose aforesaid cannot be effected without an Order of the Secretary for Scotland

confirmed by Parliament under the provisions of the A.D. 1926. Private Legislation Procedure (Scotland) Act 1899:

Now therefore in pursuance of the powers contained in the last-mentioned Act the Secretary for Scotland orders as follows:—

- 1. This Order may be cited for all purposes as Short and the Ayrshire Electricity Order 1926 and the Ayrshire collective Electricity Special Order 1924 and this Order may be titles. cited together as the Ayrshire Electricity Orders 1924 and 1926.
- 2. The time limited by section 11 (Period for Extension compulsory purchase of lands) of the Act of 1922 is of time for hereby extended for a period of five years from the lands under fourth day of August one thousand nine hundred and Act of twenty-seven and on the expiration of that period 1922. the powers in that section mentioned shall cease.
- 3. All costs charges and expenses of and incident Costs of to the preparing for obtaining and confirming this Order. Order or otherwise in relation thereto shall be paid by the Board.
