



CHAPTER xxiv

An Act to confirm certain Provisional Orders made by one of His Majesty's Principal Secretaries of State under the Marriages Validity (Provisional Orders) Acts 1905 and 1924. [30th July 1949.]

WHEREAS under the provisions of the Marriages Validity (Provisional Orders) Acts 1905 and 1924 one of His Majesty's Principal Secretaries of State has made Provisional Orders which need confirmation by Parliament: 5 Edw. 7. c. 23.
14 & 15 Geo. 5.
c. 20.

Be it therefore enacted by the King's most Excellent Majesty by and with the advice and consent of the Lords Spiritual and Temporal and Commons in this present Parliament assembled and by the authority of the same as follows:—

1. The Orders of the Secretary of State which are set out in the schedule to this Act are hereby confirmed and shall have full validity and force. Orders in schedule confirmed.

2. This Act may be cited as the Provisional Orders (Marriages) Confirmation Act 1949. Short title.

SCHEDULE

NEW SYNAGOGUE HACKNEY ORDER

WHEREAS power is given to a Secretary of State by the Marriages Validity (Provisional Orders) Acts 1905 and 1924 in the case of marriages solemnised in England which appear to him to be invalid or of doubtful validity by reason of some informality to make a Provisional Order for the purpose of removing the invalidity or doubt and to include in such Order supplemental incidental and consequential provisions including provisions for relieving from liability ministers who have solemnised the marriages to which the Order relates:

And whereas on the third day of February one thousand nine hundred and forty-six a marriage was solemnised according to the usages of the Jews at the New Synagogue Hackney in the registration district of Hackney in the county of London:

And whereas the said place being a place other than that named in the notice entered and the certificate issued by the Superintendent Registrar for the area and it is expedient in the circumstances aforesaid to remove all doubt touching the validity of such marriage and to make certain supplemental incidental and consequential provisions:

Now therefore I the Right Honourable James Chuter Ede one of His Majesty's Principal Secretaries of State in pursuance of the powers conferred on me by the said Marriages Validity (Provisional Orders) Acts 1905 and 1924 do hereby order that on and after the date of the Act of Parliament confirming this Order the following provisions shall have effect:—

- (1) The marriage solemnised on the third day of February one thousand nine hundred and forty-six in the New Synagogue Hackney which is situate in the county of London shall be deemed to have been as valid as if it had been solemnised in the place named in the notice entered and the certificate issued by the superintendent registrar for the area:
- (2) The minister who has solemnised the marriage referred to in the first paragraph of this Order shall not be liable to any proceedings whatsoever in respect thereof:
- (3) The register of the marriage so solemnised or copies of the register shall be received in all courts as evidence of this marriage in the same manner as registers of marriages duly solemnised or copies thereof are by law receivable in evidence.

“ROSEVILLE” VINE STREET SALFORD ORDER

WHEREAS power is given to a Secretary of State by the Marriages Validity (Provisional Orders) Acts 1905 and 1924 in the case of marriages solemnised in England which appear to him to be invalid or of doubtful validity by reason of some informality to make a Provisional Order for the purpose of removing the invalidity or doubt and to include in such Order supplemental incidental and consequential provisions including provisions for relieving from liability ministers who have solemnised the marriages to which the Order relates:

And whereas on the ninth day of November one thousand nine hundred and forty-seven a marriage was solemnised according to the usages of the Jews at “Roseville” Vine Street Salford in the county of Lancashire:

And whereas the said place being a place other than that named in the notice entered and the certificate issued by the superintendent registrar for the district and the said marriage having been solemnised after the expiration of three months after the entry of the said notice it is expedient in the circumstances aforesaid to remove all doubt touching the validity of such marriage and to make certain supplemental incidental and consequential provisions:

Now therefore I the Right Honourable James Chuter Ede one of His Majesty's Principal Secretaries of State in pursuance of the powers conferred on me by the said Marriages Validity (Provisional Orders) Acts 1905 and 1924 do hereby order that on and after the date of the Act of Parliament confirming this Order the following provisions shall have effect:—

- (1) The marriage solemnised on the ninth day of November one thousand nine hundred and forty-seven in “Roseville” Vine Street Salford in the county of Lancashire shall be deemed to have been as valid as if it had been solemnised in the place named in the notice entered and the certificate issued by the superintendent registrar for the district and within three months of the entry of the said notice;
- (2) The minister who has solemnised the marriage referred to in the first paragraph of this Order shall not be liable to any proceedings whatsoever in respect thereof;
- (3) The register of the marriage so solemnised or copies of the register shall be received in all courts as evidence of this marriage in the same manner as registers of marriages duly solemnised or copies thereof are by law receivable in evidence.
