CHAPTER xiii.

An Act to confirm a Provisional Order of the Minister of Health relating to the borough of Colchester. [28th April 1939.]

WHEREAS under the provisions of the Public 38 & 39 Vict. Health Act 1875 the Minister of Health has c. 55. made a Provisional Order which needs confirmation by Parliament:

Be it therefore enacted by the King's most Excellent Majesty by and with the advice and consent of the Lords Spiritual and Temporal and Commons in this present Parliament assembled and by the authority of the same as follows:—

- 1. The order of the Minister of Health which is set Order in out in the schedule to this Act is hereby confirmed and schedule shall have full validity and force.
- 2. This Act may be cited as the Ministry of Health Short title. Provisional Order Confirmation (Colchester) Act 1939.

SCHEDULE.

BOROUGH OF COLCHESTER.

Provisional Order for partially repealing a local Act.

WHEREAS the mayor aldermen and burgesses of the borough of Colchester (in this order called "the borough") acting by the council (in this order called "the corporation") propose to 26 Geo. 5. & make byelaws under the Public Health Act 1936 with respect to buildings;

And whereas the proposed by elaws will deal with the same 10 & 11 Viet. subject matter as certain provisions of the Towns Improvement Clauses Act 1847 incorporated with and forming part of an Act passed in the tenth and eleventh year of the reign of Her 10 & 11 Vict. Majesty Queen Victoria intituled "An Act to amend an Act "for improving the Navigation from the Hythe at Colchester "to Wivenhoe in the County of Essex and for better paving "lighting and improving the Town of Colchester and for "making a new Channel and deepening the River Colne from "Wivenhoe to Ram's Hard leading towards the Sea" (hereinafter referred to as the local Act) which is now in force in the borough;

> And whereas the corporation have applied to the Minister of Health for the issue of a provisional order partially to repeal the local Act in the manner following:

> Now therefore the Minister of Health in pursuance of the powers given to him by section 303 of the Public Health Act 1875 and of all other powers enabling him in that behalf hereby orders as follows:—

Repeal of section of local Act.

1. Section III (10 & 11 Vict. c. 34 incorporated with this Act) of the local Act shall be repealed on the date on which byelaws made by the corporation under the Public Health Act 1936 with respect to buildings come into operation.

Short title.

2. This order may be cited as the Colchester Order 1939.
