

CHAPTER li.

An Act to authorise and facilitate the erection of a Cathedral A.D. 1885. Church for the Diocese of Liverpool on the site of Saint John's Church in the parish of Liverpool, and to make other provisions relative thereto; to provide for the foundation of a Dean and Chapter of Liverpool; and for other [25th June 1885.] purposes.

WHEREAS the bishopric of Liverpool has been founded under the Bishoprics Act 1878 and by an Order in Council under 41 & 42 Vict. that Act dated the twenty-fourth day of March one thousand eight c. 68. hundred and eighty the parish church of Saint Peter in Liverpool (subject to the rights of the patron and incumbent thereof) has been assigned as a cathedral church to the said bishopric:

And whereas the said church of Saint Peter is by reason of its small size and the want of space about it ill adapted for a cathedral church and the reservation of rights of patron and incumbent might lead to inconvenience on the foundation of a cathedral body:

And whereas in these circumstances a committee has been appointed by a public meeting of inhabitants of Liverpool to consider the question of a site for a new cathedral church:

And whereas that committee (herein-after referred to as "the Cathedral Committee") has after full and careful inquiry reported that the best available site for the purpose is the site now occupied by the church and churchyard of Saint John in the parish of Liverpool:

And whereas the said church of Saint John was erected by commissioners appointed under two Acts of the second and seventh 2 G. 3. c. 68. years of the reign of King George the Third (whereof the titles are 7 G. 3. c. 80. set out in the First Schedule hereto) on certain lands granted by the corporation of the city of Liverpool (herein-after referred to as "the corporation") in exchange for lands belonging to the parishioners of Liverpool:

And whereas in or about the year one thousand eight hundred and twenty-eight two parcels of land adjoining the east side of the [Local.-51.]

then existing churchyard of Saint John's church and containing together about one thousand two hundred and seventy-three square yards were granted by the corporation for the purpose of enlarging the said churchyard and were duly set apart and consecrated as part of the churchyard of the said church for ever:

And whereas it is expedient to vest the said church and church-yard in the Ecclesiastical Commissioners for England (herein-after referred to as "the Ecclesiastical Commissioners") for the purpose of the erection of a cathedral church of Liverpool on the site thereof and to incorporate the Cathedral Committee and to authorise the Committee so incorporated to remove the said church of Saint John and to erect such cathedral church as aforesaid and to raise funds and to take all other necessary and proper steps for those purposes:

And whereas under the said Act of the second year of the reign of King George the Third there is payable to the minister of the said church fifty pounds annually out of the parochial rates of the parish of Liverpool and not exceeding one hundred pounds annually out of the pew rents of the said church and any deficiency of such pew rents to meet the stipends and other payments charged thereon is directed to be made good out of the parochial rates aforesaid:

And whereas under the Act of the session of the first and second years of the reign of Her present Majesty (whereof the title is set forth in the First Schedule hereto) the sum of twenty pounds annually is payable by the corporation out of the city or borough fund to the minister of Saint John's Church and the sum of one hundred pounds annually is payable to the curate of the said church out of the said parochial rates or out of a rate to be made for the purpose:

And whereas it is expedient to provide for the commutation and extinction of the said payments and for the application of the commutation moneys in manner in this Act mentioned:

And whereas under an Order in Council dated the ninth day of August one thousand eight hundred and sixty-six the sum of eighty-eight pounds is payable annually to the minister of Saint John's Church by the Ecclesiastical Commissioners out of their common fund and it is expedient that upon the cesser of the office of such minister in pursuance of this Act the said sum should be no longer payable and should cease to be paid:

And whereas by a deed dated the fifteenth day of June one thousand eight hundred and fifty the district whereof the boundaries are described in the Second Schedule to this Act was assigned by the Lord Bishop of Chester to the said church of Saint John:

And whereas the church population of the said district is small A.D. 1885. and the said district may be advantageously re-united to or merged in the parish of Liverpool out of which it was originally formed and the rector of the parish of Liverpool and the patrons of the said rectory have signified their consent thereto:

And whereas the right to present to the office of minister of the church of Saint John is now vested in Mark Wilks Collet and Thomas Whalley is the present minister thereof:

And whereas it is expedient that the said office should cease and be extinguished and the said Mark Wilks Collet and Thomas Whalley have signified their consent thereto on such provision being made for compensation to the said Thomas Whalley as is in this Act contained:

And whereas under the Bishoprics Act 1878 the Liverpool 41 & 42 Vict. Bishopric Endowment Fund is held by the Ecclesiastical Commis- c. 68. sioners on trust to provide the income therein mentioned and a residence for the Bishop of Liverpool and subject thereto to make good to the bishopric of Chester the portion of the endowment or income of that bishopric transferred in pursuance of the said Act to the bishopric of Liverpool and subject as aforesaid on trust for the foundation of a dean and chapter for the bishopric of Liverpool in such manner as may be from time to time provided by Orders in Council:

And whereas it is expedient to make such provisions for the foundation of a dean and chapter of Liverpool as are in this Act contained:

And whereas the objects of this Act cannot be attained without the authority of Parliament:

May it therefore please Your Majesty that it may be enacted and be it enacted by the Queen's most Excellent Majesty by and with the advice and consent of the Lords Spiritual and Temporal and Commons in this present Parliament assembled and by the authority of the same (as follows):

1. This Act may be cited as the Liverpool Cathedral Act 1885.

Short title.

Cathedral Committee.

2. The several persons whose names are set forth in the Third Incorpora-Schedule to this Act (being at the time of passing this Act the members of the Cathedral Committee above mentioned) together Committee. with all persons who shall at any time become members of such Committee are hereby incorporated by the name of the Liverpool Cathedral Committee (in this Act called "the Cathedral Committee") with perpetual succession and a common seal and with power to acquire and hold lands without any license in mortmain

Cathedral

A.D. 1885. and from time to time to sell let or otherwise dispose of the same and with such other powers capacities rights and duties as are in this Act mentioned or as are incidental to the purposes of their constitution.

> Additional members of the Cathedral Committee may at any time be elected by a general meeting of the Committee to be summoned with special notice of the object.

Meetings and proceedings of Cathedral Committee.

- 3.—(1) Seven members of the Cathedral Committee must be personally present to constitute a meeting of the Committee for the transaction of business.
- (2) Any five members may at any time summon a meeting of the Cathedral Committee.
- (3) Questions arising at a meeting of the Cathedral Committee are decided by a majority of votes and in case of an equality of votes the member in the chair at the meeting has a second or casting vote.
- (4) Subject as aforesaid the Cathedral Committee may meet together for the despatch of business adjourn and otherwise regulate the proceedings of the Committee as the Committee from time to time thinks fit.

Chairman of Cathedral Committee.

- 4.—(1) The Lord Bishop of Liverpool shall be entitled to preside at every meeting of the Cathedral Committee at which he shall be present.
- (2) In case of his absence or unwillingness to preside the members present shall choose a chairman unless a deputy chairman of the Cathedral Committee shall be present.
- (3) The Cathedral Committee may from time to time appoint a deputy chairman who shall be entitled to preside at all meetings at which the Lord Bishop of Liverpool does not preside.

Honorary treasurers and secretaries.

5. Sir William Bower Forwood knight and John Prescott shall be honorary treasurers and Clarke Aspinall and Arthur Earle shall be lay secretaries and John Rashdall Eyre and Samuel Wilkinson shall be clerical secretaries of the Cathedral Committee and any vacancy in their number may be from time to time supplied by that Committee and the receipt of any such treasurer shall be a full and effectual discharge for all moneys received for or on account of the Cathedral Committee under this Act or otherwise.

Exercise of powers of Cathedral Committee by executive committee.

6.—(1) Subject to any such restrictions and regulations as may from time to time be laid down or made by the Cathedral Committee all powers and duties conferred or imposed on the Cathedral Committee by this Act or otherwise belonging to the Cathedral Committee may be from time to time exercised and performed by the executive committee herein described.

- (2) John Charles Lord Bishop of Liverpool Thomas Espinell A.D. 1885. Espin chancellor of the diocese of Liverpool Alexander Stewart rector of Liverpool George Winter Warr honorary canon of Liverpool Sir James Allanson Picton knight Alfred Turner Thomas Shelmerdine the younger William Bartlett the mayor of Liverpool for the time being and Sir William Bower Forwood knight and John Prescott (the honorary treasurers) and Clarke Aspinall and Arthur Earle (the lay secretaries) and John Rashdall Eyre and Samuel Wilkinson (the clerical secretaries) shall be the first members of the executive committee of the Cathedral Committee as constituted by this Act.
- (3) Any vacancy in their number occurring by death resignation or otherwise may be filled by the Cathedral Committee as and when they see fit but so that the number of members of the executive committee be not in any event reduced below nine.
- (4) The executive committee may from time to time appoint a chairman.
- 7.—(1) Three members of the executive committee must be Meetings personally present to constitute a meeting of the committee for the transaction of business.

- (2) The chairman or any two members of the executive com- mittee. mittee may at any time summon a meeting of the committee.
- (3) Questions arising at a meeting of the executive committee are decided by a majority of votes and in case of an equality of votes the member in the chair at the meeting has a second or casting vote.
- (4) Subject as aforesaid the executive committee may meet together for the despatch of business adjourn and otherwise regulate the proceedings of the committee as the committee from time to time thinks fit.

Erection of Cathedral on site of Saint John's Church and relative provisions.

8. On and from the first day of January one thousand eight Suppression hundred and eighty-eight the office of minister of the church of Saint John in the parish of Liverpool and the advowson or right of Saint John's presentation thereto and all powers rights duties and obligations church and attaching thereto shall cease and be extinguished and all powers commisduties liabilities and obligations of the corporation and of the com- sioners. missioners appointed under the said Acts of the second and seventh 2 G. 3. c. 68. years of the reign of King George the Third shall also so far as ⁷ G. 3. c. 80. they relate to the said church and churchyard or to any office connected therewith cease and be extinguished.

Site of Saint John's church and churchyard vested in Ecclesiastical Commissioners.

9. On and from the first day of January one thousand eight hundred and eighty-eight the said church of Saint John and churchyard shall by virtue of this Act be absolutely vested for an estate in fee simple in possession in the Ecclesiastical Commissioners for the purpose of the erection of a cathedral church on the site thereof by the Cathedral Committee and for the other purposes mentioned in this Act.

Power of Cathedral Committee to erect cathe-

10. The Cathedral Committee are hereby authorised at any time after such vesting as aforesaid to take down and remove wholly or partially the said church of Saint John and on the site dral church. thereof and of the said churchyard to erect a suitable cathedral church for the diocese of Liverpool and for that purpose to receive subscriptions to enter into contracts and generally to do all things necessary or proper and the cathedral so erected shall vest in the Ecclesiastical Commissioners for the same estate as the said church and churchyard by virtue of this Act Provided always that no more of the said churchyard shall be disturbed than is necessary for the erection thereon of the said cathedral church and the works incidental thereto.

Saint Peter's church to cease to be cathedral church.

11. On and from the date of opening the cathedral church to be erected under the powers of this Act for divine service the parish church of Saint Peter in Liverpool shall cease to be the cathedral church of the bishopric of Liverpool notwithstanding anything in the recited Order in Council of the twenty-fourth day of March one thousand eight hundred and eighty and the cathedral church erected as aforesaid shall be to and for all intents and purposes the cathedral church of the said bishopric.

Commutation of payments and liabilities by corporation and churchwardens of Liverpool. 1 & 2 Viet. c. 98. s. 24.

- 12.—(1) In commutation of the yearly sum of twenty pounds payable to the minister of the church of Saint John by the corporation under the recited Act of the session of the first and second years of Her present Majesty's reign the corporation shall on or before the first day of January one thousand eight hundred and eighty-eight pay to the Cathedral Committee out of the city fund the sum of five hundred pounds and on payment thereof the corporation and the city fund shall be for ever released and discharged from payment of the said yearly sum of twenty pounds.
- (2) In commutation of the annual sums paid before the passing of this Act to the minister and to the curate of the church of Saint John out of any parochial rates or rate of the parish of Liverpool the churchwardens of the said parish shall on or before the first day of January one thousand eight hundred and eighty-eight pay to the Cathedral Committee such sum as shall be agreed or as in default of agreement shall be settled by the Ecclesiastical Commissioners and

on payment of the sum so agreed or settled the said annual sums A.D. 1885. shall cease to be payable and be extinguished but until payment of the sum so agreed or settled the said annual sums shall continue to be payable and recoverable as if this Act had not been passed.

- (3) The sum payable in commutation as last aforesaid shall be paid by the said churchwardens out of any funds in their hands applicable to the stipends of the said minister and curate and so far as such funds prove insufficient shall be assessed raised levied and paid upon and by the occupiers of houses and buildings in the parish of Liverpool at the same time and in the same manner in all respects as if the said sum were part of the sum of nine hundred and sixty pounds mentioned in section thirty-two of the said recited Act of the session of the first and second years of Her Majesty's reign and that section and the provisions therein referred to of the Act of the twenty-sixth year of the reign of King George the Third chapter fifteen shall be read and have effect and be put in force accordingly.
- (4) All sums received by the Cathedral Committee under this section shall be applied by them in or towards payment of compensation to the minister of Saint John's church under this Act and any balance remaining after such payment shall be carried to the Liverpool Chapter Endowment Fund herein-after mentioned.
- 13. The churchwardens of the parish of Liverpool may from Power of time to time borrow on mortgage of the rate leviable under the churchsaid Act of the twenty-sixth year of the reign of King George the wardens Third chapter fifteen all or any part of the sum payable by them in commutation as aforesaid and may assign the said rate as security for repayment with interest of any moneys so borrowed accordingly Provided that all moneys borrowed under this section shall be repaid within twenty years from the time or respective times of borrowing the same and that all sums from time to time required for payment of interest or repayment of principal shall be from time to time provided and raised out of and by the rate aforesaid and all powers for assessing levying and recovering the same shall continue and be put in force accordingly.

A mortgage of the said rate in the form in the Fourth Schedule to this Act shall be valid and effectual to and for all intents and purposes.

14. The sum of eighty-eight pounds payable annually to the As to payminister of the church of Saint John by the Ecclesiastical Commis- ment of sioners out of their common fund shall from and after the first day pounds by of January one thousand eight hundred and eighty-eight cease to be payable or paid by the said Commissioners.

Compensation to minister of Saint John's church.

15. Within six months after the date fixed by this Act for the suppression of the office of minister of Saint John's church the Cathedral Committee shall pay to Thomas Whalley if minister of Saint John's church at the date so fixed such sum as shall be agreed or as in default of agreement shall be settled by the Ecclesiastical Commissioners as full compensation for his interest in the said office as from the said date.

Reference of difference to Ecclesiastical Commissioners.

16. Any difference arising between the Cathedral Committee on the one hand and the churchwardens of Liverpool or the said Thomas Whalley on the other hand as to the amount of commutation or compensation moneys payable to or by the said Committee under this Act shall on the application of either party to the difference stand referred to and be finally and conclusively settled by the Ecclesiastical Commissioners.

Merger of Saint John's district in parish of Liverpool.

17. On and from the first day of January one thousand eight hundred and eighty-eight the ecclesiastical district of Saint John whereof the boundaries are described in the Second Schedule to this Act shall by virtue of this Act cease to exist as a separate ecclesiastical district and shall be re-united to and merged in the parish of Liverpool for all ecclesiastical purposes and shall form part of the benefice and cure of souls of the rectory and parish of Liverpool.

As to removal of remains from churchyard.

- 18.—(1) If the Cathedral Committee shall be of opinion and shall determine that it is necessary or desirable to remove the Saint John's remains of any deceased person interred in the church or churchyard of Saint John they shall communicate in writing such their opinion and determination to the heirs executors or administrators or relatives of such deceased person unless they cannot after reasonable inquiry be found.
 - (2) At any time within three months after the date of such a communication it shall be lawful for the heirs executors administrators or relatives of the deceased person (subject to any regulations which may be made by the Lord Bishop of Liverpool for the time being) to cause the remains of the deceased person without any faculty for that purpose to be removed to and interred in any burial ground or cemetery in which burials may legally take place.
 - (3) The expenses of such removal and interment not exceeding in the case of remains removed from any one grave the sum of ten pounds shall be defrayed by the Cathedral Committee.
 - (4) If the heirs executors administrators or relatives of any such deceased person as aforesaid cannot after reasonable inquiry be found or if they fail within three months after the date of such a communication as aforesaid to exercise the powers by this section

conferred on them it shall be lawful for the Cathedral Committee to A.D. 1885. remove the remains of the deceased person and to cause them to be interred in such place and manner as the said Lord Bishop shall direct or sanction.

- (5) The removal of remains shall in all cases be carried out under the supervision and to the satisfaction of the medical officer of health of the city of Liverpool.
- 19. The footpath across Saint John's churchyard to which the public are now admitted on sufferance pursuant to a faculty dated Saint John's the fourth day of December one thousand eight hundred and churchyard. seventy-nine may be at any time closed by an order of the Ecclesiastical Commissioners whereof a copy shall be affixed in a conspicuous position at each end of the said footpath for a period of at least one month and from and after the date of any such order the corporation shall be relieved from the payment of fifteen pounds per annum to the incumbent and churchwardens of the church of Saint John and from all other liabilities imposed on or undertaken by them in consideration of or pursuant to the said faculty.

As to foot-

Dean and Chapter.

20. So much of the Liverpool Bishopric Endowment Fund as Liverpool shall pursuant to section eight of the Bishoprics Act 1878 be held Chapter on trust for the foundation of a dean and chapter for the bishopric Fund. shall together with all donations legacies and other sums from time to time applicable to the foundation of such dean and chapter form and be entitled the Liverpool Chapter Endowment Fund.

Endowment

21.—(1) Whenever the Ecclesiastical Commissioners certify to Establish-Her Majesty under their common seal that the net income of the Liverpool Chapter Endowment Fund will provide such minimum Liverpool. income as herein-after mentioned for a dean and not less than four residentiary canons Her Majesty may by Order in Council found a dean and chapter of Liverpool and constitute them a body corporate with all the rights and powers of other cathedral chapters in England or with such of them as to Her Majesty may seem fit and may subject them to the jurisdiction of the Bishop of Liverpool as visitor.

(2) The dean and chapter of Liverpool and the endowment thereof shall be deemed for all purposes to be subject to the same laws as the dean and chapter of any other cathedral church in England and the endowment thereof and the deanery shall be in the direct patronage of Her Majesty and every canonry shall be in the patronage of the Bishop of Liverpool for the time being.

(3) It shall be lawful for Her Majesty from time to time by Order in Council to make and when made to alter and revoke statutes for the order rule and governance of the dean and chapter of Liverpool and the members officers and endowment thereof.

Income of dean and canons of Liverpool.

22. For the purposes of this Act the minimum income shall be a net annual income for a dean of one thousand pounds and for a canon of three hundred pounds exclusive in both cases of the value of any residence.

Provision for establishment of canons at Liverpool before foundation of dean and chapter.

- 23.—(1) Whenever from time to time before the foundation of a dean and chapter of Liverpool the Ecclesiastical Commissioners certify to Her Majesty under their common seal that the net income of the Liverpool Chapter Endowment Fund will provide such minimum income as is mentioned in this Act for any canon or canons Her Majesty by Order in Council may establish a residentiary canonry or residentiary canonries in the cathedral church of Liverpool and assign thereto an income not being less than the minimum income and by the same or any other Order in Council may from time to time define the duties which an incumbent of any such canonry is to perform in the said cathedral church and in the administration of the diocese of Liverpool.
- (2) Every canonry established in pursuance of this section shall be in the patronage of the Bishop of Liverpool for the time being and the incumbent of every such canonry shall hold his office by the same tenure as the incumbent of any other canonry in England and subject to any exceptions contained in any such Order in Council the law relating to other canonries in England shall so far as may be consistently with the tenour thereof and with the circumstances of the case apply to a canonry so established and to the incumbent thereof.

Trusts of
Liverpool

- 24.—(1) The Liverpool Chapter Endowment Fund shall be held on trust for the ordinary maintenance of the cathedral and its services and for the foundation of a dean and chapter of Liverpool.
- (2) Any surplus annual income arising from the Liverpool Chapter Endowment Fund before the foundation of the dean and chapter in pursuance of this Act shall till such foundation be applied in paying the incumbent of any canonry established in pursuance of this Act and subject to that payment shall be invested and accumulated as part of the fund.
- (3) The Ecclesiastical Commissioners shall have the same power with respect to sale investment management leasing or other dealing in the case of the fund as they have in the case of the Liverpool Bishopric Endowment Fund.

25. The Ecclesiastical Commissioners may from time to time A.D. 1885. submit for the approval of Her Majesty in Council a scheme or schemes:—

Schemes of Ecclesiastical Commissioners.

- (a) For transferring to the dean and chapter of Liverpool when founded the Liverpool Chapter Endowment Fund and
- (b) For making such provisions and arrangements as may be necessary for carrying into complete effect the foundation of the dean and chapter of Liverpool and the establishment of any canonry or canonries minor or honorary canonry or canonries and other offices (lay or clerical) in the cathedral church of Liverpool and this Act and any Order in Council made thereunder and all matters incidental to anything before in this section mentioned.
- 26.—(1) An Order in Council made in pursuance of this Act Validity and shall have effect as if it were enacted in this Act.

- (2) An Order in Council made in pursuance of this Act shall be Council. published in the London Gazette and laid before both Houses of Parliament forthwith after it is made if Parliament be then in session or if not then within one month after the commencement of the then next session of Parliament.
- (3) A scheme made in pursuance of this Act shall be of no effect till it has been approved by Order in Council.
- 27. Nothing in this Act shall authorise the Ecclesiastical Com- Common missioners to apply any portion of their common fund towards the endowment of the dean and chapter of Liverpool or of any canonry in the cathedral church of Liverpool.

Miscellaneous Provisions.

28. All sums payable in commutation of any payment or liability Recovery of or by way of compensation to any person under the powers of this Act may (without prejudice to any other remedy or mode of pro- Act. ceeding by action or otherwise) be recovered summarily in manner provided by the Summary Jurisdiction Acts.

29. The costs charges and expenses preliminary and incidental Costs of Act. to the preparation and obtaining of this Act shall be paid by the Cathedral Committee out of any moneys coming to their hands under the provisions of this Act and not otherwise specifically appropriated by this Act.

30. Except as by this Act otherwise specially provided nothing in this Act contained shall be held or construed to prejudice diminish alter or affect any of the rights privileges powers or authorities of rector of the patrons or of the rector for the time being of the parish or parish churches of Liverpool aforesaid.

Saving rights of patrons and parish of Liverpool.

Repeal of portions of existing Acts.

31. So much of the said Act of the second year of the reign of King George the Third (firstly described in the First Schedule to this Act) as relates to the church or churchyard of Saint John or to the minister and officers thereof and sections twenty-four and twenty-five of the said Act of the first and second years of the reign of Her present Majesty (thirdly described in the First Schedule to this Act) shall on and from the first day of January one thousand eight hundred and eighty-eight be repealed.

But the above repeal is without prejudice to and shall not affect anything duly done or suffered before the said first day of January and notwithstanding the above repeal or any other provision of this Act all arrears of rates pew rents and other payments leviable or payable under the said Acts may be levied and recovered as if this Act had not been passed and any action or cause of action pending or existing immediately before the said first day of January may be commenced or prosecuted and continued in all respects as if this Act had not been passed.

Cathedral Committee to satisfy Ecclesiastical Commissioners as to funds.

32. If the Cathedral Committee shall on or before the first day of January one thousand eight hundred and eighty-eight prove to the reasonable satisfaction of the Ecclesiastical Commissioners that their resources will be sufficient to enable them to put into execution the provisions of this Act the Ecclesiastical Commissioners on being reasonably satisfied thereof shall certify to the Committee accordingly and if the Committee fail to obtain such certificate then all the powers and provisions of this Act comprised under the heading "Erection of Cathedral on site of Saint John's Church and relative provisions" and the repeal of enactments proposed to be effected by this Act shall be void and shall not take effect.

of Marybone as far as Standish Street then turning southwardly and running along the centre of Standish Street as far as Great Crosshall Street then crossing Great Crosshall Street and running southwardly along the centre of North Street to Dale Street then turning eastwardly and running along the centre of Dale Street to Old Haymarket then crossing Old Haymarket and running eastwardly along the centre of Shaw's Brow to the said north end of Lime Street.
