



CHAPTER cxxiii.

An Act to confirm a Provisional Order made by the Education Department under the Elementary Education Act, 1870, to enable the School Board for Birmingham to put in force the Lands Clauses Consolidation Act, 1845, and the Acts amending the same. A.D. 1888.
[24th July 1888.]

WHEREAS the Lords of the Committee of the Privy Council on Education have made a Provisional Order under the authority of the Elementary Education Act, 1870, on behalf of the School Board for Birmingham, and it is requisite that the same should be confirmed by Parliament: 33 & 34 Vict.
c. 75.

Be it therefore enacted by the Queen's most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the authority of the same, as follows:

1. The following Order shall be and is hereby confirmed, and from and after the passing of this Act shall have full validity and force. Confirmation
of Order.

2. The School Board for Birmingham shall not under the powers of this Act, or of the said Order, without the consent of the Local Government Board, purchase or acquire ten or more houses which after the passing of this Act have been, or on the fifteenth day of December last were, occupied either wholly or partially by persons belonging to the labouring class as tenants or lodgers. For the purposes of this section, the expression "labouring class" includes mechanics, artizans, labourers, and others working for wages, hawkers, costermongers, persons not working for wages but working at some trade or handicraft without employing others except members of their own family, and persons, other than domestic servants, whose income does not exceed an average of thirty shillings a week, and the families of any of such persons who may be residing with them.

*Provisional Order for putting in force the Lands Clauses
Consolidation Act, 1845.*

At the Council Chamber, the 2nd day of May 1888.

WHEREAS the School Board for the borough of Birmingham, in the county of Warwick, require to purchase a piece of land for the purposes of the Elementary Education Act, 1870, and not having been able to purchase the same by agreement, require to put in force the provisions of the Lands Clauses Consolidation Act, 1845, and the Acts amending the same, which apply to the purchase and taking of lands otherwise than by agreement:

And whereas the land so required to be purchased is set forth in the schedule hereunder written:

And whereas the said Board have made due publication of the notices, and have duly served the same, according to the requirements of the Elementary Education Act, 1870, and have presented a petition to the Education Department praying that an Order may be made authorising the said School Board to put in force the powers of the said Acts with respect to the purchase and taking of lands otherwise than by agreement, in which petition were stated all the matters required by the said Elementary Education Act to be stated therein, and the same hath been supported by such evidence as the said Education Department required:

And whereas the said Department, having considered the said petition and the proofs of the publication and service of the proper notices, have thought fit to proceed with the case, and have caused inquiry to be made in the district of the said Board wherein the said land is situate as to the propriety of the proposed Order:

Now, therefore, the said Department, having received a report after such inquiry, and having duly considered the same, do hereby declare that it is proper, and do hereby order accordingly, that the said Board be authorised to put in force, with reference to the piece of land set forth in the schedule hereunder written, the powers of the said Acts for the purchase and taking of lands otherwise than by agreement or any of them.

All that piece of land, situate in the borough of Birmingham, at the back or north-west of certain land fronting to Soho Road, and already belonging or reputed to belong to the said Birmingham School Board, which said piece of land required by the said School Board is bounded on the north-west and north-east by land belonging or reputed to belong to Henry Pope and others in lease to Joseph Leonard, on the south by a public or private footpath or way leading from Bacchus Road into Soho Road aforesaid, and on the south-east by the before-mentioned land belonging or reputed to belong to the Birmingham School Board, and containing 1,011 square yards or thereabouts.
