

CHAPTER ccvii.

An Act to confirm certain Provisional Orders made by the A.D. 1900. Board of Trade under the Electric Lighting Acts 1882 and 1888 relating to Battersea Limehouse Mile End Old Town and St. George-in-the-East. [6th August 1900.]

WHEREAS under the authority of the Electric Lighting Acts 45 & 46 Vict. 1882 and 1888 the Board of Trade have made the several c. 56. 51 & 52 Vict. Provisional Orders set out in the schedule to this Act:

And whereas a Provisional Order made by the Board of Trade under the authority of the said Acts is not of any validity or force whatever until the confirmation thereof by Act of Parliament:

And whereas it is expedient that the several Provisional Orders made by the Board of Trade under the authority of the said Acts as set out in the schedule to this Act be confirmed by Act of Parliament:

Be it therefore enacted by the Queen's most Excellent Majesty by and with the advice and consent of the Lords Spiritual and Temporal and Commons in this present Parliament assembled and by the authority of the same as follows:—

- 1. This Act may be cited as the Electric Lighting Orders Short title. Confirmation (No. 10) Act 1900.
- 2. The several Orders as amended and set out in the schedule to Orders in this Act shall be and the same are hereby confirmed and all the schedule confirmed. provisions thereof in manner and form as they are set out in the said schedule shall from and after the passing of this Act have full validity and effect.

3. As from the date on which the borough councillors elected Working for the new metropolitan borough of Stepney come into office of the Whitechapel the undertakings and areas of supply under the Whitechapel Limehouse District Electric Lighting Order 1892 the Limehouse District Mile End

A.D. 1900. Old Town and St. Georgein-the-East undertakings as one undertaking on establishment of new borough of Stepney.

Electric Lighting Order 1900 the Mile End Old Town Electric Lighting Order 1900 and the St. George-in-the-East Electric Lighting Order 1900 (the three latter Orders being Orders confirmed by this Act) shall be deemed to be one undertaking and one area of supply and so far as the same provisions do not apply to these undertakings and areas of supply shall be deemed to be separate parts of one undertaking and of one area of supply Section nine (Purchase and use of lands) of the Whitechapel District Electric Lighting Order 1892 shall be read and have effect as if the Secretary of State were substituted in the said section for the Local Government Board.

For the protection of the County of London and Brush Provincial Electric Lighting Company Limited.

- 4.—(1.) If within six months from the date of the passing of this Act the County of London and Brush Provincial Electric Lighting Company Limited (in this section called "the Company") serve upon the Board of Works for the Limehouse District and the Vestries of Mile End Old Town and St. George's-in-the-East or their successors (herein-after called "the local authorities") notice in writing specifying the amount which they claim as representing (a) the cost of preparing obtaining and passing the County of London East Electric Lighting Order 1897 and (b) so much of any costs properly incurred by the Company with the object of affording a supply of electricity within the districts of the local authorities as shall have been incurred beyond what the Company would otherwise have incurred regard being had to whether any such costs incurred for works have been or may hereafter be utilised by the Company such local authorities shall within three months from the receipt of such notice unless they dispute the amount claimed therein pay the same in equal shares to the Company Provided that except as aforesaid such costs shall not include legal or Parliamentary expenses connected with the promotion of or opposition to the Bills in Parliament or Provisional Orders.
- (2.) If the local authorities or any of them dispute the amount so claimed the question of the amount of such costs shall be determined by an arbitrator to be appointed on the application of the Company or any of the local authorities by the Board of Trade and within three months from the date of the award of such arbitrator the amount thereby awarded shall be paid by the local authorities to the Company,
- (3.) Upon the payment by the local authorities of the amount so claimed or awarded as aforesaid the County of London East Electric Lighting Order 1897 shall be and is hereby revoked and the powers

rights privileges authorities and obligations thereby conferred or A.D. 1900. imposed upon the Company shall cease.

(4.) No part of any payment made under this section by the Corporation of the Borough of Stepney shall be charged upon that part of the said borough which is at the date of the passing of this Act the district of the Whitechapel Board of Works.

BATTERSEA ELECTRIC LIGHTING.

Battersea.

Provisional Order granted by the Board of Trade under the Electric Lighting Acts 1882 and 1888 to the County of London and Brush Provincial Electric Lighting Company Limited in respect of part of the Parish of St. Mary Battersea in the County of London.

Short title.

1. This Order may be cited as the Battersea Electric Lighting Order 1900.

Commencement of Order.

2. This Order shall come into force and have effect upon the day when the Act confirming this Order is passed and that date is in this Order referred to as the commencement of this Order.

Interpretation.

3. In this Order the expression "the local authority" means with respect to any part of the area of supply the local authority for that part as defined by the principal Act.

Address and description of Undertakers.

4.—(1) The Undertakers for the purposes of this Order are the County of London and Brush Provincial Electric Lighting Company Limited being a company registered under the Companies Acts 1862 to 1890 with limited liability having its registered office at Moorgate Court Moorgate Place in the city of London.

Provided that if the undertaking or any part thereof is at any time purchased by the local authority in accordance with the provisions of this Order or of the principal Act that local authority shall from the date of the purchase be the Undertakers in relation to the undertaking or part thereof for the purposes of this Order in lieu of the Company above mentioned.

- (2) The Undertakers shall not purchase or acquire the undertaking of or associate themselves with any other company or person supplying energy under any licence provisional Order or special Act unless the Undertakers are authorised by Parliament to do so.
- (3) If in contravention of this section the Undertakers purchase or acquire any such undertaking or associate themselves with such other company or person the Board of Trade may if they think fit revoke this Order upon such terms as they think just.

Area of supply.

5. Subject to the provisions of this Order the area of supply shall be the whole of the area which is included in the First Schedule annexed to this Order and is more particularly delineated upon the deposited map and thereon coloured red.

supply beyond area of supply.

Prohibition of 6. The Undertakers shall not at any time after the commencement of this Order supply energy or (except for the purposes of this Order) erect or lay down electric lines or works beyond the area of supply otherwise

than under the authority of Parliament or under a licence granted by the Board of Trade under the principal Act.

A.D. 1900.

Battersea.

If the Undertakers supply energy or erect or lay down electric lines or works in contravention of this section the Board of Trade may revoke this Order on such terms as they think just.

7.—(1) The sections numbered 2 and 7 to 81 both inclusive and 83 and 84 of the Wandsworth Electric Lighting Order 1892 (set out in the schedule to the Electric Lighting Orders Confirmation (No. 5) Act 1892) are incorporated with this Order subject to the following modifications (that is to say):—

Incorporation of sections of the Wands-worth Electric Lighting Order 1892.

- (a) The expressions "First Schedule" "Second Schedule" "Third Schedule" and "Fourth Schedule" as used in the said incorporated sections shall mean respectively the First Second Third and Fourth Schedules annexed to this Order.
- (b) Section 7 of the Wandsworth Electric Lighting Order of 1892 shall for the purpose of being applied to this Order be read as if the sum of one hundred pounds were substituted therein for the sum of one thousand pounds.
- (2) The Undertakers shall exercise the power vested in them by virtue of this Order in all respects in accordance with and subject to the provisions contained in the sections so incorporated.
