3 Control of spread of pests in Great Britain.

- (1) A competent authority may from time to time make such orders as the authority thinks expedient [F11] or called for by any [F8] obligation] for preventing the spread of pests in Great Britain [F12] or the conveyance of pests by articles exported from Great Britain].
- (2) The orders may direct or authorise—

- (3) The expenses of the Minister and Secretary of State in the execution of this Act, including any compensation under subsection (2) above, shall be paid out of moneys provided by Parliament, but shall not without the consent of the Treasury exceed two thousand pounds in any year.
