# APPEAL TO COURT OF APPEAL IN CRIMINAL CASES

Appeal against conviction on indictment

# 1 Right of appeal. E+W

- (1) [<sup>F1</sup>Subject to subsection (3) below] a person convicted of an offence on indictment may appeal to the Court of Appeal against his conviction.
- [<sup>F2</sup>(2) An appeal under this section lies only—

- (a) with the leave of the Court of Appeal; or
- (b) if[<sup>F3</sup>, within 28 days from the date of the conviction,] the judge of the court of trial grants a certificate that the case is fit for appeal.]
- [<sup>F4</sup>(3) Where a person is convicted before the Crown Court of a scheduled offence it shall not be open to him to appeal to the Court of Appeal against the conviction on the ground that the decision of the court which [<sup>F5</sup>committed him][<sup>F5</sup>sent him to the Crown Court] for trial as to the value involved was mistaken.
  - (4) In subsection (3) above "scheduled offence" and "the value involved" have the same meanings as they have in section 22 of the Magistrates' Courts Act 1980 (certain offences against property to be tried summarily if value of property or damage is small).]

# 2 Grounds for allowing appeal under s. 1. **E+W**

[<sup>F6</sup>(1) Subject to the provisions of this Act, the Court of Appeal—

- (a) shall allow an appeal against conviction if they think that the conviction is unsafe; and
- (b) shall dismiss such an appeal in any other case.]
- (2) In the case of an appeal against conviction the Court shall, if they allow the appeal, quash the conviction.
- (3) An order of the Court of Appeal quashing a conviction shall, except when under section 7 below the appellant is ordered to be retried, operate as a direction to the court of trial to enter, instead of the record of conviction, a judgment and verdict of acquittal.

## **3** Power to substitute conviction of alternative offence. **E+W**

- (1) This section applies on an appeal against conviction, where the appellant has been convicted of an offence [<sup>F7</sup>to which he did not plead guilty] and the jury could on the indictment have found him guilty of some other offence, and on the finding of the jury it appears to the Court of Appeal that the jury must have been satisfied of facts which proved him guilty of the other offence.
- (2) The Court may, instead of allowing or dismissing the appeal, substitute for the verdict found by the jury a verdict of guilty of the other offence, and pass such sentence in substitution for the sentence passed at the trial as may be authorised by law for the other offence, not being a sentence of greater severity.

# [<sup>F8</sup>3A Power to substitute conviction of alternative offence after guilty plea E+W

- (1) This section applies on an appeal against conviction where-
  - (a) an appellant has been convicted of an offence to which he pleaded guilty,
  - (b) if he had not so pleaded, he could on the indictment have pleaded, or been found, guilty of some other offence, and
  - (c) it appears to the Court of Appeal that the plea of guilty indicates an admission by the appellant of facts which prove him guilty of the other offence.
- (2) The Court of Appeal may, instead of allowing or dismissing the appeal, substitute for the appellant's plea of guilty a plea of guilty of the other offence and pass such sentence in substitution for the sentence passed at the trial as may be authorised by law for the other offence, not being a sentence of greater severity.]

# 4 [<sup>F9</sup>Power to re-sentence where appellant remains convicted of related offences.] **E+W**

 $[^{F10}(1)$  This section applies where—

- (a) two or more related sentences are passed,
- (b) the Court of Appeal allow an appeal against conviction in respect of one or more of the offences for which the sentences were passed ("the related offences"), but
- (c) the appellant remains convicted of one or more of those offences.]
- (2) Except as provided by subsection (3) below, the Court may [<sup>F11</sup>in respect of any related offence of which the appellant remains convicted] pass such sentence, in substitution for any sentence passed thereon at the trial, as they think proper and is authorised by law <sup>F12</sup>....

- (3) The Court shall not under this section pass any sentence such that the appellant's sentence [<sup>F13</sup>(taken as a whole) for all the related offences of which he remains convicted] will, in consequence of the appeal, be of greater severity than the sentence (taken as a whole) which was passed at the trial [<sup>F14</sup>for all the related offences].
- [<sup>F15</sup>(4) For the purposes of subsection (1)(a), two or more sentences are related if—
  - (a) they are passed on the same day,
  - (b) they are passed on different days but the court in passing any one of them states that it is treating that one together with the other or others as substantially one sentence, or
  - (c) they are passed on different days but in respect of counts on the same indictment.

(5) Where—

- (a) two or more sentences are related to each other by virtue of subsection (4)
   (a) or (b), and
- (b) any one or more of those sentences is related to one or more other sentences by virtue of subsection (4)(c),

all the sentences are to be treated as related for the purposes of subsection (1)(a).]

## 5 Disposal of appeal against conviction on special verdict. E+W

- (1) This section applies on an appeal against conviction [<sup>F16</sup>in a case where] the jury have found a special verdict.
- (2) If the Court of Appeal consider that a wrong conclusion has been arrived at by the court of trial on the effect of the jury's verdict they may, instead of allowing the appeal, order such conclusion to be recorded as appears to them to be in law required by the verdict, and pass such sentence in substitution for the sentence passed at the trial as may be authorised by law.

#### [<sup>F17</sup>6 Substitution of finding of insanity or findings of unfitness to plead etc. **E+W**

- (1) This section applies where, on an appeal against conviction, the Court of Appeal, on the written or oral evidence of two or more registered medical practitioners at least one of whom is duly approved, are of opinion-
  - (a) that the proper verdict would have been one of not guilty by reason of insanity; or
  - that the case is not one where there should have been a verdict of acquittal, (b) but there should have been findings that the accused was under a disability and that he did the act or made the omission charged against him.

[<sup>F18</sup>(2) The Court of Appeal shall make in respect of the accused—

- (a) a hospital order (with or without a restriction order);
- (b) a supervision order; or
- (c) an order for his absolute discharge.
- (3) Where—
  - (a) the offence to which the appeal relates is an offence the sentence for which is fixed by law, and
  - (b) the court have power to make a hospital order,

the court shall make a hospital order with a restriction order (whether or not they would have power to make a restriction order apart from this subsection).

- (4) Section 5A of the Criminal Procedure (Insanity) Act 1964 ("the 1964 Act") applies in relation to this section as it applies in relation to section 5 of that Act.

## Retrial

# 7 Power to order retrial. **E+W**

- (1) Where the Court of Appeal allow an appeal against conviction . . . <sup>F21</sup> and it appears to the Court that the interests of justice so require, they may order the appellant to be retried.
- (2) A person shall not under this section be ordered to be retried for any offence other than—
  - (a) the offence of which he was convicted at the original trial and in respect of which his appeal is allowed as mentioned in subsection (1) above;
  - (b) an offence of which he could have been convicted at the original trial on an indictment for the first-mentioned offence; or
  - (c) an offence charged in an alternative count of the indictment in respect of which [<sup>F22</sup>no verdict was given] in consequence of [<sup>F23</sup>his being convicted] of the first-mentioned offence.

## 8 Supplementary provisions as to retrial. **E+W**

- (1) A person who is to be retried for an offence in pursuance of an order under section 7 of this Act shall be tried on a fresh indictment preferred by direction of the Court of Appeal, . . . <sup>F24</sup>[<sup>F25</sup>but after the end of two months from the date of the order for his retrial he may not be arraigned on an indictment preferred in pursuance of such a direction unless the Court of Appeal give leave.]
- [<sup>F26</sup>(1A) Where a person has been ordered to be retried but may not be arraigned without leave, he may apply to the Court of Appeal to set aside the order for retrial and to direct the court of trial to enter a judgment and verdict of acquittal of the offence for which he was ordered to be retried.
  - (1B) On an application under subsection (1) or (1A) above the Court of Appeal shall have power—
    - (a) to grant leave to arraign; or



- (b) to [<sup>F27</sup>set aside the order for retrial and]direct the entry of a judgment and verdict of acquittal, but shall not give leave to arraign unless they are satisfied—
  - (i) that the prosecution has acted with all due expedition; and
  - (ii) that there is a good and sufficient cause for a retrial in spite of the lapse of time since the order under section 7 of this Act was made.]
- (2) The Court of Appeal may, on ordering a retrial, make such orders as appear to them to be necessary or expedient—
  - (a) for the custody or [<sup>F28</sup>, subject to section 25 of the Criminal Justice and Public Order Act 1994,][<sup>F29</sup>release on] bail of the person ordered to be retried pending his retrial; or
  - (b) for the retention pending the retrial of any property or money forfeited, restored or paid by virtue of the original conviction or any order made on that conviction.
- (3) If the person ordered to be retried was, immediately before the determination of his appeal, liable to be detained in pursuance of an order or direction under Part V of the <sup>MI</sup>Mental Health Act 1959 [<sup>F30</sup> or under Part III of the Mental Health Act 1983 (other than under section 35, 36 or 38 of that Act)],—
  - (a) that order or direction shall continue in force pending the retrial as if the appeal had not been allowed; and
  - (b) any order made by the Court of Appeal under this section for his custody or [<sup>F29</sup>release on] bail shall have effect subject to the said order or direction.
- [<sup>F31</sup>(3A) If the person ordered to be retried was, immediately before the determination of his appeal, liable to be detained in pursuance of a remand under [<sup>F32</sup>section 36 of the Mental Health Act 1983] or an interim hospital order under [<sup>F32</sup>section 38 of that Act], the Court of Appeal may, if they think fit, order that he shall continue to be detained in a hospital or mental nursing home, and in that event [<sup>F32</sup>Part III of that Act] shall apply as if he had been ordered under this section to be kept in custody pending his retrial and were detained in pursuance of a transfer direction together with a restriction direction.]
- [<sup>F33</sup>(3B) If the person ordered to be retried—
  - (a) was liable to be detained in pursuance of an order or direction under Part 3 of the Mental Health Act 1983;
  - (b) was then made subject to a community treatment order (within the meaning of that Act); and
  - (c) was subject to that community treatment order immediately before the determination of his appeal,

the order or direction under Part 3 of that Act and the community treatment order shall continue in force pending the retrial as if the appeal had not been allowed, and any order made by the Court of Appeal under this section for his release on bail shall have effect subject to the community treatment order.]

(4) Schedule 2 to this Act has effect with respect to the procedure in the case of a person ordered to be retried, the sentence which may be passed if the retrial results in his conviction and the order for costs which may be made if he is acquitted.

## 9 Appeal against sentence following conviction on indictment. E+W

- [<sup>F34</sup>(1)] A person who has been convicted of an offence on indictment may appeal to the Court of Appeal against any sentence (not being a sentence fixed by law) passed on him for the offence, whether passed on his conviction or in subsequent proceedings.
- [<sup>F35</sup>(1A) In subsection (1) of this section, the reference to a sentence fixed by law does not include a reference to an order made under subsection (2) or (4) of section 269 of the Criminal Justice Act 2003 in relation to a life sentence (as defined in section 277 of that Act) that is fixed by law.]

# 10 Appeal against sentence in other cases dealt with at assizes or quarter sessions. E+W

- (1) This section has effect for providing rights of appeal against sentence when a person is dealt with by [<sup>F38</sup>the Crown Court] (otherwise than on appeal from a magistrates' court) for an offence of which he was not convicted on indictment.
- (2) The proceedings from which an appeal against sentence lies under this section are those where an offender convicted of an offence by a magistrates' court—
  - (a) is committed by the court to be dealt with for his offence [<sup>F38</sup>before the Crown Court]; or
  - [<sup>F39</sup>(b) having been made the subject of an order for conditional discharge [<sup>F40</sup>a youth community order within the meaning of the Powers of Criminal Courts (Sentencing) Act 2000 or a community order within the meaning of Part 12 of the Criminal Justice Act 2003]<sup>F41</sup>... or given a suspended sentence, appears or is brought before the Crown Court to be further dealt with for his offence;]<sup>F42</sup>...
  - $F^{42}(c)$  ....
- [<sup>F43</sup>(3) An offender dealt with for an offence before the Crown Court in a proceeding to which subsection (2) of this section applies may appeal to the Court of Appeal against any sentence passed on him for the offence by the Crown Court.]
  - (4) For purposes of subsection (3)(a) of this section [<sup>F44</sup> and section 11 of this Act], any two or more sentences are to be treated as passed in the same proceeding if—
    - (a) they are passed on the same day; or
    - (b) they are passed on different days but the court in passing any one of them states that it is treating that one together with the other or others as substantially one sentence;

and consecutive terms of imprisonment [<sup>F45</sup>or detention] and terms which are wholly or partly concurrent are to be treated as a single term

## 11 Supplementary provisions as to appeal against sentence. E+W

## 13 Disposal of appeal under s. 12. E+W

    - (i) shall substitute for the verdict of not guilty by reason of insanity a verdict of guilty of that offence; and
    - (ii) shall, subject to subsection (5) below, have the like powers of punishing or otherwise dealing with the appellant, and other powers, as the court of trial would have had if the jury had come to the substituted verdict; and
  - (b) in any other case, the Court of Appeal shall substitute for the verdict of the jury a verdict of acquittal.
- (5) The Court of Appeal shall not by virtue of subsection (4)(a) above sentence any person to death; but where under that paragraph they substitute a verdict of guilty of an offence for which apart from this subsection they would be required to sentence the appellant to death, their sentence shall (whatever the circumstances) be one of imprisonment for life.
- (6) An order of the Court of Appeal allowing an appeal in accordance with this section shall operate as a direction to the court of trial to amend the record to conform with the order.

# 18 Initiating procedure. E+W

- (1) A person who wishes to appeal under this Part of this Act to the Court of Appeal, or to obtain the leave of that court to appeal, shall give notice of appeal or, as the case may be, notice of application for leave to appeal, in such manner as may be directed by rules of court.

## 21 Preparation of case for hearing. **E+W**

- (1) The registrar shall—

# 23 Evidence. E+W

- (1) For [<sup>F88</sup>the purposes of an appeal[<sup>F89</sup>, or an application for leave to appeal,] under] this Part of this Act the Court of Appeal may, if they think it necessary or expedient in the interests of justice—
  - (a) order the production of any document, exhibit or other thing connected with the proceedings, the production of which appears to them necessary for the determination of the case;

# [<sup>F110</sup>30 Restitution of property. E+W

- (1) The operation of an order for the restitution of property to a person made by the Crown Court shall, unless the Court direct to the contrary in any case in which, in their opinion, the title to the property is not in dispute, be suspended until (disregarding any power of a court to grant leave to appeal out of time) there is no further possibility of an appeal on which the order could be varied or set aside, and provision may be made by rules of court for the custody of any property in the meantime.

## **37** Detention of defendant on appeal by the Crown. **E+W**

- (1) The following provisions apply where, immediately after a decision of the Court of Appeal from which an appeal lies to the [<sup>F161</sup>Supreme Court], the prosecutor is granted or gives notice that he intends to apply for, leave to appeal.
- (2) If, but for the decision of the Court of Appeal, the defendant would be liable to be detained, the Court of Appeal [<sup>F162</sup>shall make—
  - (a) an order providing for his detention, or directing that he shall not be released except on bail (which may be granted by the Court as under section 36 above), so long as the appeal is pending, or
  - (b) an order that he be released without bail.]
- [<sup>F163</sup>(2A) The Court may make an order under subsection (2)(b) only if they think that it is in the interests of justice that the defendant should not be liable to be detained as a result of the decision of the Supreme Court on the appeal.]
  - (3) An order under [<sup>F164</sup>subsection (2)(a)] shall (unless the appeal has previously been disposed of) cease to have effect at the expiration of the period for which the defendant would have been liable to be detained but for the decision of the Court of Appeal.

- (1) The following provisions apply where, immediately after a decision of the Court of Appeal from which an appeal lies to the Supreme Court, the prosecutor is granted, or gives notice that he intends to apply for, leave to appeal.
- (2) If, but for the decision of the Court of Appeal, the defendant would be liable to recall, the Court of Appeal may make an order under this section.
- (3) For the purposes of this section, a person is liable to recall if he is subject to a community treatment order (within the meaning of the Mental Health Act 1983) and, when that order was made, he was liable to be detained in pursuance of an order or direction under Part 3 of that Act.

- (4) An order under this section is an order providing for the continuation of the community treatment order and the order or direction under Part 3 of that Act so long as an appeal to the Supreme Court is pending.
- (5) Where an order is made under this section the provisions of the Mental Health Act 1983 with respect to persons liable to recall (including provisions as to the extension of the community treatment period, the removal or discharge of community patients, the revocation of community treatment orders and the re-detention of patients following revocation) shall apply accordingly.
- (6) An order under this section shall (unless the appeal has previously been disposed of) cease to have effect at the expiration of the period for which the defendant would, but for the decision of the Court of Appeal, have been—
  - (a) liable to recall; or
  - (b) where the community treatment order is revoked, liable to be detained in pursuance of the order or direction under Part 3 of the Mental Health Act 1983.
- (7) Where the Court of Appeal have power to make an order under this section, and either no such order is made or the defendant is discharged, by virtue of subsection (5) or (6) of this section, before the appeal is disposed of, the defendant shall not be liable to be again detained as the result of the decision of the Supreme Court on the appeal.]



# 51 Interpretation. E+W

(1) In this Act, except where the context otherwise requires—



# TRANSITIONAL PROVISIONS
