

- (1) Subject to the provisions of this section, the [F104] designated medical officer] for any district shall, on producing, if so required, some duly authenticated document showing his authority, have a right to enter any premises in that district at all reasonable hours for the purpose of the performance of any duty imposed on him by—

- (7) A person who fails to give to any person acting in the execution of this section or of any warrant issued thereunder any assistance which that person may reasonably request him to give, or any information which that person is expressly authorised by any enactment to call for or may reasonably require, or who, when required to give any such information, knowingly makes any mis-statement in respect thereof, shall be guilty of an offence against this section:
  - Provided that nothing in this subsection shall be construed as requiring a person to answer any question, or give any information, if to do so might incriminate him.
- (8) A person guilty of an offence against this section shall be liable on summary conviction to a fine not exceeding [F105] level 3 on the standard scale] or to imprisonment for a term not exceeding six months, or to both such fine and imprisonment.
- (9) In this section . . . F106 references to the sheriff shall be construed in relation to any place, as including references to any justice of the peace appointed for an area which includes that place, and to any burgh magistrate so appointed.
- (10) This section applies to Scotland only.
