63 Provision of instruction for officers of hospital authorities and other persons employed, or contemplating employment, in certain activities connected with health or welfare.

- (1) [^{F7}The Secretary of State] may, either directly or by entering into arrangements with others,—
- (a) provide, for persons employed or having it in contemplation to be employed as officers, or servants of a [^{F8}Strategic Health Authority][^{F9}Health Authority [^{F10}or Special Health Authority, Health Board [^{F11}, Primary Care Trust or Local Health Board]]] such instruction as appears to him conducive to securing their efficiency as such officers or servants;
