*Rights relating to property*

- 6 (1) Section 39—
  - (a) does not apply to an existing instrument or enactment in so far as it contains a disposition of property, and
  - (b) does not apply to any public general Act in its application to any disposition of property in an existing instrument or enactment.
- (2) Sections 16 and 17 of the Adoption Act 1958, and provisions containing references to those sections shall continue to apply in relation to dispositions of property effected by existing instruments notwithstanding the repeal of those sections, and such provisions, by the <sup>M1</sup>Children Act 1975.
