# PART I

# DISCRIMINATION TO WHICH ACT APPLIES

# 1 Racial discrimination.

- (1) A person discriminates against another in any circumstances relevant for the purposes of any provision of this Act if—
  - (a) on racial grounds he treats that other less favourably than he treats or would treat other persons; or
  - (b) he applies to that other a requirement or condition which he applies or would apply equally to persons not of the same racial group as that other but—
    - (i) which is such that the proportion of persons of the same racial group as that other who can comply with it is considerably smaller than the proportion of persons not of that racial group who can comply with it; and
    - (ii) which he cannot show to be justifiable irrespective of the colour, race, nationality or ethnic or national origins of the person to whom it is applied; and
    - (iii) which is to the detriment of that other because he cannot comply with it.
- [<sup>F1</sup>(1A) A person also discriminates against another if, in any circumstances relevant for the purposes of any provision referred to in subsection (1B), he applies to that other a provision, criterion or practice which he applies or would apply equally to persons not of the same race or ethnic or national origins as that other, but—
  - (a) which puts or would put persons of the same race or ethnic or national origins as that other at a particular disadvantage when compared with other persons,
  - (b) which puts  $[^{F2}$  or would put] that other at that disadvantage, and
  - (c) which he cannot show to be a proportionate means of achieving a legitimate aim.
  - (1B) The provisions mentioned in subsection (1A) are—
    - (a) Part II;
    - (b) sections 17 to 18D;
    - (c) section 19B, so far as relating to -
      - (i) any form of social security;
      - (ii) health care;
      - (iii) any other form of social protection; and
      - (iv) any form of social advantage;

which does not fall within section 20;

- (d) sections 20 to 24;
- (e) sections 26A and 26B;
- (f) sections 76 and 76ZA; and
- (g) Part IV, in its application to the provisions referred to in paragraphs (a) to (f).
- (1C) Where, by virtue of subsection (1A), a person discriminates against another, subsection (1)(b) does not apply to him.]
  - (2) It is hereby declared that, for the purposes of this Act, segregating a person from other persons on racial grounds is treating him less favourably than they are treated.

# 2 Discrimination by way of victimisation.

- (1) A person ("the discriminator") discriminates against another person ("the person victimised") in any circumstances relevant for the purposes of any provision of this Act if he treats the person victimised less favourably than in those circumstances he treats or would treat other persons, and does so by reason that the person victimised has—
  - (a) brought proceedings against the discriminator or any other person under this Act; or
  - (b) given evidence or information in connection with proceedings brought by any person against the discriminator or any other person under this Act; or
  - (c) otherwise done anything under or by reference to this Act in relation to the discriminator or any other person; or
  - (d) alleged that the discriminator or any other person has committed an act which (whether or not the allegation so states) would amount to a contravention of this Act,

or by reason that the discriminator knows that the person victimised intends to do any of those things, or suspects that the person victimised has done, or intends to do, any of them.

(2) Subsection (1) does not apply to treatment of a person by reason of any allegation made by him if the allegation was false and not made in good faith.

# 3 Meaning of "racial grounds", "racial group" etc.

(1) In this Act, unless the context otherwise requires—

"racial grounds" means any of the following grounds, namely colour, race, nationality or ethnic or national origins;

"racial group" means a group of persons defined by reference to colour, race, nationality or ethnic or national origins, and references to a person's racial group refer to any racial group into which he falls.

- (2) The fact that a racial group comprises two or more distinct racial groups does not prevent it from constituting a particular racial group for the purposes of this Act.
- (3) In this Act—
  - (a) references to discrimination refer to any discrimination falling within section 1 or 2; and
  - (b) references to racial discrimination refer to any discrimination falling within section 1,

and related expressions shall be construed accordingly.

(4) A comparison of the case of a person of a particular racial group with that of a person not of that group under section 1(1) [<sup>F3</sup>or (1A)] must be such that the relevant circumstances in the one case are the same, or not materially different, in the other.

# 3A Harassment

- (1) A person subjects another to harassment in any circumstances relevant for the purposes of any provision referred to in section 1(1B) where, on grounds of race or ethnic or national origins, he engages in unwanted conduct which has the purpose or effect of—
  - (a) violating that other person's dignity, or
  - (b) creating an intimidating, hostile, degrading, humiliating or offensive environment for him.
- (2) Conduct shall be regarded as having the effect specified in paragraph (a) or (b) of subsection (1) only if, having regard to all the circumstances, including in particular the perception of that other person, it should reasonably be considered as having that effect.

# Discrimination by employers

# <sup>F4</sup>... applicants and employees.

- (1) It is unlawful for a person, in relation to employment by him at an establishment in Great Britain, to discriminate against another—
  - (a) in the arrangements he makes for the purpose of determining who should be offered that employment; or
  - (b) in the terms on which he offers him that employment; or
  - (c) by refusing or deliberately omitting to offer him that employment.
- (2) It is unlawful for a person, in the case of a person employed by him at an establishment in Great Britain, to discriminate against that employee—
  - (a) in the terms of employment which he affords him; or

- (b) in the way he affords him access to opportunities for promotion, transfer or training, or to any other benefits, facilities or services, or by refusing or deliberately omitting to afford him access to them; or
- (c) by dismissing him, or subjecting him to any other detriment.
- [<sup>F5</sup>(2A) It is unlawful for an employer, in relation to employment by him at an establishment in Great Britain, to subject to harassment a person whom he employs or who has applied to him for employment.]
  - (3) Except in relation to discrimination falling within section 2 [<sup>F6</sup>or discrimination on grounds of race or ethnic or national origins], subsections (1) and (2) do not apply to employment for the purposes of a private household.
  - (4) Subsection (2) does not apply to benefits, facilities or services of any description if the employer is concerned with the provision (for payment or not) of benefits, facilities or services of that description to the public, or to a section of the public comprising the employee in question, unless—
    - (a) that provision differs in a material respect from the provision of the benefits, facilities or services by the employer to his employees; or
    - (b) the provision of the benefits, facilities or services to the employee in question is regulated by his contract of employment; or
    - (c) the benefits, facilities or services relate to training.

# 4A Exception for genuine occupational requirement

(1) In relation to discrimination on grounds of race or ethnic or national origins—

- (a) section 4(1)(a) or (c) does not apply to any employment; and
- (b) section 4(2)(b) does not apply to promotion or transfer to, or training for, any employment; and
- (c) section 4(2)(c) does not apply to dismissal from any employment;

where subsection (2) applies.

- (2) This subsection applies where, having regard to the nature of the employment or the context in which it is carried out—
  - (a) being of a particular race or of particular ethnic or national origins is a genuine and determining occupational requirement;
  - (b) it is proportionate to apply that requirement in the particular case; and
  - (c) either—
    - (i) the person to whom that requirement is applied does not meet it, or
    - (ii) the employer is not satisfied, and in all the circumstances it is reasonable for him not to be satisfied, that that person meets it.

# 5 Exceptions for genuine occupational qualifications.

(1) In relation to racial discrimination [<sup>F8</sup>in cases where section 4A does not apply]—

- (a) section 4(1)(a) or (c) does not apply to any employment where being of a particular racial group is a genuine occupational qualification for the job; and
- (b) section 4(2)(b) does not apply to opportunities for promotion or transfer to, or training for, such employment.
- (2) Being of a particular racial group is a genuine occupational qualification for a job only where—
  - (a) the job involves participation in a dramatic performance or other entertainment in a capacity for which a person of that racial group is required for reasons of authenticity; or
  - (b) the job involves participation as an artist's or photographic model in the production of a work of art, visual image or sequence of visual images for which a person of that racial group is required for reasons of authenticity; or
  - (c) the job involves working in a place where food or drink is (for payment or not) provided to and consumed by members of the public or a section of the public in a particular setting for which, in that job, a person of that racial group is required for reasons of authenticity; or
  - (d) the holder of the job provides persons of that racial group with personal services promoting their welfare, and those services can most effectively be provided by a person of that racial group.
- (3) Subsection (2) applies where some only of the duties of the job fall within paragraph (a), (b), (c) or (d) as well as where all of them do.

- (4) Paragraph (a), (b), (c) or (d) of subsection (2) does not apply in relation to the filling of a vacancy at a time when the employer already has employees of the racial group in question—
  - (a) who are capable of carrying out the duties falling within that paragraph; and
  - (b) whom it would be reasonable to employ on those duties; and
  - (c) whose numbers are sufficient to meet the employer's likely requirements in respect of those duties without undue inconvenience.

# 6 Exception for employment intended to provide training in skills to be exercised outside Great Britain.

—Nothing in section 4 shall render unlawful any act done by an employer  $[F^9$ , on grounds other than those of race or ethnic or national origins,] for the benefit of a person not ordinarily resident in Great Britain in or in connection with employing him at an establishment in Great Britain, where the purpose of that employment is to provide him with training in skills which he appears to the employer to intend to exercise wholly outside Great Britain.

# 7 <sup>F10</sup>... contract workers.

- (1) This section applies to any work for a person ("the principal") which is available for doing by individuals ("contract workers") who are employed not by the principal himself but by another person, who supplies them under a contract made with the principal.
- (2) It is unlawful for the principal, in relation to work to which this section applies, to discriminate against a contract worker—
  - (a) in the terms on which he allows him to do that work; or
  - (b) by not allowing him to do it or continue to do it; or

- (c) in the way he affords him access to any benefits, facilities or services or by refusing or deliberately omitting to afford him access to them; or
- (d) by subjecting him to any other detriment.
- (3) The principal does not contravene subsection (2)(b) by doing any act in relation to a person not of a particular racial group [<sup>F11</sup>, or not of a particular race or particular ethnic or national origins,] at a time when, if the work were to be done by a person taken into the principal's employment, being of that racial group [<sup>F12</sup>or of that race or those origins] would be a genuine occupational qualification [<sup>F13</sup>or, as the case may be, that act would be lawful by virtue of section 4A] for the job.
- [<sup>F14</sup>(3A) It is unlawful for the principal, in relation to work to which this section applies, to subject a contract worker to harassment.]
  - (4) Nothing in this section shall render unlawful any act done by the principal [<sup>F15</sup> on grounds other than those of race or ethnic or national origins,] for the benefit of a contract worker not ordinarily resident in Great Britain in or in connection with allowing him to do work to which this section applies, where the purpose of his being allowed to do that work is to provide him with training in skills which he appears to the principal to intend to exercise wholly outside Great Britain.
  - (5) Subsection (2)(c) does not apply to benefits, facilities or services of any description if the principal is concerned with the provision (for payment or not) of benefits, facilities or services of that description to the public, or to a section of the public to which the contract worker in question belongs, unless that provision differs in a material respect from the provision of the benefits, facilities or services by the principal to his contract workers.

# 8 Meaning of employment at establishment in Great Britain.

- (1) For the purposes of this Part ("the relevant purposes"), employment is to be regarded as being at an establishment in Great Britain [<sup>F16</sup> if the employee—
  - (a) does his work wholly or partly in Great Britain; or
  - (b) does his work wholly outside Great Britain and subsection (1A) applies]
- [<sup>F17</sup>(1A) This subsection applies if, in a case involving discrimination on grounds of race or ethnic or national origins, or harassment—
  - (a) the employer has a place of business at an establishment in Great Britain;
  - (b) the work is for the purposes of the business carried on at that establishment; and
  - (c) the employee is ordinarily resident in Great Britain—
    - (i) at the time when he applies for or is offered the employment, or
    - (ii) at any time during the course of the employment.]
  - - (3) In the case of employment on board a ship registered at a port of registry in Great Britain (except where the employee does his work wholly outside Great Britain) the ship shall for the relevant purposes be deemed to be the establishment.
    - (4) Where work is not done at an establishment it shall be treated for the relevant purposes as done at the establishment from which it is done or (where it is not done from any establishment) at the establishment with which it has the closest connection.
    - (5) In relation to employment concerned with exploration of the sea bed or subsoil or the exploitation of their natural resources, Her Majesty may by Order in Council provide that subsections (1) to (3) shall have effect as if in both subsection (1) and subsection (3) the last reference to Great Britain included any area for the time being designated under section 1(7) of the <sup>MI</sup>Continental Shelf Act 1964, except an area or part of an area in which the law of Northern Ireland applies.
    - (6) An Order in Council under subsection (5) may provide that, in relation to employment to which the Order applies, this Part is to have effect with such modifications as are specified in the Order.
    - (7) An Order in Council under subsection (5) shall be of no effect unless a draft of the Order has been laid before and approved by resolution of each House of Parliament.

# 9 Exception for seamen recruited abroad.

- (1) Nothing in section 4 shall render unlawful any act done by an employer in or in connection with employment by him on any ship in the case of a person who applied or was engaged for that employment outside Great Britain [<sup>F19</sup>to the extent that the act—
  - (a) relates to the pay the person receives in respect of his employment, and
  - (b) amounts to discrimination against the person on the basis of his nationality.]
- (2) Nothing in section 7 shall, as regards work to which that section applies, render unlawful any act done by the principal in or in connection with such work on any ship in the case of a contract worker who was engaged outside Great Britain by the person by whom he is supplied [<sup>F20</sup> to the extent that the act—
  - (a) relates to the pay the person receives in respect of the work, and
  - (b) amounts to discrimination against the person on the basis of his nationality.]
- (3) Subsections (1) and (2) do not apply to employment or work concerned with exploration of the sea bed or subsoil or the exploitation of their natural resources in any area for the time being designated under section 1(7) of the <sup>M2</sup>Continental Shelf Act 1964, not being an area or part of an area in which the law of Northern Ireland applies.
- (4) For the purposes of subsection (1) a person brought to Great Britain with a view to his entering into an agreement in Great Britain to be employed on any ship shall be treated as having applied for the employment outside Great Britain.
- [<sup>F21</sup>(5) In this section—

"pay" includes retirement or death benefit;

"retirement or death benefit" means a pension, annuity, lump sum, gratuity or other similar benefit which will be paid or given to the employee or contract worker or a member of his family or household in the event of his retirement or death.]

# Discrimination by other bodies

# 10 Partnerships.

- (1) It is unlawful for a firm consisting of six or more partners, in relation to a position as partner in the firm, to discriminate against a person—
  - (a) in the arrangements they make for the purpose of determining who should be offered that position; or
  - (b) in the terms on which they offer him that position; or
  - (c) by refusing or deliberately omitting to offer him that position; or
  - (d) in a case where the person already holds that position—
    - (i) in the way they afford him access to any benefits, facilities or services, or by refusing or deliberately omitting to afford him access to them; or
    - (ii) by expelling him from that position, or subjecting him to any other detriment.
- [<sup>F22</sup>(1A) The limitation of subsection (1) to six or more partners does not apply in relation to discrimination on grounds of race or ethnic or national origins.
  - (1B) It is unlawful for a firm, in relation to a position as a partner in the firm, to subject to harassment a person who holds or has applied for that position.]
    - (2) [<sup>F23</sup>Subsections (1), (1A) and (1B)] shall apply in relation to persons proposing to form themselves into a partnership as it applies in relation to a firm.
    - (3) Subsection (1)(a) and (c) do not apply to a position as partner where, if it were employment, [<sup>F24</sup>section 4A or 5 would apply to such employment].
    - (4) In the case of a limited partnership references in this section to a partner shall be construed as references to a general partner as defined in section 3 of the <sup>M3</sup>Limited Partnerships Act 1907.
  - [<sup>F25</sup>(5) This section applies to a limited liability partnership as it applies to a firm; and, in its application to a limited liability partnership, references to a partner in a firm are references to a member of the limited liability partnership.]

# 11 Trade unions etc.

- (1) This section applies to an organisation of workers, an organisation of employers, or any other organisation whose members carry on a particular profession or trade for the purposes of which the organisation exists.
- (2) It is unlawful for an organisation to which this section applies, in the case of a person who is not a member of the organisation, to discriminate against him—
  - (a) in the terms on which it is prepared to admit him to membership; or
  - (b) by refusing or deliberately omitting to accept, his application for membership.

  - (c) by subjecting him to any other detriment.

- (1) It is unlawful for an authority or body which can confer an authorisation or qualification which is needed for, or facilitates, engagement in a particular profession or trade to discriminate against a person—
  - (a) in the terms on which it is prepared to confer on him that authorisation or qualification; or
  - (b) by refusing, or deliberately omitting to grant, his application for it; or
  - (c) by withdrawing it from him or varying the terms on which he holds it.

# 14 Employment agencies.

(1) It is unlawful for an employment agency to discriminate against a person—

(a) in the terms on which the agency offers to provide any of its services; or

- (b) by refusing or deliberately omitting to provide any of its services; or
- (c) in the way it provides any of its services.
- [<sup>F32</sup>(1A) It is unlawful for an employment agency, in relation to the provision of its services, to subject to harassment a person to whom it provides such services or who requests the provision of such services.]

      - (b) that it was reasonable for it to rely on the statement.
    - (6) A person who knowingly or recklessly makes a statement such as is referred to in subsection (5)(a) which in a material respect is false or misleading commits an offence, and shall be liable on summary conviction to a fine not exceeding [<sup>F38</sup>level 5 on the standard scale].

# **19A** Discrimination by planning authorities.

- (1) It is unlawful for a planning authority to discriminate against a person in carrying out their planning functions.
- (2) In this section "planning authority" means—
  - (a) in England and Wales, a county [<sup>F88</sup>county borough,], district or London borough council [<sup>F89</sup>the Broads Authority [<sup>F90</sup>a National Park authority or]], a joint planning board <sup>F91</sup>... and

- (1) It is unlawful for any person concerned with the provision (for payment or not) of goods, facilities or services to the public or a section of the public to discriminate against a person who seeks to obtain or use those goods, facilities or services—
  - (a) by refusing or deliberately omitting to provide him with any of them; or
  - (b) by refusing or deliberately omitting to provide him with goods, facilities or services of the like quality, in the like manner and on the like terms as are normal in the first-mentioned person's case in relation to other members of the public or (where the person so seeking belongs to a section of the public) to other members of that section.
- (2) The following are examples of the facilities and services mentioned in subsection (1)
  - (a) access to and use of any place which members of the public are permitted to enter;
  - (b) accommodation in a hotel, boarding house or other similar establishment;
  - (c) facilities by way of banking or insurance or for grants, loans, credit or finance;

- (d) facilities for education;
- (e) facilities for entertainment, recreation or refreshment;

# 22 Exception from ss. 20(1) and 21: small dwellings.

- (1) Sections 20(1) and 21 do not apply to [<sup>F117</sup>discrimination on grounds other than those of race or ethnic or national origins in either] the provision by a person of accommodation in any premises, or the disposal of premises by him, if—

- (a) in the case of premises comprising residential accommodation for one or more households (under separate letting or similar agreements) in addition to the accommodation occupied by the relevant occupier, there is not normally residential accommodation for more than two such households and only the relevant occupier and any member of his household reside in the accommodation occupied by him;
- (b) in the case of premises not falling within paragraph (a), there is not normally residential accommodation on the premises for more than six persons in addition to the relevant occupier and any members of his household.

# 24 <sup>F122</sup>... consent for assignment or sub-letting.

- (1) Where the licence or consent of the landlord or of any other person is required for the disposal to any person of premises in Great Britain comprised in a tenancy, it is unlawful for the landlord or other person
  - [<sup>F123</sup>(a) to discriminate against a person by withholding the licence or consent for disposal of the premises to him, or

# 25 Discrimination: associations not within s. 11.


- This section applies to any association of persons (however described, whether corporate or unincorporate, and whether or not its activities are carried on for profit) if—
  - (a) it has twenty-five or more members; and
  - (b) admission to membership is regulated by its constitution and is so conducted that the members do not constitute a section of the public within the meaning of section 20(1); and
  - (c) it is not an organisation to which section 11 applies.
- (2) It is unlawful for an association to which this section applies, in the case of a person who is not a member of the association, to discriminate against him—
  - (a) in the terms on which it is prepared to admit him to membership; or
  - (b) by refusing or deliberately omitting to accept his application for membership.
- (3) It is unlawful for an association to which this section applies, in the case of a person who is a member or associate of the association, to discriminate against him—
  - (a) in the way it affords him access to any benefits, facilities or services, or by refusing or deliberately omitting to afford him access to them; or
  - (b) in the case of a member, by depriving him of membership, or varying the terms on which he is a member; or
  - (c) in the case of an associate, by depriving him of his rights as an associate, or varying those rights; or
  - (d) in either case, by subjecting him to any other detriment.

(4) For the purposes of this section—

- (a) a person is a member of an association if he belongs to it by virtue of his admission to any sort of membership provided for by its constitution (and is not merely a person with certain rights under its constitution by virtue of his membership of some other association), and references to membership of an association shall be construed accordingly;
- (b) a person is an associate of an association to which this section applies if, not being a member of it, he has under its constitution some or all of the rights enjoyed by members (or would have apart from any provision in its constitution authorising the refusal of those rights in particular cases).

# 26 Exception from s. 25 for certain associations.

- (1) An association to which section 25 applies is within this subsection if the main object of the association is to enable the benefits of membership (whatever they may be) to be enjoyed by persons of a particular racial group defined otherwise than by reference to colour; and in determining whether that is the main object of an association regard shall be had to the essential character of the association and to all relevant circumstances including, in particular, the extent to which the affairs of the association are so conducted that the persons primarily enjoying the benefits of membership are of the racial group in question.
- (2) In the case of an association within subsection (1), nothing in section 25 shall render unlawful any act not involving discrimination on the ground of colour.

- (1) It is unlawful for a barrister or barrister's clerk, in relation to any offer of a pupillage or tenancy, to discriminate against a person—
  - (a) in the arrangements which are made for the purpose of determining to whom it should be offered;
  - (b) in respect of any terms on which it is offered; or
  - (c) by refusing, or deliberately omitting, to offer it to him.
- (2) It is unlawful for a barrister or barrister's clerk, in relation to a pupil or tenant in the chambers in question, to discriminate against him—
  - (a) in respect of any terms applicable to him as a pupil or tenant;
  - (b) in the opportunities for training, or gaining experience which are afforded or denied to him;
  - (c) in the benefits, facilities or services which are afforded or denied to him; or
  - (d) by terminating his pupillage or by subjecting him to any pressure to leave the chambers or other detriment.
- (3) It is unlawful for any person, in relation to the giving, withholding or acceptance of instructions to a barrister, to discriminate against any person [<sup>F127</sup> or to subject any person to harassment].
- [<sup>F128</sup>(3A) It is unlawful for a barrister or barrister's clerk, in relation to a pupillage or tenancy in the set of chambers in question, to subject to harassment a person who is, or has applied to be, a pupil or tenant.]
  - (4) In this section— "barrister's clerk" includes any person carrying out any of the functions of a barrister's clerk; and "pupil", "pupillage", "tenancy" and "tenant" have the meanings commonly associated with their use in the context of a set of barristers' chambers.
  - (5) This section does not apply to Scotland.

# 26B <sup>F129</sup>... advocates.

- (1) It is unlawful for an advocate, in relation to taking any person as his pupil, to discriminate against a person—
  - (a) in the arrangements which he makes for the purpose of determining whom he will take as his pupil;
  - (b) in respect of any terms on which he offers to take any person as his pupil; or
  - (c) by refusing, or deliberately omitting, to take a person as his pupil.
- (2) It is unlawful for an advocate, in relation to a person who is a pupil, to discriminate against him—
  - (a) in respect of any terms applicable to him as a pupil;
  - (b) in the opportunities for training, or gaining experience, which are afforded or denied to him;
  - (c) in the benefits, facilities or services which are afforded or denied to him; or
  - (d) by terminating the relationship or by subjecting him to any pressure to terminate the relationship or other detriment.
- (3) It is unlawful for any person, in relation to the giving, withholding or acceptance of instructions to an advocate, to discriminate against any person [<sup>F130</sup>or to subject any person to harassment].
- [<sup>F131</sup>(3A) It is unlawful for an advocate, in relation to taking any person as his pupil, to subject to harassment a person who has applied to be, or is, a pupil.]
  - (4) In this section— "advocate" means a member of the Faculty of Advocates practising as such; and "pupil" has the meaning commonly associated with its use in the context of a person training to be an advocate.
  - (5) This section does not apply to England and Wales.

# 27 Extent of Part III.

- Sections 17 to [<sup>F132</sup>18D] do not apply to benefits, facilities or services outside Great Britain except—
  - (a) travel in a ship registered at a port of registry in Great Britain; and
  - (b) benefits, facilities or services provided on a ship so registered.

(5) This section shall not render unlawful an act done in or over a country outside the United Kingdom, or in or over that country's territorial waters, for the purpose of complying with the laws of that country.

# 27A Relationships which have come to an end

(1) In this section a "relevant relationship" is a relationship during the course of which, by virtue of any provision referred to in section 1(1B), taken with section 1(1) or (1A), or (as the case may be) by virtue of section 3A—

- (a) an act of discrimination by one party to the relationship ("the relevant party") against another party to the relationship, on grounds of race or ethnic or national origins, or
- (b) harassment of another party to the relationship by the relevant party,

is unlawful.

- (2) Where a relevant relationship has come to an end it is unlawful for the relevant party—
  - (a) to discriminate against another party, on grounds of race or ethnic or national origins, by subjecting him to a detriment, or
  - (b) to subject another party to harassment,

where the discrimination or harassment arises out of and is closely connected to that relationship.

- (3) In subsection (1) reference to an act of discrimination or harassment which is unlawful includes, in the case of a relationship which has come to an end before 19th July 2003, reference to such an act which would, after that date, be unlawful.
- (4) For the purposes of any proceedings in respect of an unlawful act under subsection (2), that act shall be treated as falling within circumstances relevant for the purposes of such of the provisions, or Parts, referred to in subsection (1) as determine most closely the nature of the relevant relationship.

# 28 Discriminatory practices.

(1) In this section "discriminatory practice" means —

- [<sup>F134</sup>(a)] the application of a requirement or condition which results in an act of discrimination which is unlawful by virtue of any provision of Part II or III taken with section 1(1)(b), or which would be likely to result in such an act of discrimination if the persons to whom it is applied included persons of any particular racial group as regards which there has been no occasion for applying it
  - [F135 or
    - (b) the application of a provision, criterion or practice which results in an act of discrimination which is unlawful by virtue of any provision referred to in section 1(1B), taken with section 1(1A), or which would be likely to result in such an act of discrimination, if the persons to whom it is applied included persons of any particular race or of any particular ethnic or national origins, as regards which there has been no occasion for applying it].
- (2) A person acts in contravention of this section if and so long as—
  - (a) he applies a discriminatory practice; or
  - (b) he operates practices or other arrangements which in any circumstances would call for the application by him of a discriminatory practice.
- (3) Proceedings in respect of a contravention of this section shall be brought only by the Commission in accordance with [<sup>F136</sup>sections 20 to 24 of the Equality Act 2006].

# 29 Discriminatory advertisements.

- (1) It is unlawful to publish or to cause to be published an advertisement which indicates, or might reasonably be understood as indicating, an intention by a person to do an act of discrimination, whether the doing of that act by him would be lawful or, by virtue of Part II or III, unlawful.
- (2) Subsection (1) does not apply to an advertisement—
  - (a) if the intended act would be lawful by virtue of any of sections 5, 6, 7(3) and (4), 10(3), 26, 34(2)(b), 35 to 39 and 41; or
  - (b) if the advertisement relates to the services of an employment agency (within the meaning of section 14(1)) and the intended act only concerns employment which the employer could by virtue of section 5, 6 or 7(3) or (4) lawfully refuse to offer to persons against whom the advertisement indicates an intention to discriminate.
- (3) Subsection (1) does not apply to an advertisement which indicates that persons of any class defined otherwise than by reference to colour, race or ethnic or national origins are required for employment outside Great Britain.
- (4) The publisher of an advertisement made unlawful by subsection (1) shall not be subject to any liability under that subsection in respect of the publication of the advertisement if he proves—
  - (a) that the advertisement was published in reliance on a statement made to him by the person who caused it to be published to the effect that, by reason of the operation of subsection (2) or (3), the publication would not be unlawful; and
  - (b) that it was reasonable for him to rely on the statement.
- (5) A person who knowingly or recklessly makes a statement such as is mentioned in subsection (4)(a) which in a material respect is false or misleading commits an offence, and shall be liable on summary conviction to a fine not exceeding [<sup>F137</sup>level 5 on the standard scale].

  - (a) by the Commission, and
  - (b) in accordance with section 25 of the Equality Act 2006.]

# **30** Instructions to [<sup>F139</sup>commit unlawful acts].

[<sup>F140</sup>(1)] It is unlawful for a person—

- (a) who has authority over another person; or
- (b) in accordance with whose wishes that other person is accustomed to act,

to instruct him to do any act which is unlawful by virtue of Part II or III, [<sup>F141</sup>section 76ZA or, where it renders an act unlawful on grounds of race or ethnic or national origins, section 76,] or procure or attempt to procure the doing by him of any such act.

[<sup>F142</sup>(2) Proceedings in respect of a contravention of subsection (1) may be brought only—

- (a) by the Commission, and
- (b) in accordance with section 25 of the Equality Act 2006.]

# 31 Pressure to [<sup>F143</sup>commit unlawful acts].

- It is unlawful to induce, or attempt to induce, a person to do any act which contravenes Part II or III [<sup>F144</sup>section 76ZA or, where it renders an act unlawful on grounds of race or ethnic or national origins, section 76].
- (2) An attempted inducement is not prevented from falling within subsection (1) because it is not made directly to the person in question, if it is made in such a way that he is likely to hear of it.

# 32 Liability of employers and principals.

(1) Anything done by a person in the course of his employment shall be treated for the purposes of this Act (except as regards offences thereunder) as done by his employer as well as by him, whether or not it was done with the employer's knowledge or approval.

- (2) Anything done by a person as agent for another person with the authority (whether express or implied, and whether precedent or subsequent) of that other person shall be treated for the purposes of this Act (except as regards offences thereunder) as done by that other person as well as by him.
- (3) In proceedings brought under this Act against any person in respect of an act alleged to have been done by an employee of his it shall be a defence for that person to prove that he took such steps as were reasonably practicable to prevent the employee from doing that act, or from doing in the course of his employment acts of that description.

# **33** Aiding unlawful acts.

- (1) A person who knowingly aids another person to do an act made unlawful by this Act shall be treated for the purposes of this Act as himself doing an unlawful act of the like description.
- (2) For the purposes of subsection (1) an employee or agent for whose act the employer or principal is liable under section 32 (or would be so liable but for section 32(3)) shall be deemed to aid the doing of the act by the employer or principal.
- (3) A person does not under this section knowingly aid another to do an unlawful act if-
  - (a) he acts in reliance on a statement made to him by that other person that, by reason of any provision of this Act, the act which he aids would not be unlawful; and
  - (b) it is reasonable for him to rely on the statement.
- (4) A person who knowingly or recklessly makes a statement such as is mentioned in subsection (3)(a) which in a material respect is false or misleading commits an offence, and shall be liable on summary conviction to a fine not exceeding [<sup>F146</sup>level 5 on the standard scale].

# PART V

### **CHARITIES**

### 34 Charities.

- (1) A provision which is contained in a charitable instrument (whenever that instrument took or takes effect) and which provides for conferring benefits on persons of a class defined by reference to colour shall have effect for all purposes as if it provided for conferring the like benefits—
  - (a) on persons of the class which results if the restriction by reference to colour is disregarded; or
  - (b) where the original class is defined by reference to colour only, on persons generally;

but nothing in this subsection shall be taken to alter the effect of any provision as regards any time before the coming into operation of this subsection.

- (2) Nothing in Parts II to IV shall—
  - (a) be construed as affecting a provision to which this subsection applies; or
  - (b) render unlawful an act which is done in order to give effect to such a provision.
- (3) Subsection (2) applies to any provision which is contained in a charitable instrument (whenever that instrument took or takes effect) and which provides for conferring benefits on persons of a class defined otherwise than by reference to colour (including a class resulting from the operation of subsection (1)).
- [<sup>F147</sup>(3A) subsection (2)(b) does not apply to an act which is unlawful, on grounds of race or ethnic or national origins, by virtue of section 4 or 7.]
  - (4) In this section "charitable instrument" means an enactment or other instrument passed or made for charitable purposes, or an enactment or other instrument so far as it relates to charitable purposes, and in Scotland includes the governing instrument of an endowment or of an educational endowment as those expressions are defined in section 135(1) of the <sup>M5</sup>Education (Scotland) Act 1962.

In the application of this section to England and Wales, "charitable purposes" means purposes which are exclusively charitable according to the law of England and Wales.

# PART VI

# GENERAL EXCEPTIONS FROM PARTS II TO IV

# 35 Special needs of racial groups in regard to education, training or welfare.

—Nothing in Parts II to IV shall render unlawful any act done in affording persons of a particular racial group access to facilities or services to meet the special needs of persons of that group in regard to their education, training or welfare, or any ancillary benefits.

# 36 Provision of education or training for persons not ordinarily resident in Great Britain.

—Nothing in Parts II to IV shall render unlawful any act done by a person  $[^{F148}$ , on grounds other than race or ethnic or national origins,] for the benefit of persons not ordinarily resident in Great Britain in affording them access to facilities for education or training or any ancillary benefits, where it appears to him that the persons in question do not intend to remain in Great Britain after their period of education or training there.

# **37** Discriminatory training by certain bodies.

- Nothing in Parts II to IV shall render unlawful any act done in relation to particular work by [<sup>F149</sup>any person] in or in connection with—
  - (a) affording only persons of a particular racial group access to facilities for training which would help to fit them for that work; or
  - (b) encouraging only persons of a particular racial group to take advantage of opportunities for doing that work,

where  $[^{F149}$ it reasonably appears to that person] that at any time within the twelve months immediately preceding the doing of the act—

- (i) there were no persons of that group among those doing that work in Great Britain; or
- (ii) the proportion of persons of that group among those doing that work in Great Britain was small in comparison with the proportion of persons of that group among the population of Great Britain.
- (2) Where in relation to particular work [<sup>F150</sup>it reasonably appears to any person] that although the condition for the operation of subsection (1) is not met for the whole of Great Britain it is met for an area within Great Britain, nothing in Parts II to IV shall render unlawful any act done by [<sup>F150</sup>that person] in or in connection with—
  - (a) affording persons who are of the racial group in question, and who appear likely to take up that work in that area, access to facilities for training which would help to fit them for that work; or
  - (b) encouraging persons of that group to take advantage of opportunities in the area for doing that work.

[<sup>F151</sup>(3) The preceding provisions of this section shall not apply to any discrimination which is rendered unlawful by section 4(1) or (2).]

### **38** Other discriminatory training etc.

- (1) Nothing in Parts II to IV shall render unlawful any act done by an employer in relation to particular work in his employment at a particular establishment in Great Britain, being an act done in or in connection with—
  - (a) affording only those of his employees working at that establishment who are of a particular racial group access to facilities for training which would help to fit them for that work; or
  - (b) encouraging only persons of a particular racial group to take advantage of opportunities for doing that work at that establishment,

where any of the conditions in subsection (2) was satisfied at any time within the twelve months immediately preceding the doing of the act.

- (2) Those conditions are—
  - (a) that there are no persons of the racial group in question among those doing that work at that establishment; or
  - (b) that the proportion of persons of that group among those doing that work at that establishment is small in comparison with the proportion of persons of that group—
    - (i) among all those employed by that employer there; or
    - (ii) among the population of the area from which that employer normally recruits persons for work in his employment at that establishment.
- (3) Nothing in section 11 shall render unlawful any act done by an organisation to which that section applies in or in connection with—
  - (a) affording only members of the organisation who are of a particular racial group access to facilities for training which would help to fit them for holding a post of any kind in the organisation; or
  - (b) encouraging only members of the organisation who are of a particular racial group to take advantage of opportunities for holding such posts in the organisation,

where either of the conditions in subsection (4) was satisfied at any time within the twelve months immediately preceding the doing of the act.

(4) Those conditions are—

- (a) that there are no persons of the racial group in question among persons holding such posts in that organisation; or
- (b) that the proportion of persons of that group among those holding such posts in that organisation is small in comparison with the proportion of persons of that group among the members of the organisation.

- (5) Nothing in Parts II to IV shall render unlawful any act done by an organisation to which section 11 applies in or in connection with encouraging only persons of a particular racial group to become members of the organisation where at any time within the twelve months immediately preceding the doing of the act—
  - (a) no persons of that group were members of the organisation; or
  - (b) the proportion of persons of that group among members of the organisation was small in comparison with the proportion of persons of that group among those eligible for membership of the organisation.
- (6) Section 8 (meaning of employment at establishment in Great Britain) shall apply for the purposes of this section as if this section were contained in Part II.

# **39** Sports and competitions.

—Nothing in Parts II to IV shall render unlawful any act whereby a person discriminates against another on the basis of that other's nationality or place of birth or the length of time for which he has been resident in a particular area or place, if the act is done—

- (a) in selecting one or more persons to represent a country, place or area, or any related association, in any sport or game; or
- (b) in pursuance of the rules of any competition so far as they relate to eligibility to compete in any sport or game.

# 40 Indirect access to benefits etc.

- (1) References in this Act to the affording by any person of access to benefits, facilities or services are not limited to benefits, facilities or services provided by that person himself, but include any means by which it is in that person's power to facilitate access to benefits, facilities or services provided by any other person (the "actual provider").
- (2) Where by any provision of this Act the affording by any person of access to benefits, facilities or services in a discriminatory way is in certain circumstances prevented from being unlawful, the effect of the provision shall extend also to the liability under this Act of any actual provider.

# 41 Acts done under statutory authority etc.

- (1) Nothing in Parts II to IV shall render unlawful any act of discrimination done—
  - (a) in pursuance of any enactment or Order in Council; or
  - (b) in pursuance of any instrument made under any enactment by a Minister of the Crown; or
  - (c) in order to comply with any condition or requirement imposed by a Minister of the Crown (whether before or after the passing of this Act) by virtue of any enactment.

References in this [<sup>F152</sup>section] to an enactment, Order in Council or instrument include an enactment, Order in Council or instrument passed or made after the passing of this Act.

[<sup>F153</sup>(1A) Subsection (1) does not apply to an act which is unlawful, on grounds of race or ethnic or national origins, by virtue of a provision referred to in section 1(1B).]

  - $I^{F154}(a)$  in pursuance of any enactment or Order in Council; or
    - (b) in pursuance of any instrument made under any enactment by a Minister of the Crown; or
    - (c) in order to comply with any requirement imposed by a Minister of the Crown (whether before or after the passing of this Act) by virtue of any enactment; or
    - (d) in pursuance of any arrangements made (whether before or after the passing of this Act) by or with the approval of, or for the time being approved by, a Minister of the Crown; or

# General

# 53 Restriction of proceedings for breach of Act.

(1) Except as provided by this Act [<sup>F173</sup> or the <sup>M7</sup>Special Immigration Appeals Commission Act 1997 or [<sup>F174</sup>Part 5 of the Nationality, Immigration and Asylum Act 2002]] no proceedings, whether civil or criminal, shall lie against any person in respect of an act by reason that the act is unlawful by virtue of a provision of this Act.

- (2) Subsection (1) does not preclude the making of an order of certiorari, mandamus or prohibition.
- (3) In Scotland, subsection (1) does not preclude the exercise of the jurisdiction of the Court of Session to entertain an application for reduction or suspension of any order or determination or otherwise to consider the validity of any order or determination, or to require reasons for any order or determination to be stated.
- [<sup>F175</sup>(4) Subsections (2) and (3) do not, except so far as provided by section 76, apply to any act which is unlawful by virtue of section 76(5) or (9) or by virtue of section 76(10) (b) [<sup>F176</sup>, (11) and (11B)].]

# 54A Burden of proof: employment tribunals

- (1) This section applies where a complaint is presented under section 54 and the complaint is that the respondent—
  - (a) has committed an act of discrimination, on grounds of race or ethnic or national origins, which is unlawful by virtue of any provision referred to in section 1(1B)(a), (e) or (f), or Part IV in its application to those provisions, or
  - (b) has committed an act of harassment.
- (2) Where, on the hearing of the complaint, the complainant proves facts from which the tribunal could, apart from this section, conclude in the absence of an adequate explanation that the respondent—
  - (a) has committed such an act of discrimination or harassment against the complainant, or
  - (b) is by virtue of section 32 or 33 to be treated as having committed such an act of discrimination or harassment against the complainant,

the tribunal shall uphold the complaint unless the respondent proves that he did not commit or, as the case may be, is not to be treated as having committed, that act.

# 56 Remedies on complaint under s. 54.

- (1) Where an [<sup>F183</sup>employment tribunal] finds that a complaint presented to it under section 54 is well-founded, the tribunal shall make such of the following as it considers just and equitable—
  - (a) an order declaring the rights of the complainant and the respondent in relation to the act to which the complaint relates;
  - (b) an order requiring the respondent to pay to the complainant compensation of an amount corresponding to any damages he could have been ordered by a county court or by a sheriff court to pay to the complainant if the complaint had fallen to be dealt with under section 57;
  - (c) a recommendation that the respondent take within a specified period action appearing to the tribunal to be practicable for the purpose of obviating or reducing the adverse effect on the complainant of any act of discrimination to which the complaint relates.

- (4) If without reasonable justification the respondent to a complaint fails to comply with a recommendation made by an [<sup>F183</sup>employment tribunal] under subsection (1)(c), then, if it thinks it just and equitable to do so—
  - (a) the tribunal may  $^{F186}$ ... increase the amount of compensation required to be paid to the complainant in respect of the complaint by an order made under subsection (1)(b); or
  - (b) if an order under subsection (1)(b) could have been made but was not, the tribunal may make such an order.

[<sup>F187</sup>(5) The [<sup>F188</sup>Minister] may by regulations make provision—

- (a) for enabling a tribunal, where an amount of compensation falls to be awarded under subsection (1)(b), to include in the award interest on that amount; and

# Enforcement of Part III

# 57 Claims under Part III [<sup>F191</sup>etc.].

(1) A claim by any person ("the claimant") that another person ("the respondent")-

- (a) has committed an act <sup>F192</sup>... against the claimant which is unlawful by virtue of Part III [<sup>F193</sup> other than, in relation to discrimination on grounds of race or ethnic or national origins, or harassment, section 26A or 26B]; or
- (b) is by virtue of section 32 or 33 to be treated as having committed such an act  $^{F192}$ ... against the claimant,

may be made the subject of civil proceedings in like manner as any other claim in tort or (in Scotland) in reparation for breach of statutory duty.

- (2) Proceedings under subsection (1)—
  - (a) shall, in England and Wales, be brought only in a designated county court; and
  - (b) shall, in Scotland, be brought only in a sheriff court;

but all such remedies shall be obtainable in such proceedings as, apart from this subsection and section 53(1), would be obtainable in the High Court or the Court of Session, as the case may be.

- (3) As respects an unlawful act of discrimination falling within section 1(1)(b), no award of damages shall be made if the respondent proves that the requirement or condition in question was not applied with the intention of treating the claimant unfavourably on racial grounds.
- (4) For the avoidance of doubt it is hereby declared that damages in respect of an unlawful act of discrimination may include compensation for injury to feelings whether or not they include compensation under any other head.
- [<sup>F194</sup>(4A) As respects an act which is done, or by virtue of section 32 or 33 is treated as done, by a person in carrying out public investigator functions or functions as a public prosecutor and which is unlawful by virtue of section 19B, no remedy other than—
  - (a) damages; or
  - (b) a declaration or, in Scotland, a declarator;

shall be obtainable unless the court is satisfied that the remedy concerned would not prejudice a criminal investigation, a decision to institute criminal proceedings or any criminal proceedings.

(4B) In this section-

"criminal investigation" means-

- (a) any investigation which a person in carrying out functions to which section 19B applies has a duty to conduct with a view to it being ascertained whether a person should be charged with, or in Scotland prosecuted for, an offence, or whether a person charged with or prosecuted for an offence is guilty of it;
- (b) any investigation which is conducted by a person in carrying out functions to which section 19B applies and which in the circumstances may lead to a decision by that person to institute criminal proceedings which the person has power to conduct; or
- (c) any investigation which is conducted by a person in carrying out functions to which section 19B applies and which in the circumstances may lead to a decision by that person to make a report to the procurator fiscal for the purpose of enabling him to determine whether criminal proceedings should be instituted; and

"public investigator functions" means functions of conducting criminal investigations or charging offenders;

and in this subsection "offence" includes [<sup>F195</sup>any service offence within the meaning of the Armed Forces Act 2006] (and "offender" shall be construed accordingly).

(4C) Subsection (4D) applies where a party to proceedings under subsection (1) which have arisen by virtue of section 19B has applied for a stay or sist of those proceedings on the grounds of prejudice to—

- (a) particular criminal proceedings;
- (b) a criminal investigation; or
- (c) a decision to institute criminal proceedings.
- (4D) The court shall grant the stay or sist unless it is satisfied that the continuance of the proceedings under subsection (1) would not result in the prejudice alleged.]
  - (5) Civil proceedings in respect of a claim by any person that he has been discriminated against in contravention of section 17 or 18 by a body to which [<sup>F196</sup>subsection (5A)] applies shall not be instituted unless the claimant has given notice of the claim to the Secretary of State <sup>F197</sup>....

# 57ZA Burden of proof : County and Sheriff Courts

- (1) This section applies where a claim is brought under section 57 and the claim is that the respondent—

  - (a) has committed such an act of discrimination or harassment against the claimant, or

the court shall uphold the claim unless the respondent proves that he did not commit or, as the case may be, is not to be treated as having committed, that act.

# [<sup>F201</sup>57A Claims under section 19B in immigration cases.

# 65 Help for aggrieved persons in obtaining information etc.

- (1) With a view to helping a person ("the person aggrieved") who considers he may have been discriminated against [<sup>F220</sup> or subjected to harassment] in contravention of this Act to decide whether to institute proceedings and, if he does so, to formulate and present his case in the most effective manner, the [<sup>F221</sup>Minister] shall by order prescribe—
  - (a) forms by which the person aggrieved may question the respondent on his reasons for doing any relevant act, or on any other matter which is or may be relevant; and
  - (b) forms by which the respondent may if he so wishes reply to any questions.
- (2) Where the person aggrieved questions the respondent (whether in accordance with an order under subsection (1) or not)—
  - (a) the question, and any reply by the respondent (whether in accordance with such an order or not) shall, subject to the following provisions of this section, be admissible as evidence in the proceedings;
  - (b) if it appears to the court or tribunal that the respondent deliberately, and without reasonable excuse, omitted to reply within a reasonable period [<sup>F222</sup> or,

> where the question relates to discrimination on grounds of race or ethnic or national origins, or to harassment, the period of eight weeks beginning with the day on which the question was served on him] or that his reply is evasive or equivocal, the court or tribunal may draw any inference from that fact that it considers it just and equitable to draw, including an inference that he committed an unlawful act.

- (3) The [<sup>F221</sup>Minister] may by order—
  - (a) prescribe the period within which questions must be duly served in order to be admissible under subsection (2)(a); and
  - (b) prescribe the manner in which a question, and any reply by the respondent, may be duly served.
- (4) Rules may enable the court entertaining a claim under section 57 to determine, before the date fixed for the hearing of the claim, whether a question or reply is admissible under this section or not.
- [<sup>F223</sup>(4A) In section 19B proceedings, subsection (2)(b) does not apply in relation to a failure to reply, or a particular reply, if the conditions specified in subsection (4B) are satisfied.

- (5) This section is without prejudice to any other enactment or rule of law regulating interlocutory and preliminary matters in proceedings before a county court, sheriff court or [<sup>F224</sup>employment tribunal], and has effect subject to any enactment or rule of law regulating the admissibility of evidence in such proceedings.
- (6) In this section "respondent" includes a prospective respondent and "rules"—
  - (a) in relation to county court proceedings, means county court rules;
  - (b) in relation to sheriff court proceedings, means sheriff court rules.

# Sheriff courts and designated county courts

### 67 Sheriff courts and designated county courts.

- (1) For the purposes of this Act a "designated" county court is one designated for the time being for those purposes by an order made by the Lord Chancellor [<sup>F228</sup>with the concurrence of the Lord Chief Justice].
- (2) An order under subsection (1) designating any county court for the purposes of this Act shall assign to that court as its district for those purposes any county court district or two or more county court districts.
- (3) A designated county court or a sheriff court shall have jurisdiction to entertain proceedings under this Act with respect to an act done on a ship, aircraft or hovercraft outside its district, including such an act done outside Great Britain.
- [<sup>F229</sup>(3A) A designated county court or a sheriff court shall have jurisdiction to entertain proceedings under this Act with respect to an act done outside the United Kingdom where section 19B applies in relation to such an act by virtue of section 27(1A).]
  - (4) In any proceedings under this Act in a designated county court or a sheriff court the judge or sheriff shall, unless with the consent of the parties he sits without assessors, be assisted by two assessors appointed from a list of persons prepared and maintained by the [<sup>F230</sup>Minister], being persons appearing to the [<sup>F230</sup>Minister] to have special knowledge and experience of problems connected with relations between persons of different racial groups.
  - (5) The remuneration of assessors appointed under subsection (4) shall be at such rate as may, with the approval of [<sup>F231</sup>the Treasury], be determined by the Lord Chancellor (for proceedings in England and Wales) or the Lord President of the Court of Session (for proceedings in Scotland).

- [F<sup>232</sup>(6) The Lord Chief Justice may nominate a judicial office holder (as defined in section 109(4) of the Constitutional Reform Act 2005) to exercise his functions under this section.]
  - (6) Without prejudice to section 74(3), an order for the discontinuance of the jurisdiction of any county court under this Act, whether wholly or within a part of the district assigned to it for the purposes of this Act, may include provision with respect to any proceedings under this Act commenced in that court before the order comes into operation.

- (1) Rules may make provision for enabling a court in which relevant proceedings have been brought, where it considers it expedient in the interests of national security—
  - (a) to exclude from all or part of the proceedings—
    - (i) the claimant;
    - (ii) the claimant's representatives; or
    - (iii) the assessors (if any) appointed by virtue of section 67(4);

- (3) A person appointed under subsection (2)—
  - (a) if appointed for the purposes of proceedings in England and Wales, must  $[^{F235}$  be a person who, for the purposes of the Legal Services Act 2007, is an authorised person in relation to an activity which constitutes the exercise of a right of audience or the conduct of litigation (within the meaning of that Act), and]
  - (b) if appointed for the purposes of proceedings in Scotland, must be— (i) an advocate; or

- (1) Every body or other person specified in Schedule 1A or of a description falling within that Schedule shall, in carrying out its functions, have due regard to the need—
  - (a) to eliminate unlawful racial discrimination; and
  - (b) to promote equality of opportunity and good relations between persons of different racial groups.
- (2) The [<sup>F254</sup>Minister] may by order impose, on such persons falling within Schedule 1A as he considers appropriate, such duties as he considers appropriate for the purpose of ensuring the better performance by those persons of their duties under subsection (1).
- (3) An order under subsection (2)—
  - (a) may be made in relation to a particular person falling within Schedule 1A, any description of persons falling within that Schedule or every person falling within that Schedule;
  - (b) may make different provision for different purposes.
- (4) Before making an order under subsection (2), the [<sup>F254</sup>Minister] shall consult the Commission.

# 72 Validity and revision of contracts.

(1) A term of a contract is void where—

- (a) its inclusion renders the making of the contract unlawful by virtue of this Act; or
- (b) it is included in furtherance of an act rendered unlawful by this Act; or
- (c) it provides for the doing of an act which would be rendered unlawful by this Act.
- (2) Subsection (1) does not apply to a term the inclusion of which constitutes, or is in furtherance of, or provides for, unlawful discrimination against [<sup>F269</sup> or harassment of,] a party to the contract, but the term shall be unenforceable against that party.
- (3) A term in a contract which purports to exclude or limit any provision of this Act is unenforceable by any person in whose favour the term would operate apart from this subsection.
- (4) Subsection (3) does not apply—
  - (a) to a contract settling a complaint to which section 54(1) applies where the contract is made with the assistance of a conciliation officer; or
  - [<sup>F270</sup>(aa) to a contract settling a complaint to which section 54(1) applies if the conditions regulating compromise contracts under this Act are satisfied in relation to the contract;]
    - (b) to a contract settling a claim to which section 57 applies.

[<sup>F271</sup>(4A) The conditions regulating compromise contracts under this Act are that—

- (a) the contract must be in writing;
- (b) the contract must relate to the particular complaint;
- (c) the complainant must have received [<sup>F272</sup>advice from a relevant independent advisor] as to the terms and effect of the proposed contract and in particular its effect on his ability to pursue his complaint before an [<sup>F273</sup>employment tribunal];
- (d) there must be in force, when the adviser gives the advice, a [<sup>F274</sup>contract of insurance, or an indemnity provided for members of a profession or professional body,] covering the risk of a claim by the complainant in respect of loss arising in consequence of the advice;
- (e) the contract must identify the adviser; and
- (f) the contract must state that the conditions regulating compromise contracts under this Act are satisfied.

- (b) if he is an officer, official, employee or member of an independent trade union who has been certified in writing by the trade union as competent to give advice and as authorised to do so on behalf of the trade union,
- (c) if he works at an advice centre (whether as an employee or a volunteer) and has been certified in writing by the centre as competent to give advice and as authorised to do so on behalf of the centre, or

# 72A Collective agreements and rules of undertakings

- (1) This section applies to—
  - (a) any term of a collective agreement, including an agreement which was not intended, or is presumed not to have been intended, to be a legally enforceable contract;
  - (b) any rule made by an employer for application to all or any of the persons who are employed by him or who apply to be, or are, considered by him for employment;
  - (c) any rule made by an organisation to which section 11 (trade organisations) applies, or by a body to which section 12 (qualifying bodies) applies, for application to—
    - (i) all or any of its members or prospective members; or
    - (ii) all or any of the persons on whom it has conferred authorisations or qualifications or who are seeking the authorisations or qualifications which it has power to confer.
- (2) Any term or rule to which this section applies is void where—

- (a) the making of the collective agreement is, by reason of the inclusion of the term, unlawful on grounds of race or ethnic or national origins, by virtue of a provision referred to in section 1(1B);
- (b) the term or rule is included or made in furtherance of an act which is unlawful on such grounds by virtue of such a provision; or
- (c) the term or rule provides for the doing of such an act.
- (3) Subsection (2) applies whether the agreement was entered into, or the rule made, before, on or after 19th July 2003; but in the case of an agreement entered into, or a rule made, before that date, that subsection does not apply in relation to any period before that date.
- (4) In this section, and in section 72B, "collective agreement" means any agreement relating to one or more of the matters mentioned in section 178(2) of the Trade Union and Labour Relations (Consolidation) Act 1992 <sup>M12</sup> (meaning of trade dispute), being an agreement made by or on behalf of one or more employers or one or more organisations of employers or associations of such organisations with one or more organisations of workers or associations of such organisations.

# 72B

- (1) A person to whom this subsection applies may present a complaint to an employment tribunal that a term or rule is void by virtue of section 72A if he has reason to believe—
  - (a) that the term or rule may at some future time have effect in relation to him; and
  - (b) where he alleges that it is void by virtue of section 72A(2)(c), that—
    - (i) an act for the doing of which it provides may at some such time be done in relation to him, and
    - (ii) the act would be rendered unlawful on grounds of race or ethnic or national origins by a provision referred to in section 1(1B) if done in relation to him in present circumstances.
  - (2) In the case of a complaint about—
    - (a) a term of a collective agreement made by or on behalf of—
      - (i) an employer;
      - (ii) an organisation of employers of which an employer is a member; or
      - (iii) an association of such organisations of one of which an employer is a member; or
    - (b) a rule made by an employer, within the meaning of section 72A(1)(b);

subsection (1) applies to any person who is, or is genuinely and actively seeking to become, one of his employees.

- (3) In the case of a complaint about a rule made by an organisation or body to which section 72A(1)(c) applies, subsection (1) applies to any person—
  - (a) who is, or is genuinely and actively seeking to become, a member of the organisation or body;
  - (b) on whom the organisation or body has conferred an authorisation or qualification; or

- (c) who is genuinely and actively seeking an authorisation or qualification which the organisation or body has power to confer.
- (4) When an employment tribunal finds that a complaint presented to it under subsection (1) is well-founded the tribunal shall make an order declaring that the term or rule is void.
- (5) An order under subsection (4) may include provision as respects any period before the making of the order (but after 19th July 2003).
- (6) The avoidance by virtue of section 72 A(2) of any term or rule which provides for any person to be discriminated against shall be without prejudice to the following rights (except in so far as they enable any person to require another person to be treated less favourably than himself) namely—
  - (a) such of the rights of the person to be discriminated against, and
  - (b) such of the rights of any person who will be treated more favourably in direct or indirect consequence of the discrimination,

as are conferred by or in respect of a contract made or modified wholly or partly in pursuance of, or by reference to, that term or rule.

# 73 Power to amend certain provisions of Act.

- (1) The [<sup>F279</sup>Minister] may by an order the draft of which has been approved by each House of Parliament—
  - (a) amend or repeal section 9 (including that section as amended by a previous order under this subsection);
  - (b) amend Part II, III or IV so as to render lawful an act which, apart from the amendment, would be unlawful by reason of section 4(1) or (2), [<sup>F280</sup>19B,] 20(1), 21, 24 or 25;
  - (c) amend section 10(1) or 25(1)(a) so as to alter the number of partners or members specified in that provision.

# 74 Orders and regulations.

- (1) Any power of a Minister of the Crown to make orders or regulations under the provisions of this Act<sup>F281</sup>... shall be exercisable by statutory instrument.
- (2) An order made by a Minister of the Crown under the preceding provisions of this Act [<sup>F282</sup>(except section 73(1))], and any regulations made under section [<sup>F283</sup>56(5), (6) or] 75(5)(a) [<sup>F284</sup>or (9A)], shall be subject to annulment in pursuance of a resolution of either House of Parliament.

# 75 Application to Crown etc.

- (1) This Act applies—
  - (a) to an act done by or for purposes of a Minister of the Crown or government department; or
  - (b) to an act done on behalf of the Crown by a statutory body, or a person holding a statutory office,

as it applies to an act done by a private person.

- (2) Parts II and IV apply to—
  - (a) service for purposes of a Minister of the Crown or government department, other than service of a person holding a statutory office; or
  - (b) service on behalf of the Crown for purposes of a person holding a statutory office or purposes of a statutory body; or
  - (c) service in the armed forces,

as they apply to employment by a private person, and shall so apply as if references to a contract of employment included references to the terms of service.

In this subsection "employment" includes service of any kind, and "public body" means a body of persons, whether corporate or unincorporate, carrying on a service or undertaking of a public nature.

- (6) The provisions of Parts II to IV of the <sup>M13</sup>Crown Proceedings Act 1947 shall apply to proceedings against the Crown under this Act as they apply to proceedings in England and Wales which by virtue of section 23 of that Act are treated for the purposes of Part II of that Act as civil proceedings by or against the Crown, <sup>F289</sup>....

# 76 Government appointments outside s. 4.

- (1) [<sup>F303</sup>Subsection (2)] applies to any appointment by a Minister of the Crown or government department to an office or post where section 4 does not apply in relation to the appointment.
- (2) In making the appointment, and in making the arrangements for determining who should be offered the office or post, the Minister of the Crown or government department shall not do an act which would be unlawful under section 4 if the Crown were the employer for the purposes of this Act.

[<sup>F304</sup>(3) Subsection (5) applies to—

the Race Relations Act 1976 (Repealed). (See end of Document for details)

- (a) any recommendation made by a Minister of the Crown or government department in relation to an appointment to an office or post where section 4 does not apply in relation to the appointment; and
- (b) any approval given by such a Minister or department in relation to any such appointment.
- (4) Subsection (5) also applies to-
  - (a) any recommendation made by a Minister of the Crown or government department in relation to a conferment by the Crown of a dignity or honour; and
  - (b) any approval given by such a Minister or department in relation to any such conferment.
- (5) In making the recommendation, or giving the approval, and in making the arrangements for determining who should be recommended or approved, the Minister of the Crown or government department shall not do an act which would be unlawful under section 4 if the recommendation or approval were an offer of employment and the Crown were the employer for the purposes of this Act.
- (6) Subsections (3) to (5) do not apply in relation to the making of negative recommendations.
- (7) Subsection (9) applies to—
  - (a) any negative recommendation made by a Minister of the Crown or government department, or any refusal to make a recommendation by such a Minister or department, in relation to an appointment to an office or post where section 4 does not apply in relation to the appointment; and
  - (b) any approval refused by such a Minister or department in relation to any such appointment.
- (8) Subsection (9) also applies to-
  - (a) any negative recommendation made by a Minister of the Crown or government department, or any refusal to make a recommendation by such a Minister or department, in relation to a conferment by the Crown of a dignity or honour; and
  - (b) any approval refused by such a Minister or department in relation to any such conferment.
- (9) In making a negative recommendation or in refusing to make a recommendation or give an approval, and in making the arrangements for determining whether to make such a recommendation or refusal, the Minister of the Crown or government department shall not do an act which would be unlawful under section 4 if the recommendation or refusal were a refusal to offer the person concerned employment and the Crown were the employer for the purposes of this Act.
- (10) [<sup>F305</sup>subsections (11) and (11B) apply] in relation to any appointment to an office or post where section 4 does not apply and—
  - (a) the appointment is made by a Minister of the Crown or government department; or
  - (b) the office or post is an office or post in relation to which a Minister of the Crown or government department has made a recommendation (other than a negative recommendation) or given an approval.

- (11) A Minister of the Crown or government department shall not do an act in connection with—
  - (a) the terms of the appointment;
  - (b) access for the person appointed to opportunities for promotion, transfer or training, or to any other benefits, facilities or services; or
  - (c) the termination of the appointment, or subjecting the person appointed to any other detriment;

which would be unlawful under section 4 if the Crown were the employer for the purposes of this Act.

[In subsection (11)(c) reference to the termination of the appointment includes, where  $F^{306}(11A)$  the act is committed on the grounds of race or ethnic or national origins, reference—

- (a) to the termination of the appointment by the expiration of any period (including a period expiring by reference to an event or circumstance), not being a termination immediately after which the appointment is renewed on the same terms and conditions; and
- (b) to the termination of the appointment by any act of the person appointed (including the giving of notice) in circumstances such that he is entitled to terminate the appointment by reason of the conduct of the Minister or the department, as the case may be.
- (11B) It is unlawful for a Minister of the Crown or government department to subject to harassment a person who has been appointed, or who is seeking or being considered for, the appointment.]
  - (12) The High Court may, on an application for judicial review, make a declaration to the effect that a Minister of the Crown or government department has [<sup>F307</sup> contravened—
    - (a) subsection (5);
    - (b) subsection (9);
    - (c) in relation to an appointment falling within subsection (10)(b), subsection (11); or
    - (d) subsection (11B),

and may award damages in respect of the contravention].

- (13) In Scotland, the Court of Session may, in a petition for judicial review, grant declarator to the like effect and may award damages in respect of the contravention.
- [<sup>F308</sup>(14) The provision made by subsection (12) in respect of judicial review does not affect the ability, where an act on grounds of race or ethnic or national origins, or harassment, is alleged, to present a complaint to an employment tribunal under section 54A(1).]

# 76ZA Other office holders

- (1) It is unlawful for a relevant person, in relation to an appointment to an office or post to which this section applies, to discriminate against a person on the grounds of race or ethnic or national origins—
  - (a) in the arrangements which he makes for the purpose of determining to whom the appointment should be offered;
  - (b) in the terms on which he offers him the appointment; or
  - (c) by refusing or deliberately omitting to offer him the appointment.
- (2) It is unlawful for a relevant person, in relation to a person who has been appointed to an office or post to which this section applies, to discriminate against him on grounds of race or ethnic or national origins—
  - (a) in the terms of the appointment;
  - (b) in the way he affords him access to opportunities for promotion, transfer, training or to any other benefits, facilities or services, or by refusing or deliberately omitting to afford him access to them;
  - (c) by terminating the appointment; or
  - (d) by subjecting him to any other detriment in relation to the appointment.
- (3) It is unlawful for a relevant person, in relation to an office or post to which this section applies, to subject to harassment a person who has been appointed to, or is seeking or being considered for appointment to, such an office or post.
- (4) Subsections (1) and (2) do not apply to any act in relation to an office or post where, if the office or post constituted employment, the act would be lawful by virtue of section 4A (exception for genuine occupational requirement).
- (5) Subsection (2) does not apply to benefits, facilities or services of any description if the relevant person is concerned with the provision (for payment or not) of benefits,

facilities or services of that description to the public, or a section of the public to which the person belongs, unless—

- (a) that provision differs in a material respect from the provision of the benefits, facilities or services to persons appointed to offices or posts which are the same as, or not materially different from, that to which the person has been appointed;
- (b) the provision of the benefits, facilities or services to the person appointed is regulated by the terms and conditions of his appointment; or
- (c) the benefits, facilities or services relate to training.
- (6) In subsection (2)(c) reference to the termination of the appointment includes reference—
  - (a) to the termination of the appointment by the expiration of any period (including a period expiring by reference to an event or circumstance), not being a termination immediately after which the appointment is renewed on the same terms and conditions; and
  - (b) to the termination of the appointment by any act of the person appointed (including the giving of notice) in circumstances such that he is entitled to terminate the appointment by reason of the conduct of the relevant person.

(7) This section applies to any office or post, other than a political office or post, where—

- (a) sections 4, 7, 10, 26A, 26B and 76 do not apply in relation to appointment to that office or post;
- (b) it is an office or post to which persons are appointed to discharge functions personally under the direction of another person; and
- (c) it is an office or post in respect of which they are entitled to remuneration.

(8) For the purposes of subsection (7) the holder of an office or post—

- (a) is to be regarded as discharging his functions under the direction of another person if that other person is entitled to direct him as to when and where he discharges those functions; and
- (b) is not to be regarded as entitled to remuneration merely because he is entitled to payments—
  - (i) in respect of expenses incurred by him in carrying out the functions of the office or post, or
  - (ii) by way of compensation for the loss of income or benefits he would or might have received from any person had he not been carrying out the functions of the office or post.

(9) In this section—

- (a) appointment to an office or post does not include election to an office or post;
- (b) "political office or post" means-
  - (i) any office of the House of Commons held by a member of it;
  - (ii) a life peerage within the meaning of the Life Peerages Act 1958 <sup>M16</sup>, or any office held in the House of Lords by a member of it;
  - (iii) any office mentioned in Schedule 2 (Ministerial offices) to the House of Commons Disqualification Act 1975 <sup>M17</sup>;
  - (iv) the offices of Leader of the Opposition, Chief Opposition Whip or Assistant Opposition Whip within the meaning of the Ministerial and other Salaries Act 1975 <sup>M18</sup>;
  - (v) any office of the Scottish Parliament held by a member of it;

- (vi) a member of the Scottish Executive within the meaning of section 44 of the Scotland Act 1998 <sup>M19</sup>, or a junior Scottish Minister within the meaning of section 49 of that Act;
- (vii) any office of the National Assembly for Wales held by a member of it;
- [<sup>F310</sup>(viia) a member of the Welsh Assembly Government;]
  - (viii) in England, any office of a county council, a London borough council, a district council or a parish council held by a member of it;
  - (ix) in Wales, any office of a county council, a county borough council or a community council held by a member of it;
  - (x) in relation to a council constituted under section 2 of the Local Government etc (Scotland) Act 1994 <sup>M20</sup> or a community council established under section 51 of the Local Government (Scotland) Act 1973 <sup>M21</sup>, which is held by a member of it;
  - (xi) any office of the Greater London Authority held by a member of it;
  - (xii) any office of the Common Council of the City of London held by a member of it;
  - (xiii) any office of the Council of the Isles of Scilly held by a member of it; or
  - (xiv) any office of a political party; and
- (c) "relevant person", in relation to an office or post, means-
  - (i) any person with power to make or terminate appointments to the office or post, or to determine the terms of appointment; and
  - (ii) any person with power to determine the working conditions of a person appointed to the office or post in relation to opportunities for promotion, a transfer, training or for receiving any other benefit.

# F31276A Police forces.

- (1) In this section, "relevant police office" means-
  - (a) the office of constable held—
    - (i) as a member of a police force; or
    - (ii) on appointment as a special constable for a police area; or
  - (b) an appointment as police cadet to undergo training with a view to becoming a member of a police force.
- (2) For the purposes of Part II, the holding of a relevant police office shall be treated as employment—
  - (a) by the chief officer of police as respects any act done by him in relation to that office or a holder of it;
  - (b) by the police authority as respects any act done by it in relation to that office or a holder of it.

(3) For the purposes of section 32—

- (a) the holding of a relevant police office shall be treated as employment by the chief officer of police (and as not being employment by any other person); and
- (b) anything done by a person holding such an office in the performance, or purported performance, of his functions shall be treated as done in the course of that employment.
- (4) There shall be paid out of the police fund—
  - (a) any compensation, costs or expenses awarded against a chief officer of police in any proceedings brought against him under this Act, and any costs or expenses incurred by him in any such proceedings so far as not recovered by him in the proceedings; and
  - (b) any sum required by a chief officer of police for the settlement of any claim made against him under this Act if the settlement is approved by the police authority.
- (5) Any proceedings under this Act which, by virtue of this section, would lie against a chief officer of police shall be brought against—
  - (a) the chief officer of police for the time being; or
  - (b) in the case of a vacancy in that office, against the person for the time being performing the functions of that office;

and references in subsection (4) to the chief officer of police shall be construed accordingly.

- (6) A police authority may, in such cases and to such extent as appear to it to be appropriate, pay out of the police fund—
  - (a) any damages or costs awarded in proceedings under this Act against a person under the direction and control of the chief officer of police;

- (b) any costs incurred and not recovered by such a person in such proceedings; and
- (c) any sum required in connection with the settlement of a claim that has or might have given rise to such proceedings.

#### 77 Financial provisions.

There shall be defrayed out of money provided by Parliament-

- (a) sums required by the Secretary of State for making payments under paragraph 5 or 16 of Schedule 1 or paragraph 12 of Schedule 2, and for defraying any other expenditure falling to be made by him under or by virtue of this Act;
- (b) any expenses incurred by the Secretary of State with the consent of the Treasury in undertaking, or financially assisting the undertaking by other persons of, research into any matter connected with relations between persons of different racial groups;
- (c) payments falling to be made under section 67(5) in respect of the remuneration of assessors; and
- (d) any increase attributable to the provisions of this Act in the sums payable out of money provided by Parliament under any other Act.

#### 78 General interpretation provisions.

(1) In this Act, unless the context otherwise requires—

"access" shall be construed in accordance with section 40;

"act" includes a deliberate omission;

"advertisement" includes every form of advertisement or notice, whether to the public or not, and whether in a newspaper or other publication, by television or radio, by display of notices, signs, labels, showcards or goods, by distribution of samples, circulars, catalogues, price lists or other material, by exhibition of pictures, models or films, or in any other way, and references to the publishing of advertisements shall be construed accordingly;
