

# Estate Agents Act 1979

### **1979 CHAPTER 38**

Supervision, enforcement, publicity etc.

#### 26 Enforcement authorities.

- (1) Without prejudice to section 25(1) above, the following authorities (in this Act referred to as "enforcement authorities") have a duty to enforce this Act—
  - (a) the [F1]lead enforcement authority],
  - (b) in Great Britain, a local weights and measures authority, and
  - (c) in Northern Ireland, the [F2Department of Enterprise, Trade and Investment in Northern Ireland].
- [F3(1A) For the investigatory powers available to an authority for the purposes of the duty in subsection (1), see Schedule 5 to the Consumer Rights Act 2015.]
  - - (3) Nothing in this section or in section 25 above authorises an enforcement authority to institute proceedings in Scotland for an offence.
    - (4) Every local weights and measures authority shall, whenever the [F5]lead enforcement authority] requires, report to [F6it] in such form and with such particulars as [F6it] requires on the exercise of their functions under this Act.
