- (1) In this Act “the [^{F2}Relevant Authority]” means the [^{F3}Regulator of Social Housing], [^{F4}the Secretary of State] or Scottish Homes, subject as follows.
- (2) In relation to a housing association which is—
 - (a) a registered charity which has its address for the purposes of registration by the [^{F5}Charity Commission] in Wales,
 - (b) a [^{F6}registered society within the meaning of the Co-operative and Community Benefit Societies Act 2014] which has its registered office for the purposes of that Act in Wales, or
 - (c) a company [^{F7}registered under the Companies Act 2006] which has its registered office for the purposes of that Act in Wales,“the [^{F2}Relevant Authority]” means [^{F4}the Secretary of State].
- (3) In relation to a housing association which is a [^{F6} registered society within the meaning of the Co-operative and Community Benefit Societies Act 2014] which has its registered office for the purposes of that Act in Scotland, “the [^{F2}Relevant Authority]” means Scottish Homes.
- (4) In relation to any other housing association which is a registered charity, a [^{F6}registered society within the meaning of the Co-operative and Community Benefit Societies Act 2014] or a company [^{F7}registered under the Companies Act 2006], “the [^{F2}Relevant Authority]” means the [^{F8}Regulator of Social Housing].
