(9) Nothing in this Part of this Act, except section 1, shall affect^{F2}—

(a) any educational endowment within the meaning of section 122(1) of the ^{M1}Education (Scotland) Act 1980^{F3}; or

(b) any body entered in the Scottish Charity Register.]

(10) The ^{M2}War Charities Act 1940 shall cease to have effect as regards Scotland; but nothing in this subsection shall affect any prosecution for an offence under that Act which has been instituted before the commencement of this section.

- (11) Any power in this Part of this Act of the Secretary of State to make regulations or orders shall be exercisable by statutory instrument subject to annulment in pursuance of a resolution of either House of Parliament.
