- 12 (1) As soon as possible after the end of each financial year, the [F<sup>1</sup>Service] shall prepare a general report of their proceedings during that year and transmit it to [F<sup>2</sup>OFCOM].

[F<sup>3</sup>(1A) The report must include a statement of how the Service are proposing to carry out their functions during the next financial year.]

- (2) The report shall have attached to it the statement of accounts for the year and a copy of any report made by the auditors on that statement.

- (3) [F<sup>2</sup>OFCOM] shall send a copy of each annual report received by them in accordance with this paragraph to

[F<sup>4</sup>(a) the Secretary of State, who must lay a copy of it before each House of Parliament, and

(b) the Scottish Ministers, who must lay a copy of it before the Scottish Parliament.]
