##### *Charges, fees and contributions payable by undertakers*

#### **76 Liability for cost of temporary traffic regulation.**

- (1) Where by reason of street works—
- the traffic authority makes an order or issues a notice under section 14 of the <sup>M1</sup>Road Traffic Regulation Act 1984 (temporary prohibition or restriction of traffic), or
  - a concessionaire issues a notice under that section by virtue of section 3(4) of this Act,
- the authority or concessionaire may recover from the undertaker the whole of the costs incurred by them in connection with or in consequence of the order or notice.
- (2) Those costs shall be taken to include, in particular, the cost to the authority or concessionaire—
- of complying with any requirement to notify the public of any matter in connection with the making, issuing or operation of the order or notice, and
  - of providing traffic signs in connection with the prohibition or restriction of traffic by the order or notice.
