1991 CHAPTER 48

An Act to make provision for the [^{F1}calculation], collection and enforcement of periodical maintenance payable by certain parents with respect to children of theirs who are not in their care; for the collection and enforcement of certain other kinds of maintenance; and for connected purposes. [25th July 1991]

Be it enacted by the Queen's most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the authority of the same, as follows:—

The basic principles

1 The duty to maintain.

- (1) For the purposes of this Act, each parent of a qualifying child is responsible for maintaining him.
- (2) For the purposes of this Act, [^{F2}a non-resident parent] shall be taken to have met his responsibility to maintain any qualifying child of his by making periodical payments of maintenance with respect to the child of such amount, and at such intervals, as may be determined in accordance with the provisions of this Act.
- (3) Where a [^{F3}maintenance calculation] made under this Act requires the making of periodical payments, it shall be the duty of the [^{F2}non-resident parent] with respect to whom the [^{F1}calculation] was made to make those payments.

2 Welfare of children: the general principle.

Where, in any case which falls to be dealt with under this Act, the Secretary of State ^{F4}... is considering the exercise of any discretionary power conferred by this Act, he shall have regard to the welfare of any child likely to be affected by his decision.

3 Meaning of certain terms used in this Act.

- (1) A child is a “qualifying child” if—
 - (a) one of his parents is, in relation to him, [^{F2}a non-resident parent]; or
 - (b) both of his parents are, in relation to him, [^{F2}non-resident parents].

- (2) The parent of any child is [^{F2}a “non-resident parent”], in relation to him, if—
 - (a) that parent is not living in the same household with the child; and
 - (b) the child has his home with a person who is, in relation to him, a person with care.
- (3) A person is a “person with care”, in relation to any child, if he is a person—
 - (a) with whom the child has his home;
 - (b) who usually provides day to day care for the child (whether exclusively or in conjunction with any other person); and
 - (c) who does not fall within a prescribed category of person.
- (4) The Secretary of State shall not, under subsection (3)(c), prescribe as a category—
 - (a) parents;
 - (b) guardians;
 - (c) persons in whose favour residence orders under section 8 of the ^{M1}Children Act 1989 are in force;
 - (d) in Scotland, persons [^{F5}with whom a child is to live by virtue of a residence order under section 11 of the Children (Scotland) Act 1995.]
- (5) For the purposes of this Act there may be more than one person with care in relation to the same qualifying child.
- (6) Periodical payments which are required to be paid in accordance with a [^{F3}maintenance calculation] are referred to in this Act as “child support maintenance”.
- (7) Expressions are defined in this section only for the purposes of this Act.

4 Child support maintenance.

- (1) A person who is, in relation to any qualifying child or any qualifying children, either the person with care or the [F²non-resident parent] may apply to the Secretary of State for a [F³maintenance calculation] to be made under this Act with respect to that child, or any of those children.
- (2) Where a [F³maintenance calculation] has been made in response to an application under this section the Secretary of State may, if the person with care or [F²non-resident parent] with respect to whom the [F¹calculation] was made applies to him under this subsection, arrange for—
 - (a) the collection of the child support maintenance payable in accordance with the [F¹calculation];
 - (b) the enforcement of the obligation to pay child support maintenance in accordance with the [F¹calculation].
- (3) Where an application under subsection (2) for the enforcement of the obligation mentioned in subsection (2)(b) authorises the Secretary of State to take steps to enforce that obligation whenever he considers it necessary to do so, the Secretary of State may act accordingly.
- (4) A person who applies to the Secretary of State under this section shall, so far as that person reasonably can, comply with such regulations as may be made by the Secretary of State with a view to the Secretary of State F⁶... being provided with the information which is required to enable—
 - (a) the [F²non-resident parent] to be [F⁷identified or] traced (where that is necessary);
 - (b) the amount of child support maintenance payable by the [F²non-resident parent] to be assessed; and
 - (c) that amount to be recovered from the [F²non-resident parent].
- (5) Any person who has applied to the Secretary of State under this section may at any time request him to cease acting under this section.
- (6) It shall be the duty of the Secretary of State to comply with any request made under subsection (5) (but subject to any regulations made under subsection (8)).
- (7) The obligation to provide information which is imposed by subsection (4)—
 - (a) shall not apply in such circumstances as may be prescribed; and
 - (b) may, in such circumstances as may be prescribed, be waived by the Secretary of State.
- (8) The Secretary of State may by regulations make such incidental, supplemental or transitional provision as he thinks appropriate with respect to cases in which he is requested to cease to act under this section.
- (9) No application may be made under this section if there is in force with respect to the person with care and [F²non-resident parent] in question a [F³maintenance calculation] made in response to an application [F⁸treated as made] under section 6.

5 Child support maintenance: supplemental provisions.

- (1) Where—
 - (a) there is more than one person with care of a qualifying child; and
 - (b) one or more, but not all, of them have parental responsibility for ^{F12}... the child; no application may be made for a [^{F3}maintenance calculation] with respect to the child by any of those persons who do not have parental responsibility for ^{F12}... the child.
- (2) Where more than one application for a [^{F3}maintenance calculation] is made with respect to the child concerned, only one of them may be proceeded with.
- (3) The Secretary of State may by regulations make provision as to which of two or more applications for a [^{F3}maintenance calculation] with respect to the same child is to be proceeded with.

^{F13}6 Applications by those claiming or receiving benefit.

- (1) This section applies where income support, an income-based jobseeker's allowance or any other benefit of a prescribed kind is claimed by or in respect of, or paid to or in respect of, the parent of a qualifying child who is also a person with care of the child.
- (2) In this section, that person is referred to as "the parent".
- (3) The Secretary of State may—
 - (a) treat the parent as having applied for a maintenance calculation with respect to the qualifying child and all other children of the non-resident parent in relation to whom the parent is also a person with care; and
 - (b) take action under this Act to recover from the non-resident parent, on the parent's behalf, the child support maintenance so determined.
- (4) Before doing what is mentioned in subsection (3), the Secretary of State must notify the parent in writing of the effect of subsections (3) and (5) and section 46.
- (5) The Secretary of State may not act under subsection (3) if the parent asks him not to (a request which need not be in writing).
- (6) Subsection (1) has effect regardless of whether any of the benefits mentioned there is payable with respect to any qualifying child.
- (7) Unless she has made a request under subsection (5), the parent shall, so far as she reasonably can, comply with such regulations as may be made by the Secretary of

- State with a view to the Secretary of State's being provided with the information which is required to enable—
- (a) the non-resident parent to be identified or traced;
 - (b) the amount of child support maintenance payable by him to be calculated; and
 - (c) that amount to be recovered from him.
- (8) The obligation to provide information which is imposed by subsection (7)—
- (a) does not apply in such circumstances as may be prescribed; and
 - (b) may, in such circumstances as may be prescribed, be waived by the Secretary of State.
- (9) If the parent ceases to fall within subsection (1), she may ask the Secretary of State to cease acting under this section, but until then he may continue to do so.
- (10) The Secretary of State must comply with any request under subsection (9) (but subject to any regulations made under subsection (11)).
- (11) The Secretary of State may by regulations make such incidental or transitional provision as he thinks appropriate with respect to cases in which he is asked under subsection (9) to cease to act under this section.
- (12) The fact that a maintenance calculation is in force with respect to a person with care does not prevent the making of a new maintenance calculation with respect to her as a result of the Secretary of State's acting under subsection (3).]

7 **Right of child in Scotland to apply for [F¹ calculation].**

- (1) A qualifying child who has attained the age of 12 years and who is habitually resident in Scotland may apply to the Secretary of State for a [F³ maintenance calculation] to be made with respect to him if—
- (a) no such application has been made by a person who is, with respect to that child, a person with care or [F² a non-resident parent]; or
 - [F¹⁴(b) no parent has been treated under section 6(3) as having applied for a maintenance calculation with respect to the child.]
- (2) An application made under subsection (1) shall authorise the Secretary of State to make a [F³ maintenance calculation] with respect to any other children of the [F² non-resident parent] who are qualifying children in the care of the same person as the child making the application.
- (3) Where a [F³ maintenance calculation] has been made in response to an application under this section the Secretary of State may, if the person with care, the [F² non-resident parent] with respect to whom the [F¹ calculation] was made or the child concerned applies to him under this subsection, arrange for—
- (a) the collection of the child support maintenance payable in accordance with the [F¹ calculation];

8 Role of the courts with respect to maintenance for children.

- (1) This subsection applies in any case where [^{F20}the Secretary of State] would have jurisdiction to make a [^{F3}maintenance calculation] with respect to a qualifying child and [^{F2}a non-resident parent] of his on an application duly made [^{F21}(or treated as made)] by a person entitled to apply for such [^{F1}a calculation] with respect to that child.

9 Agreements about maintenance.

- (1) In this section “maintenance agreement” means any agreement for the making, or for securing the making, of periodical payments by way of maintenance, or in Scotland aliment, to or for the benefit of any child.
- (2) Nothing in this Act shall be taken to prevent any person from entering into a maintenance agreement.
- (3) [^{F25}Subject to section 4(10)(a) and section 7(10),] the existence of a maintenance agreement shall not prevent any party to the agreement, or any other person, from applying for a [^{F3}maintenance calculation] with respect to any child to or for whose benefit periodical payments are to be made or secured under the agreement.
- (4) Where any agreement contains a provision which purports to restrict the right of any person to apply for a [^{F3}maintenance calculation], that provision shall be void.

10 Relationship between maintenance [^{F1}calculations] and certain court orders and related matters.

28J Voluntary payments.

31 Deduction from earnings orders.

- (1) The Secretary of State may by regulations make provision with respect to deduction from earnings orders.
- (2) The regulations may, in particular, make provision—
 - (a) as to the circumstances in which one person is to be treated as employed by another;
 - (b) requiring any deduction from earnings under an order to be made in the prescribed manner;
 - ^[F116](bb) for the amount or amounts which are to be deducted from the liable person's earnings not to exceed a prescribed proportion of his earnings (as determined by the employer);]
 - (c) requiring an order to specify the amount or amounts to which the order relates and the amount or amounts which are to be deducted from the liable person's earnings in order to meet his liabilities under the ^[F3]maintenance calculation] in question;

 - (k) similar to that made by section 31(7), in relation to any variation of an order;
 - (l) for an order to lapse when the employer concerned ceases to have the liable person in his employment;
 - (m) as to the revival of an order in such circumstances as may be prescribed;
 - (n) allowing or requiring an order to be discharged;

- (8) If any person fails to comply with the requirements of a deduction from earnings order, or with any regulation under this section which is designated for the purposes of this subsection, he shall be guilty of an offence.

50 Unauthorised disclosure of information.

55 Meaning of “child”.

- (1) For the purposes of this Act a person is a child if—
 - (a) he is under the age of 16;
 - (b) he is under the age of 19 and receiving full-time education (which is not advanced education)—
 - (i) by attendance at a recognised educational establishment; or
 - (ii) elsewhere, if the education is recognised by the Secretary of State; or
 - (c) he does not fall within paragraph (a) or (b) but—
 - (i) he is under the age of 18, and

CALCULATION OF WEEKLY AMOUNT OF CHILD SUPPORT MAINTENANCE

General rule

- 1 (1) The weekly rate of child support maintenance is the basic rate unless a reduced rate, a flat rate or the nil rate applies.
- (2) Unless the nil rate applies, the amount payable weekly to a person with care is—
- (a) the applicable rate, if paragraph 6 does not apply; or
 - (b) if paragraph 6 does apply, that rate as apportioned between the persons with care in accordance with paragraph 6,
- as adjusted, in either case, by applying the rules about shared care in paragraph 7 or 8.

Basic rate

- 2 (1) The basic rate is the following percentage of the non-resident parent's net weekly income—
- 15% where he has one qualifying child;
 - 20% where he has two qualifying children;
 - 25% where he has three or more qualifying children.
- (2) If the non-resident parent also has one or more relevant other children, the appropriate percentage referred to in sub-paragraph (1) is to be applied instead to his net weekly income less—
- 15% where he has one relevant other child;
 - 20% where he has two relevant other children;

Reduced rate

- 3 (1) A reduced rate is payable if—

Flat rate

- 4 (1) Except in a case falling within sub-paragraph (2), a flat rate of £5 is payable if the nil rate does not apply and—
- (a) the non-resident parent's net weekly income is £100 or less; or
 - (b) he receives any benefit, pension or allowance prescribed for the purposes of this paragraph of this sub-paragraph; or
 - (c) he or his partner (if any) receives any benefit prescribed for the purposes of this paragraph of this sub-paragraph.
- (2) A flat rate of a prescribed amount is payable if the nil rate does not apply and—
- (a) the non-resident parent has a partner who is also a non-resident parent;
 - (b) the partner is a person with respect to whom a maintenance calculation is in force; and
 - (c) the non-resident parent or his partner receives any benefit prescribed under sub-paragraph (1)(c).
- (3) The benefits, pensions and allowances which may be prescribed for the purposes of sub-paragraph (1)(b) include ones paid to the non-resident parent under the law of a place outside the United Kingdom.

Nil rate

- 5 The rate payable is nil if the non-resident parent—
- (a) is of a prescribed description; or
 - (b) has a net weekly income of below £5.

Apportionment

- 6 (1) If the non-resident parent has more than one qualifying child and in relation to them there is more than one person with care, the amount of child support maintenance payable is (subject to paragraph 7 or 8) to be determined by apportioning the rate between the persons with care.
- (2) The rate of maintenance liability is to be divided by the number of qualifying children, and shared among the persons with care according to the number of qualifying children in relation to whom each is a person with care.

Shared care—basic and reduced rate

- 7 (1) This paragraph applies only if the rate of child support maintenance payable is the basic rate or a reduced rate.

 - (b) costs attributable to a long-term illness or disability of a relevant other child (within the meaning of paragraph 10C(2) of Schedule 1);
 - (c) debts of a prescribed description incurred, before the non-resident parent became a non-resident parent in relation to a child with respect to whom the maintenance calculation has been applied for (or treated as having been applied for)—
 - (i) for the joint benefit of both parents;
