The basic principles

1 The duty to maintain.

- (1) For the purposes of this Act, each parent of a qualifying child is responsible for maintaining him.
- (2) For the purposes of this Act, [F2 a non-resident parent] shall be taken to have met his responsibility to maintain any qualifying child of his by making periodical payments of maintenance with respect to the child of such amount, and at such intervals, as may be determined in accordance with the provisions of this Act.

3 Meaning of certain terms used in this Act.

- (1) A child is a "qualifying child" if—
 - (a) one of his parents is, in relation to him, [F2 a non-resident parent]; or
 - (b) both of his parents are, in relation to him, [F2non-resident parents].

4 Child support maintenance.

- (1) A person who is, in relation to any qualifying child or any qualifying children, either the person with care or the [F2non-resident parent] may apply to the Secretary of State for a [F3maintenance calculation] to be made under this Act with respect to that child, or any of those children.

8 Role of the courts with respect to maintenance for children.

- (1) This subsection applies in any case where [F23 the Secretary of State] would have jurisdiction to make a [F3 maintenance calculation] with respect to a qualifying child and [F2 a non-resident parent] of his on an application duly made [F24 (or treated as made)] by a person entitled to apply for such [F1 a calculation] with respect to that child.

- (10) This section shall not prevent a court from exercising any power which it has to make a maintenance order in relation to a child if the order is made against a person with care of the child.
- (11) In this Act "maintenance order", in relation to any child, means an order which requires the making or securing of periodical payments to or for the benefit of the child and which is made under—

9 Agreements about maintenance.

(1) In this section "maintenance agreement" means any agreement for the making, or for securing the making, of periodical payments by way of maintenance, or in Scotland aliment, to or for the benefit of any child.

- (2) Nothing in this Act shall be taken to prevent any person from entering into a maintenance agreement.
- (3) [F32Subject to section 4(10)(a) [F33and (ab)] and section 7(10),] the existence of a maintenance agreement shall not prevent any party to the agreement, or any other person, from applying for a [F3maintenance calculation] with respect to any child to or for whose benefit periodical payments are to be made or secured under the agreement.
- (4) Where any agreement contains a provision which purports to restrict the right of any person to apply for a [F3 maintenance calculation], that provision shall be void.

10 Relationship between maintenance [F1 calculations] and certain court orders and related matters.

- (1) Where an order of a kind prescribed for the purposes of this subsection is in force with respect to any qualifying child with respect to whom a [F3 maintenance calculation] is made, the order—
 - (a) shall, so far as it relates to the making or securing of periodical payments, cease to have effect to such extent as may be determined in accordance with regulations made by the Secretary of State; or
 - (b) where the regulations so provide, shall, so far as it so relates, have effect subject to such modifications as may be so determined.
- (2) Where an agreement of a kind prescribed for the purposes of this subsection is in force with respect to any qualifying child with respect to whom a [F3 maintenance calculation] is made, the agreement—
 - (a) shall, so far as it relates to the making or securing of periodical payments, be unenforceable to such extent as may be determined in accordance with regulations made by the Secretary of State; or
 - (b) where the regulations so provide, shall, so far as it so relates, have effect subject to such modifications as may be so determined.

31 Deduction from earnings orders.

35 Enforcement of liability orders by distress.

- (1) Where a liability order has been made against a person ("the liable person"), the Secretary of State may levy the appropriate amount by distress and sale of the liable person's goods.
- (2) In subsection (1), "the appropriate amount" means the aggregate of—
 - (a) the amount in respect of which the order was made, to the extent that it remains unpaid; and

- (3) The Secretary of State may, in exercising his powers under subsection (1) against the liable person's goods, seize—
 - (a) any of the liable person's goods except—
 - (i) such tools, books, vehicles and other items of equipment as are necessary to him for use personally by him in his employment, business or vocation;
 - (ii) such clothing, bedding, furniture, household equipment and provisions as are necessary for satisfying his basic domestic needs; and
 - (b) any money, banknotes, bills of exchange, promissory notes, bonds, specialties or securities for money belonging to the liable person.
- (4) For the purposes of subsection (3), the liable person's domestic needs shall be taken to include those of any member of his family with whom he resides.
- (5) No person levying a distress under this section shall be taken to be a trespasser—
 - (a) on that account; or
 - (b) from the beginning, on account of any subsequent irregularity in levying the distress.
- (6) A person sustaining special damage by reason of any irregularity in levying a distress under this section may recover full satisfaction for the damage (and no more) by proceedings in trespass or otherwise.

57 Application to Crown.

- (1) The power of the Secretary of State to make regulations under section 14 requiring prescribed persons to furnish information may be exercised so as to require information to be furnished by persons employed in the service of the Crown or otherwise in the discharge of Crown functions.

PROVISION OF INFORMATION TO SECRETARY OF STATE

Inland Revenue records



PART I

THE CASES

General

- 1 (1) The cases in which a variation may be agreed are those set out in this Part of this Schedule or in regulations made under this Part.

 - (a) the amount payable by the non-resident parent by way of maintenance was less than would have been the case had that transfer or those transfers not been made; or
 - (b) no amount was payable by the non-resident parent by way of maintenance.
 - (3) For the purposes of sub-paragraph (2), "maintenance" means periodical payments of maintenance made (otherwise than under this Act) with respect to the child, or any of the children, with respect to whom the application for a maintenance calculation has been made.

Additional cases

- 4 (1) The Secretary of State may by regulations prescribe other cases in which a variation may be agreed.
 - (2) Regulations under this paragraph may, for example, make provision with respect to cases where—
 - (a) the non-resident parent has assets which exceed a prescribed value;
 - (b) a person's lifestyle is inconsistent with his income for the purposes of a calculation made under Part I of Schedule 1;
 - (c) a person has income which is not taken into account in such a calculation;
 - (d) a person has unreasonably reduced the income which is taken into account in such a calculation.

PART II

REGULATORY CONTROLS

- 5 (1) The Secretary of State may by regulations make provision with respect to the variations from the usual rules for calculating maintenance which may be allowed when a variation is agreed.
 - (2) No variations may be made other than those which are permitted by the regulations.
 - (3) Regulations under this paragraph may, in particular, make provision for a variation to result in—
 - (a) a person's being treated as having more, or less, income than would be taken into account without the variation in a calculation under Part I of Schedule 1;

- (b) a person's being treated as liable to pay a higher, or a lower, amount of child support maintenance than would result without the variation from a calculation under that Part.
- (4) Regulations may provide for the amount of any special expenses to be taken into account in a case falling within paragraph 2, for the purposes of a variation, not to exceed such amount as may be prescribed or as may be determined in accordance with the regulations.
- (5) Any regulations under this paragraph may in particular make different provision with respect to different levels of income.
- The Secretary of State may by regulations provide for the application, in connection with child support maintenance payable following a variation, of paragraph 7(2) to (7) of Schedule 1 (subject to any prescribed modifications).]
