

Child Support Act 1991

1991 CHAPTER 48

An Act to make provision for the [^{F1}calculation], collection and enforcement of periodical maintenance payable by certain parents with respect to children of theirs who are not in their care; for the collection and enforcement of certain other kinds of maintenance; and for connected purposes. [25th July 1991]

Be it enacted by the Queen's most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the authority of the same, as follows:—

The basic principles

1 The duty to maintain.

- (1) For the purposes of this Act, each parent of a qualifying child is responsible for maintaining him.
- (2) For the purposes of this Act, [^{F2}a non-resident parent] shall be taken to have met his responsibility to maintain any qualifying child of his by making periodical payments of maintenance with respect to the child of such amount, and at such intervals, as may be determined in accordance with the provisions of this Act.
- (3) Where a [^{F3}maintenance calculation] made under this Act requires the making of periodical payments, it shall be the duty of the [^{F2}non-resident parent] with respect to whom the [^{F1}calculation] was made to make those payments.

Where, in any case which falls to be dealt with under this Act, the [^{F4}Commission]^{F5}... is considering the exercise of any discretionary power conferred by this Act, [^{F6}it] shall have regard to the welfare of any child likely to be affected by [^{F7}its] decision.

3 Meaning of certain terms used in this Act.

- (1) A child is a "qualifying child" if—
 - (a) one of his parents is, in relation to him, [^{F2}a non-resident parent]; or
 - (b) both of his parents are, in relation to him, $[^{F2}$ non-resident parents].
- (2) The parent of any child is [^{F2}a "non-resident parent"], in relation to him, if—
 - (a) that parent is not living in the same household with the child; and
 - (b) the child has his home with a person who is, in relation to him, a person with care.
- (3) A person is a "person with care", in relation to any child, if he is a person-
 - (a) with whom the child has his home;
 - (b) who usually provides day to day care for the child (whether exclusively or in conjunction with any other person); and
 - (c) who does not fall within a prescribed category of person.
- (4) The Secretary of State shall not, under subsection (3)(c), prescribe as a category—
 - (a) parents;
 - (b) guardians;
 - (c) persons in whose favour residence orders under section 8 of the ^{MI}Children Act 1989 are in force;
 - (d) in Scotland, persons [^{F8}with whom a child is to live by virtue of a residence order under section 11 of the Children (Scotland) Act 1995.]
- (5) For the purposes of this Act there may be more than one person with care in relation to the same qualifying child.
- (6) Periodical payments which are required to be paid in accordance with a [^{F3}maintenance calculation] are referred to in this Act as "child support maintenance".
- (7) Expressions are defined in this section only for the purposes of this Act.

4 Child support maintenance.

- (1) A person who is, in relation to any qualifying child or any qualifying children, either the person with care or the [^{F2}non-resident parent] may apply to the [^{F9}Commission] for a [^{F3}maintenance calculation] to be made under this Act with respect to that child, or any of those children.
- (2) Where a [^{F3}maintenance calculation] has been made in response to an application under this section the [^{F10}Commission] may, if the person with care or [^{F2}non-resident parent] with respect to whom the [^{F1}calculation] was made applies to [^{F11}it] under this subsection, arrange for—
 - (a) the collection of the child support maintenance payable in accordance with the [^{F1}calculation];
 - (b) the enforcement of the obligation to pay child support maintenance in accordance with the [F1 calculation].
- (3) Where an application under subsection (2) for the enforcement of the obligation mentioned in subsection (2)(b) authorises the [^{F12}Commission] to take steps to enforce that obligation whenever [^{F13}it] considers it necessary to do so, the [^{F12}Commission] may act accordingly.
- (4) A person who applies to the [^{F14}Commission] under this section shall, so far as that person reasonably can, comply with such regulations as may be made by the Secretary of State with a view to the [^{F14}Commission]^{F15}... being provided with the information which is required to enable—
 - (a) the [^{F2}non-resident parent] to be [^{F16}identified or] traced (where that is necessary);
 - (b) the amount of child support maintenance payable by the [^{F2}non-resident parent] to be assessed; and
 - (c) that amount to be recovered from the [^{F2}non-resident parent].
- (5) Any person who has applied to the [^{F17}Commission] under this section may at any time request [^{F18}it] to cease acting under this section.
- (6) It shall be the duty of the [^{F19}Commission] to comply with any request made under subsection (5) (but subject to any regulations made under subsection (8)).
- (7) The obligation to provide information which is imposed by subsection (4)—
 - (a) shall not apply in such circumstances as may be prescribed; and
 - (b) may, in such circumstances as may be prescribed, be waived by the $[^{\rm F20}{\rm Commission}].$

5 Child support maintenance: supplemental provisions.

(1) Where—

(a) there is more than one person with care of a qualifying child; and

(b) one or more, but not all, of them have parental responsibility for F28 ... the child; no application may be made for a [F3 maintenance calculation] with respect to the child by any of those persons who do not have parental responsibility for F28 ... the child.

- (2) Where more than one application for a [^{F3}maintenance calculation] is made with respect to the child concerned, only one of them may be proceeded with.
- (3) The Secretary of State may by regulations make provision as to which of two or more applications for a [^{F3}maintenance calculation] with respect to the same child is to be proceeded with.

7 Right of child in Scotland to apply for [^{F1}calculation].

- (1) A qualifying child who has attained the age of 12 years and who is habitually resident in Scotland may apply to the [^{F30}Commission] for a [^{F3}maintenance calculation] to be made with respect to him if—
 - (a) no such application has been made by a person who is, with respect to that child, a person with care or [^{F2}a non-resident parent]; ^{F31}...
 - ^{F31}(b)
- (2) An application made under subsection (1) shall authorise the [^{F32}Commission] to make a [^{F3}maintenance calculation] with respect to any other children of the [^{F2}non-resident parent] who are qualifying children in the care of the same person as the child making the application.
- (3) Where a [^{F3}maintenance calculation] has been made in response to an application under this section the [^{F33}Commission] may, if the person with care, the [^{F2}non-resident parent] with respect to whom the [^{F1}calculation] was made or the child concerned applies to [^{F34}it] under this subsection, arrange for—

8 Role of the courts with respect to maintenance for children.

(1) This subsection applies in any case where [^{F47}the [^{F48}Commission]] would have jurisdiction to make a [^{F3}maintenance calculation] with respect to a qualifying child and [^{F2}a non-resident parent] of his on an application duly made ^{F49}... by a person entitled to apply for such [^{F1}a calculation] with respect to that child.

- (2) Subsection (1) applies even though the circumstances of the case are such that [^{F47}the [^{F48}Commission]] would not make [^{F1}a calculation] if it were applied for.

9 Agreements about maintenance.

- (1) In this section "maintenance agreement" means any agreement for the making, or for securing the making, of periodical payments by way of maintenance, or in Scotland aliment, to or for the benefit of any child.
- (2) Nothing in this Act shall be taken to prevent any person from entering into a maintenance agreement.
- (3) [^{F57}Subject to section 4(10)(a) [^{F58}and (ab)] and section 7(10),] the existence of a maintenance agreement shall not prevent any party to the agreement, or any other

person, from applying for a [^{F3}maintenance calculation] with respect to any child to or for whose benefit periodical payments are to be made or secured under the agreement.

- (4) Where any agreement contains a provision which purports to restrict the right of any person to apply for a [^{F3}maintenance calculation], that provision shall be void.

10 Relationship between maintenance [^{F1}calculations] and certain court orders and related matters.

- (1) Where an order of a kind prescribed for the purposes of this subsection is in force with respect to any qualifying child with respect to whom a [^{F3}maintenance calculation] is made, the order—
 - (a) shall, so far as it relates to the making or securing of periodical payments, cease to have effect to such extent as may be determined in accordance with regulations made by the Secretary of State; or
 - (b) where the regulations so provide, shall, so far as it so relates, have effect subject to such modifications as may be so determined.
- (2) Where an agreement of a kind prescribed for the purposes of this subsection is in force with respect to any qualifying child with respect to whom a [^{F3}maintenance calculation] is made, the agreement—
 - (a) shall, so far as it relates to the making or securing of periodical payments, be unenforceable to such extent as may be determined in accordance with regulations made by the Secretary of State; or
 - (b) where the regulations so provide, shall, so far as it so relates, have effect subject to such modifications as may be so determined.
- (3) Any regulations under this section may, in particular, make such provision with respect to—
 - (a) any case where any person with respect to whom an order or agreement of a kind prescribed for the purposes of subsection (1) or (2) has effect applies to the prescribed court, before the end of the prescribed period, for the order or agreement to be varied in the light of the [^{F3}maintenance calculation] and of the provisions of this Act;
 - (b) the recovery of any arrears under the order or agreement which fell due before the coming into force of the [^{F3}maintenance calculation],

as the Secretary of State considers appropriate and may provide that, in prescribed circumstances, an application to any court which is made with respect to an order of a prescribed kind relating to the making or securing of periodical payments to or for the benefit of a child shall be treated by the court as an application for the order to be revoked.

(4) The Secretary of State may by regulations make provision for-

- (a) notification to be given by [^{F61}the [^{F62}Commission]] to the prescribed person in any case where [^{F63}it] considers that the making of a [^{F3}maintenance calculation] has affected, or is likely to affect, any order of a kind prescribed for the purposes of this subsection;
- (b) notification to be given by the prescribed person to the [^{F62}Commission] in any case where a court makes an order which it considers has affected, or is likely to affect, a [^{F3}maintenance calculation].

15 **Powers of inspectors.**



28ZA Decisions involving issues that arise on appeal in other cases

- (1) This section applies where—
 - (a) a decision by the [^{F180}Commission] falls to be made under section 11, 12, 16 or 17 ^{F181}...; and
 - [^{F182}(b) an appeal is pending against a decision given in relation to a different matter by [^{F183}the Upper Tribunal] or a court.]
- (2) If the [^{F180}Commission] considers it possible that the result of the appeal will be such that, if it were already determined, it would affect the decision in some way—
 - (a) [^{F184}it] need not, except in such cases or circumstances as may be prescribed, make the decision while the appeal is pending;
 - (b) [^{F184}it] may, in such cases or circumstances as may be prescribed, make the decision on such basis as may be prescribed.
- (3) Where the [^{F180}Commission] acts in accordance with subsection (2)(b), following the determination of the appeal [^{F184}it] shall if appropriate revise [^{F185}its] decision (under section 16) in accordance with that determination.
- (4) For the purposes of this section, an appeal against a decision is pending if—
 - (a) an appeal against the decision has been brought but not determined;
 - (b) an application for leave to appeal against the decision has been made but not determined; or

28ZB Appeals involving issues that arise on appeal in other cases

- (1) This section applies where—
 - [^{F186}(a) an appeal ("appeal A") in relation to a decision or the imposition of a requirement falling within section 20(1) is made to [^{F187}the First-tier Tribunal, or from the First-tier Tribunal to the Upper Tribunal];] and

 - (a) in a case where appeal A has not been determined by the [^{F193}First-tier Tribunal], revise (under section 16) [^{F194}its] decision which gave rise to that appeal; or
 - (b) in a case where appeal A has been determined by the [^{F195}First-tier Tribunal], make a decision (under section 17) superseding the tribunal's decision.
- (4) Where appeal A is to be dealt with in accordance with this subsection, the [^{F196}First-tier Tribunal or Upper Tribunal] shall either—
 - (a) stay appeal A until appeal B is determined; or

28ZC Restrictions on liability in certain cases of error

- (1) Subject to subsection (2), this section applies where-
 - (a) the effect of the determination, whenever made, of an appeal to [^{F203}the Upper Tribunal] or the court ("the relevant determination") is that the adjudicating authority's decision out of which the appeal arose was erroneous in point of law; and
 - (b) after the date of the relevant determination a decision falls to be made by the [^{F204}Commission] in accordance with that determination (or would, apart from this section, fall to be so made)—
 - (i) with respect to an application for a [^{F3}maintenance calculation] (made after the commencement date) ^{F205}...;
 - (ii) as to whether to revise, under section 16, [^{F206}any decision (made after the commencement date) referred to in section 16(1A)]; or
 - (iii) on an application under section 17 (made after the commencement date) for [^{F207}any decision (made after the commencement date) referred to in section 17(1)].
- (2) This section does not apply where the decision of the [^{F204}Commission] mentioned in subsection (1)(b)—

28J Voluntary payments.

(1) This section applies where—

- (a) a person has applied for a maintenance calculation under section 4(1) or 7(1) $\stackrel{F256}{\dots}$;
- (b) the [^{F257}Commission] has neither made a decision under section 11 or 12 on the application, nor decided not to make a maintenance calculation; and
- (c) the non-resident parent makes a voluntary payment.

(2) A "voluntary payment" is a payment—

30 Collection and enforcement of other forms of maintenance.

31 Deduction from earnings orders.

- (1) This section applies where any person ("the liable person") is liable to make payments of child support maintenance.
- (2) The [^{F273}Commission] may make an order ("a deduction from earnings order") against a liable person to secure the payment of any amount due under the [^{F3}maintenance calculation] in question.
- (3) A deduction from earnings order may be made so as to secure the payment of—
 - (a) arrears of child support maintenance payable under the [^{F1}calculation];
 - (b) amounts of child support maintenance which will become due under the $[^{F1}$ calculation]; or
 - (c) both such arrears and such future amounts.

(4) A deduction from earnings order—

(a) shall be expressed to be directed at a person ("the employer") who has the liable person in his employment; and

(b) shall have effect from such date as may be specified in the order.

(5) A deduction from earnings order shall operate as an instruction to the employer to-

- (a) make deductions from the liable person's earnings; and
- (b) pay the amounts deducted to the $[^{F273}$ Commission].
- (6) The [^{F273}Commission] shall serve a copy of any deduction from earnings order which [^{F274}it] makes under this section on—
 - (a) the person who appears to the [^{F273}Commission] to have the liable person in question in his employment; and
 - (b) the liable person.

(7) Where—

- (a) a deduction from earnings order has been made; and
- (b) a copy of the order has been served on the liable person's employer,

it shall be the duty of that employer to comply with the order; but he shall not be under any liability for non-compliance before the end of the period of 7 days beginning with the date on which the copy was served on him.

32 Regulations about deduction from earnings orders.

- (1) The Secretary of State may by regulations make provision with respect to deduction from earnings orders.
- (2) The regulations may, in particular, make provision-
 - (a) as to the circumstances in which one person is to be treated as employed by another;

- (b) requiring any deduction from earnings under an order to be made in the prescribed manner;
- [^{F275}(bb) for the amount or amounts which are to be deducted from the liable person's earnings not to exceed a prescribed proportion of his earnings (as determined by the employer);]
 - (c) requiring an order to specify the amount or amounts to which the order relates and the amount or amounts which are to be deducted from the liable person's earnings in order to meet his liabilities under the [^{F3}maintenance calculation] in question;
 - (d) requiring the intervals between deductions to be made under an order to be specified in the order;
 - (e) as to the payment of sums deducted under an order to the [F276 Commission];
 - (f) allowing the person who deducts and pays any amount under an order to deduct from the liable person's earnings a prescribed sum towards his administrative costs;
 - (g) with respect to the notification to be given to the liable person of amounts deducted, and amounts paid, under the order;
 - (h) requiring any person on whom a copy of an order is served to notify the [^{F276}Commission] in the prescribed manner and within a prescribed period if he does not have the liable person in his employment or if the liable person ceases to be in his employment;
 - (i) as to the operation of an order where the liable person is in the employment of the Crown;
 - (j) for the variation of orders;
 - (k) similar to that made by section 31(7), in relation to any variation of an order;
 - (1) for an order to lapse when the employer concerned ceases to have the liable person in his employment;
 - (m) as to the revival of an order in such circumstances as may be prescribed;
 - (n) allowing or requiring an order to be discharged;
 - (o) as to the giving of notice by the [^{F276}Commission] to the employer concerned that an order has lapsed or has ceased to have effect.
- (3) The regulations may include provision that while a deduction from earnings order is in force—
 - (a) the liable person shall from time to time notify the [^{F276}Commission], in the prescribed manner and within a prescribed period, of each occasion on which he leaves any employment or becomes employed, or re-employed, and shall include in such a notification a statement of his earnings and expected earnings from the employment concerned and of such other matters as may be prescribed;
 - (b) any person who becomes the liable person's employer and knows that the order is in force shall notify the [^{F276}Commission], in the prescribed manner and within a prescribed period, that he is the liable person's employer, and shall include in such a notification a statement of the liable person's earnings and expected earnings from the employment concerned and of such other matters as may be prescribed.

[^{F278}32A Orders for regular deductions from accounts

(1) If in relation to any person it appears to the Commission-

(a) that the person has failed to pay an amount of child support maintenance; and(b) that the person holds an account with a deposit-taker;

it may make an order against that person to secure the payment of any amount due under the maintenance calculation in question by means of regular deductions from the account.

(2) An order under this section may be made so as to secure the payment of-

- (a) arrears of child support maintenance payable under the calculation;

(1) Where a liability order has been made against a person ("the liable person"), the [^{F287}Commission] may levy the appropriate amount by distress and sale of the liable person's goods.

57 Application to Crown.

- (1) The power of the Secretary of State to make regulations under section 14 requiring prescribed persons to furnish information may be exercised so as to require information to be furnished by persons employed in the service of the Crown or otherwise in the discharge of Crown functions.

(2) A flat rate of a prescribed amount is payable if the nil rate does not apply and—

- (a) the non-resident parent has a partner who is also a non-resident parent;
- (b) the partner is a person with respect to whom a maintenance calculation is in force; and
- (c) the non-resident parent or his partner receives any benefit prescribed under sub-paragraph (1)(c).
- (3) The benefits, pensions and allowances which may be prescribed for the purposes of sub-paragraph (1)(b) include ones paid to the non-resident parent under the law of a place outside the United Kingdom.

Nil rate

The rate payable is nil if the non-resident parent—

5

- (a) is of a prescribed description; or
- (b) has a net weekly income of below £5.

Apportionment

6 (1) If the non-resident parent has more than one qualifying child and in relation to them there is more than one person with care, the amount of child support maintenance payable is (subject to paragraph 7 or 8) to be determined by apportioning the rate between the persons with care.

(2) The rate of maintenance liability is to be divided by the number of qualifying children, and shared among the persons with care according to the number of qualifying children in relation to whom each is a person with care.

Shared care—basic and reduced rate

- 7 (1) This paragraph applies only if the rate of child support maintenance payable is the basic rate or a reduced rate.
 - (2) If the care of a qualifying child is shared between the non-resident parent and the person with care, so that the non-resident parent from time to time has care of the child overnight, the amount of child support maintenance which he would otherwise have been liable to pay the person with care, as calculated in accordance with the preceding paragraphs of this Part of this Schedule, is to be decreased in accordance with this paragraph.
 - (3) First, there is to be a decrease according to the number of such nights which the [^{F407}Commission] determines there to have been, or expects there to be, or both during a prescribed twelve-month period.
 - (4) The amount of that decrease for one child is set out in the following Table—

Number of nights	Fraction to subtract
52 to 103	One-seventh
104 to 155	Two-sevenths
156 to 174	Three-sevenths
175 or more	One-half

- (5) If the person with care is caring for more than one qualifying child of the non-resident parent, the applicable decrease is the sum of the appropriate fractions in the Table divided by the number of such qualifying children.
- (6) If the applicable fraction is one-half in relation to any qualifying child in the care of the person with care, the total amount payable to the person with care is then to be further decreased by £7 for each such child.
- (7) If the application of the preceding provisions of this paragraph would decrease the weekly amount of child support maintenance (or the aggregate of all such amounts) payable by the non-resident parent to the person with care (or all of them) to less than £5, he is instead liable to pay child support maintenance at the rate of £5 a week, apportioned (if appropriate) in accordance with paragraph 6.
