JURISDICTION AND POWERS

[^{F1}Sittings of sheriff and JP courts]

8 *[^{F1}Sittings of sheriff and JP courts].*

- (1) Notwithstanding any enactment or rule of law, a sheriff court or a [^{F2}JP court]—
 - (a) shall not be required to sit on any Saturday or Sunday or on a day which by virtue of subsection (2) or (3) below is a court holiday; but
 - (b) may sit on any day for the disposal of criminal business.
- (2) A sheriff principal may in an order made under [^{F3}section 28(1) of the Courts Reform (Scotland) Act 2014] prescribe in respect of criminal business not more than [^{F4}11] days, other than Saturdays and Sundays, in a calendar year as court holidays in the sheriff courts within his jurisdiction; and may in the like manner prescribe as an additional court holiday any day which has been proclaimed, under section 1(3) of the ^{M1}Banking and Financial Dealings Act 1971, to be a bank holiday either throughout the United Kingdom or in a place or locality in the United Kingdom within his jurisdiction.
- (3) [^{F5}A sheriff principal may] prescribe not more than [^{F4}11] days, other than Saturdays and Sundays, in a calendar year as court holidays in the [^{F6}JP courts] within his jurisdiction; and he may ^{F7}. . . prescribe as an additional holiday any day which has been proclaimed, under section 1(3) of the said Banking and Financial Dealings Act 1971, to be a bank holiday either throughout the United Kingdom or in a place or locality in the United Kingdom within his jurisdiction.
- (4) A sheriff principal may in pursuance of subsection (2) or (3) above prescribe different days as court holidays in relation to different sheriff or [^{F8}JP courts] .
