- (a) compile such information, and
- (b) make such provision for conducting, or assisting the conduct of, research, as may be required for the purpose of providing the Secretary of State ^{F5}..., in such form and at such times as may be prescribed, with such information relating to the provision of primary or secondary education in the area of the [F3]local authority] as may be prescribed.
- (4) The Secretary of State shall exercise his powers under subsection (3) so as to secure, in particular, the provision of information relating to the provision of education for children with special educational needs.
- [^{F6}(4A) In subsection (4) as it applies in relation to the Welsh Ministers, the reference to special educational needs is to be interpreted as a reference to additional learning needs.]
