1997 CHAPTER 50

An Act to make provision for the National Criminal Intelligence Service and the National Crime Squad; to make provision about entry on and interference with property and with wireless telegraphy in the course of the prevention or detection of serious crime; to make provision for the Police Information Technology Organisation; to provide for the issue of certificates about criminal records; to make provision about the administration and organisation of the police; to repeal certain enactments about rehabilitation of offenders; and for connected purposes. [21st March 1997]

Be it enacted by the Queen's most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the authority of the same, as follows:—

The Service Authority

1 The Service Authority for the National Criminal Intelligence Service.

- (1) There shall be a body corporate to be known as the Service Authority for the National Criminal Intelligence Service (in this Part referred to as "the NCIS Service Authority").
- (2) Subject to the following provisions of this section, the NCIS Service Authority shall consist of [FI eleven] members.
- (3) The Secretary of State may by order provide that the number of members shall be a specified odd number greater than [F1eleven].
- (4) Before making an order under subsection (3), the Secretary of State shall consult—
 - (a) the NCIS Service Authority F2...,
 - (b) persons whom the Secretary of State considers to represent the interests of the authorities who between them maintain the police forces in Great Britain and the [F3Police Service of Northern Ireland],
 - (c) persons whom the Secretary of State considers to represent the interests of chief officers of police of police forces in England and Wales, chief constables of police forces in Scotland and the Chief Constable of the [F3Police Service of Northern Ireland], F4...
 - (d) the Commissioners of Customs and Excise.

- (e) the Scottish Ministers.]
- (5) A statutory instrument containing an order under subsection (3) shall be laid before Parliament after being made.
- (6) The NCIS Service Authority may co-opt such additional members as it thinks fit.
- (7) Parts I, II and IV of Schedule 1 and [F8Schedules 2 and 2A] shall have effect in relation to the NCIS Service Authority.

Functions

2 General functions of the NCIS Service Authority and NCIS.

- (1) The NCIS Service Authority shall maintain a body to be known as the National Criminal Intelligence Service (in this Part referred to as "NCIS").
- (2) The functions of NCIS shall be—
 - (a) to gather, store and analyse information in order to provide criminal intelligence,
 - (b) to provide criminal intelligence to police forces in Great Britain, the [F9Police Service of Northern Ireland], the National Crime Squad and other law enforcement agencies, and
 - (c) to act in support of such police forces, the [F9Police Service of Northern Ireland], the National Crime Squad and other law enforcement agencies carrying out their criminal intelligence activities.
- (3) For the purposes of subsection (2), "law enforcement agency" includes—
 - (a) any government department [F10 and the Scottish Administration],
 - (b) the States of Jersey Police Force, the salaried police force of the Island of Guernsey and the Isle of Man Constabulary,
 - (c) any other person charged with the duty of investigating offences or charging offenders, and
 - (d) any other person engaged outside the United Kingdom in the carrying on of activities similar to any carried on by the NCIS Service Authority, NCIS, a police authority, a police force, the NCS Service Authority or the National Crime Squad.
- [FII(3A) NCIS may disclose information for the purposes of Part II of the MIFootball Spectators Act 1989 to any person prescribed by regulations made by the Secretary of State.
 - (3B) A statutory instrument containing regulations under subsection (3A) shall be subject to annulment in pursuance of a resolution of either House of Parliament.
 - (4) In discharging its functions, the NCIS Service Authority shall have regard to—
 - (a) any objectives determined by the Secretary of State under section 26.
 - (b) any objectives determined by the Authority under section 3,
 - (c) any performance targets established by the Authority, whether in compliance with a direction under section 27 or otherwise, and
 - (d) any service plan issued by the Authority under section 4.
 - (5) In discharging any function to which a code of practice issued under section 28 relates, the NCIS Service Authority shall have regard to the code.

(6) The NCIS Service Authority shall comply with any direction given to it by the Secretary of State under section 27 or 30 F12. . . [F13 or by the Scottish Ministers under section 30].

3 Objectives.

- (1) The NCIS Service Authority shall secure that NCIS is efficient and effective.
- (2) The NCIS Service Authority shall, before the beginning of each financial year, determine objectives for that year for NCIS.
- (3) Objectives determined under this section may relate to matters to which objectives determined under section 26 also relate, or to other matters, but in any event shall be so framed as to be consistent with the objectives determined under that section.
- (4) Before determining objectives under this section, the NCIS Service Authority shall consult—
 - (a) the Director General of NCIS,
 - (b) persons whom it considers to represent the interests of the authorities who between them maintain the police forces in Great Britain and the [F14Police Service of Northern Ireland],

4 Service plans.

- (1) The NCIS Service Authority shall, before the beginning of each financial year, issue a plan setting out the proposed arrangements for the carrying out by NCIS of its functions during the year ("the service plan").
- (2) The service plan shall include a statement of the Authority's priorities for the year, of the financial resources expected to be available and of the proposed allocation of those resources, and shall give particulars of—
 - (a) any objectives determined by the Secretary of State under section 26,
 - (b) any objectives determined by the Authority under section 3, and
 - (c) any performance targets established by the Authority, whether in compliance with a direction under section 27 or otherwise.
- (3) A draft of the service plan shall be prepared by the Director General of NCIS and submitted by him to the Authority for it to consider.
- (4) Before issuing a service plan which differs from the draft submitted by the Director General under subsection (3), the Authority shall consult the Director General.
- (5) The Authority shall arrange for every service plan issued by it under this section to be published in such manner as appears to it to be appropriate, and shall send a copy of the plan to—
 - (a) the Secretary of State,
 - (b) each police authority for an area in Great Britain, each joint police board (within the meaning of the M2Police (Scotland) Act 1967) and the [F17Northern Ireland Policing Board],
 - (c) the chief officer of police of each police force in England and Wales, the chief constable of each police force in Scotland and the Chief Constable of the [F18Police Service of Northern Ireland],

Director General and other members

6 Appointment of Director General.

- (1) NCIS shall have a Director General appointed by the [F29Secretary of State] on such terms and conditions as [F30he] considers appropriate.
- [F31(1A) The NCIS Service Authority shall pay to the Director General such remuneration and allowances as the Secretary of State may determine.]
 - (2) The Director General shall be chosen by [F32 the Secretary of State] from a [F33 shortlist] which has been prepared by [F34 a panel of members of the NCIS Service Authority] and approved by the Secretary of State F35 . . .
- [F36(2A)] Where an appointment falls to be made under this section and a list has been approved by the Secretary of State for the purposes of subsection (2), the panel mentioned in that subsection may make, to the Secretary of State, such recommendations as it thinks fit.
- F36(2B) Before making an appointment under this section, the Secretary of State shall—
 - (a) have regard to any recommendations made to him under subsection (2A), and
 - (b) consult the Scottish Ministers.

 - (4) The panel mentioned in subsection (2) shall be convened by the chairman of the NCIS Service Authority and shall consist only of members of that Authority appointed—
 - (a) by the Secretary of State F38..., or

 - (5) The Director General shall, on appointment, be attested as a constable by making a declaration in the form set out in Schedule 4 to the Police Act 1996 before a justice of the peace ^{F41}... in England and Wales.
- [F42(5A) The Director General shall not be attested as a constable under subsection (5) if—
 - (a) he was not a serving police officer immediately before his appointment as Director General took effect; or

- (b) he had already been attested as a constable in England and Wales and still held that office immediately before his appointment took effect.
- (6) Without prejudice to any other enactment conferring powers on constables for particular purposes, the Director General [F43, except in a case where he was not a serving police officer immediately before his appointment took effect,] shall have all the powers and privileges of a constable throughout England and Wales and the adjacent United Kingdom waters.
- (7) The Director General [^{F44}, except in a case where he was not a serving police officer immediately before his appointment took effect,] shall hold the rank of chief constable.
- (8) In subsection (6)—

"powers" includes powers under any enactment, whenever passed or made; "United Kingdom waters" means the sea and other waters within the seaward limits of the territorial sea;

and that subsection, so far as it relates to powers under any enactment, makes them exercisable throughout the United Kingdom waters whether or not the enactment applies to those waters apart from this provision.

9 Members of NCIS.

- (1) NCIS shall consist of—
 - (a) the Director General of NCIS appointed under section 6,
 - (b) persons appointed by the NCIS Service Authority under this paragraph as police members of NCIS, and
 - (c) other persons appointed by the NCIS Service Authority under this paragraph to be members of NCIS as employees of the Authority.
- (2) A person shall be appointed as a police member of NCIS only if—

Functions of Director General

10 General function of Director General.

- (1) NCIS shall be under the direction and control of the Director General.

- (1) The NCIS Service Authority may appoint officers and employees to enable it to discharge its functions.

- (1) The NCIS Service Authority shall, before the beginning of each financial year, submit to the Secretary of State a budget statement for that year.

- (4) If the NCIS Service Authority is directed to submit an action plan, that authority shall direct the Director General of NCIS to prepare a draft of it and to submit it to the NCIS Service Authority for that authority to consider.
- (5) The NCIS Service Authority, on considering a draft action plan submitted to it under subsection (4) may submit the plan to the Secretary of State, with or without modifications.
- (6) If the NCIS Service Authority proposes to make modifications to the draft of the action plan submitted under subsection (4), it must consult with the Director General of NCIS.

34 Inquiries.

- (1) The Secretary of State may cause an inquiry to be held by a person appointed by him into any matter connected with NCIS.
- (2) An inquiry under this section shall be held in public or in private as the Secretary of State may direct.
- (3) For the purposes of an inquiry under this section, the person appointed to hold the inquiry may by summons require any person to attend, at a time and place stated in the summons, to give evidence or to produce any documents in his custody or under his control which relate to any matter in question at the inquiry, and may take evidence on oath, and for that purpose administer oaths.
- (4) No person shall be required, in obedience to a summons under subsection (3), to attend to give evidence or to produce any documents, unless the necessary expenses of his attendance are paid or tendered to him.

- (6) Every person who refuses or deliberately fails to attend in obedience to a summons issued under this section, or to give evidence, or who deliberately alters, suppresses, conceals, destroys, or refuses to produce any book or other document which he is required or is liable to be required to produce for the purposes of this section, shall be liable on summary conviction to a fine not exceeding level 3 on the standard scale or to imprisonment for a term not exceeding six months, or to both.
- (7) Where the report of the person holding an inquiry under this section is not published, a summary of his findings and conclusions shall be made known by the Secretary of State so far as appears to him consistent with the public interest.
- (8) The Secretary of State may direct that the whole or part of the costs (or, in relation to any inquiry held in Scotland, the expenses) incurred by any person for the purposes of an inquiry held under this section shall be defrayed out of the NCIS service fund; and any costs (or expenses) payable under this section shall be subject to taxation in such manner as the Secretary of State may direct.

48 General functions of the NCS Service Authority and the National Crime Squad.



- (1) The Prime Minister [F196 after consultation with the Scottish Ministers], shall appoint for the purposes of this Part—
 - (a) a Chief Commissioner, and
 - (b) such number of other Commissioners as the Prime Minister thinks fit.

No entry on or interference with property or with wireless telegraphy shall be unlawful if it is authorised by an authorisation having effect under this Part.

- (1) Where a person gives, renews or cancels an authorisation, he shall, as soon as is reasonably practicable and in accordance with arrangements made by the Chief Commissioner, give notice in writing that he has done so to a Commissioner appointed under section 91(1)(b).

98 Matters subject to legal privilege.

- (1) Subject to subsection (5) below, in section 97 "matters subject to legal privilege" means matters to which subsection (2), (3) or (4) below applies.

109 Police Information Technology Organisation.

Arrangements for discharge of functions by Service Authorities

- 5 (1) Each Service Authority may arrange for the discharge of any of its functions by a committee, a sub-committee or an officer of the Authority.
 - (2) Where by virtue of this paragraph any functions of an Authority may be discharged by a committee of the Authority, then, unless the Authority otherwise directs, the committee may arrange for the discharge of any of those functions by a subcommittee or an officer of the Authority.
 - (3) Where by virtue of this paragraph any functions of an Authority may be discharged by a sub-committee of the Authority, then, unless the Authority or the committee otherwise directs, the sub-committee may arrange for the discharge of any of those functions by an officer of the Authority.
 - (4) Any arrangements made by an Authority, a committee or sub-committee under this paragraph shall not prevent it from exercising the functions concerned.
- 6 (1) A Service Authority may discharge any of its functions jointly with—
 - (a) the other Service Authority;
 - (b) one or more police authorities; or
 - (c) the other Service Authority and one or more police authorities.
 - (2) Where such arrangements ("joint arrangements") are in force, the parties to the arrangements may also provide for the discharge of those functions by a joint committee of theirs or by an officer of one of them.
 - (3) Where, under sub-paragraph (2), joint arrangements provide that functions may be discharged by a joint committee, then, unless the parties to the arrangements otherwise direct, that committee may arrange for the discharge of any of those functions by a sub-committee of the joint committee or an officer of one of the parties to the arrangements.
 - (4) Where joint arrangements are in force, any enactment relating to the functions to which the arrangements relate or to the authorities by whom or the areas in respect of which they are to be discharged shall have effect subject to all necessary modifications in respect of its application in relation to those functions and the authorities by whom and the areas in respect of which (whether in pursuance of the arrangements or otherwise) they are to be discharged.
 - (5) For the purposes of sub-paragraph (1) "police authorities" means—
 - (a) police authorities for areas in England and Wales;
 - (b) police authorities for areas in Scotland; and
 - (c) the Northern Ireland Policing Board.
- References in paragraphs 5 and 6 to the discharge of any of the functions of a Service Authority include references to the doing of anything which is calculated to facilitate, or is conducive or incidental to, the discharge of any of those functions.
- 8 (1) For the purposes of paragraphs 5 and 6, "officer"—
 - (a) in relation to the NCIS Service Authority, means the Director General of NCIS, his deputy while performing the duties of the Director General and any person employed by the Authority; and
 - (b) in relation to the NCS Service Authority, means the Director General of the National Crime Squad, his deputy while performing the duties of the Director General and any person employed by the Authority.

- (2) Where pursuant to arrangements made by virtue of paragraph 5 or 6 the Director General of NCIS, or his deputy, may discharge functions of the NCIS Service Authority, he may arrange for the discharge of any of those functions by any other member of NCIS.
- (3) Where pursuant to arrangements made by virtue of paragraph 5 or 6 the Director General of the National Crime Squad, or his deputy, may discharge functions of the NCS Service Authority, he may arrange for the discharge of any of those functions by any other member of that Squad.

Interpretation

- 9 In this Schedule "Service Authority" means—
 - (a) the NCIS Service Authority, or
 - (b) the NCS Service Authority.]

THE POLICE INFORMATION TECHNOLOGY ORGANISATION

Constitution

- 1 (1) [F456 Subject to sub-paragraph (2A)] The Police Information Technology Organisation ("the Organisation") shall consist of a chairman and other members appointed by the Secretary of State [F456] or, where so provided in sub-paragraph (3) below, the Scottish Ministers].

 - (i) at least one shall be appointed by the Secretary of State;
 - (ii) at least one shall be appointed by the Secretary of State after consultation with the Scottish Ministers; and
 - (iii) at least one shall be appointed by the Scottish Ministers.]


