Supplementary

74 Amendments, transitional provisions, repeals, etc.

- (1) The statutory provisions mentioned in Schedule 4 shall be amended as provided in that Schedule.
- (2) Schedule 5 (which contains transitional provisions and savings) shall have effect.
- (3) The statutory provisions mentioned in Schedule 6 are repealed to the extent specified in the third column of that Schedule.
- (4) In the ^{MI}Northern Ireland (Modification of Enactments No. 1) Order 1973 the following provisions are revoked, namely—
 - (a) Article 6(5) and (6)(c);
 - (b) in Schedule 1, the entries relating to
 - the ^{M2}Constabulary (Ireland) Act 1836;
 - the ^{M3}Police (Property) Act 1897;
 - the ^{M4}Constabulary and Police (Ireland) Act 1919;

 - the ^{M6}Constabulary Act Northern Ireland) 1922;
 - the ^{M7}Police Act Northern Ireland) 1970;
 - (c) in Schedule 4, the entry relating to the ^{M8}Police Act Northern Ireland) 1970; and
 - (d) in Schedule 5, paragraphs 11, 21 and 61.
