U.K.

An Act to make provision about competition and the abuse of a dominant position in the market; to confer powers in relation to investigations conducted in connection with [FI Article 81 or 82] of the treaty establishing the European Community; to amend the Fair Trading Act 1973 in relation to information which may be required in connection with investigations under that Act; to make provision with respect to the meaning of "supply of services" in the Fair Trading Act 1973; and for connected purposes.

Be it enacted by the Queen's most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the authority of the same, as follows:—

CHAPTER I U.K.

AGREEMENTS

Introduction

1 Enactments replaced. U.K.

The following shall cease to have effect—

- (a) the Restrictive Practices Court Act 1976 (c. 33),
- (b) the Restrictive Trade Practices Act 1976 (c. 34),
- (c) the Resale Prices Act 1976 (c. 53), and
- (d) the Restrictive Trade Practices Act 1977 (c. 19).

The prohibition

2 Agreements etc. preventing, restricting or distorting competition. U.K.

- (1) Subject to section 3, agreements between undertakings, decisions by associations of undertakings or concerted practices which—
 - (a) may affect trade within the United Kingdom, and
 - (b) have as their object or effect the prevention, restriction or distortion of competition within the United Kingdom,

are prohibited unless they are exempt in accordance with the provisions of this Part.

- (2) Subsection (1) applies, in particular, to agreements, decisions or practices which—
 - (a) directly or indirectly fix purchase or selling prices or any other trading conditions;
 - (b) limit or control production, markets, technical development or investment;
 - (c) share markets or sources of supply:
 - (d) apply dissimilar conditions to equivalent transactions with other trading parties, thereby placing them at a competitive disadvantage;
 - (e) make the conclusion of contracts subject to acceptance by the other parties of supplementary obligations which, by their nature or according to commercial usage, have no connection with the subject of such contracts.
- (3) Subsection (1) applies only if the agreement, decision or practice is, or is intended to be, implemented in the United Kingdom.
- (4) Any agreement or decision which is prohibited by subsection (1) is void.
- (5) A provision of this Part which is expressed to apply to, or in relation to, an agreement is to be read as applying equally to, or in relation to, a decision by an association of undertakings or a concerted practice (but with any necessary modifications).

- (6) Subsection (5) does not apply where the context otherwise requires.
- (7) In this section "the United Kingdom" means, in relation to an agreement which operates or is intended to operate only in a part of the United Kingdom, that part.
- (8) The prohibition imposed by subsection (1) is referred to in this Act as "the Chapter I prohibition".

3 Excluded agreements. U.K.

- (1) The Chapter I prohibition does not apply in any of the cases in which it is excluded by or as a result of—
 - (a) Schedule 1 (mergers and concentrations);
 - (b) Schedule 2 (competition scrutiny under other enactments);
 - (c) Schedule 3 (planning obligations and other general exclusions). F2...
 - ^{F3}(d)
- (2) The Secretary of State may at any time by order amend Schedule 1, with respect to the Chapter I prohibition, by—
 - (a) providing for one or more additional exclusions; or
 - (b) amending or removing any provision (whether or not it has been added by an order under this subsection).
- (3) The Secretary of State may at any time by order amend Schedule 3, with respect to the Chapter I prohibition, by—
 - (a) providing for one or more additional exclusions; or
 - (b) amending or removing any provision—
 - (i) added by an order under this subsection; or
 - (ii) included in paragraph 1, 2, 8 or 9 of Schedule 3.
- (4) The power under subsection (3) to provide for an additional exclusion may be exercised only if it appears to the Secretary of State that agreements which fall within the additional exclusion—
 - (a) do not in general have an adverse effect on competition, or
 - (b) are, in general, best considered under Chapter II or [F4the MIFair Trading Act 1973][F4the Enterprise Act 2002].
- (5) An order under subsection (2)(a) or (3)(a) may include provision (similar to that made with respect to any other exclusion provided by the relevant Schedule) for the exclusion concerned to cease to apply to a particular agreement.

Exemptions

4 Individual exemptions. U.K.

- [F5(1) The [F6OFT] may grant an exemption from the Chapter I prohibition with respect to a particular agreement if—
 - (a) a request for an exemption has been made to [F6it] under section 14 by a party to the agreement; and
 - (b) the agreement is one to which section 9 applies.
 - (2) An exemption granted under this section is referred to in this Part as an individual exemption.
 - (3) The exemption—
 - (a) may be granted subject to such conditions or obligations as the [F6OFT] considers it appropriate to impose; and
 - (b) has effect for such period as the [F6OFT] considers appropriate.
 - (4) That period must be specified in the grant of the exemption.
 - (5) An individual exemption may be granted so as to have effect from a date earlier than that on which it is granted.
 - (6) On an application made in such way as may be specified by rules under section 51, the [F6OFT] may extend the period for which an exemption has effect; but, if the rules so provide, [F6it] may do so only in specified circumstances.]

5 Cancellation etc. of individual exemptions. U.K.

- [F7(1) If the [F8OFT] has reasonable grounds for believing that there has been a material change of circumstance since [F8it] granted an individual exemption, [F8it] may by notice in writing—
 - (a) cancel the exemption;
 - (b) vary or remove any condition or obligation; or
 - (c) impose one or more additional conditions or obligations.
 - (2) If the [F8OFT] has a reasonable suspicion that the information on which [F8it] based [F8its] decision to grant an individual exemption was incomplete, false or misleading in a material particular, [F8it] may by notice in writing take any of the steps mentioned in subsection (1).
 - (3) Breach of a condition has the effect of cancelling the exemption.
 - (4) Failure to comply with an obligation allows the [F8OFT], by notice in writing, to take any of the steps mentioned in subsection (1).
 - (5) Any step taken by the [F8OFT] under subsection (1), (2) or (4) has effect from such time as may be specified in the notice.
 - (6) If an exemption is cancelled under subsection (2) or (4), the date specified in the notice cancelling it may be earlier than the date on which the notice is given.
 - (7) The [F8OFT] may act under subsection (1), (2) or (4) on [F8its] own initiative or on a complaint made by any person.]

6 Block exemptions. U.K.

- (1) If agreements which fall within a particular category of agreement are, in the opinion of the [FOFT], likely to be [FIO exempt agreements], the [FOFT] may recommend that the Secretary of State make an order specifying that category for the purposes of this section.
- (2) The Secretary of State may make an order ("a block exemption order") giving effect to such a recommendation—
 - (a) in the form in which the recommendation is made; or

- (b) subject to such modifications as he considers appropriate.
- (3) An agreement which falls within a category specified in a block exemption order is exempt from the Chapter I prohibition.
- (4) An exemption under this section is referred to in this Part as a block exemption.
- (5) A block exemption order may impose conditions or obligations subject to which a block exemption is to have effect.
- (6) A block exemption order may provide—
 - (a) that breach of a condition imposed by the order has the effect of cancelling the block exemption in respect of an agreement;
 - (b) that if there is a failure to comply with an obligation imposed by the order, the [F9OFT] may, by notice in writing, cancel the block exemption in respect of the agreement;
 - (c) that if the [F9OFT] considers that a particular agreement is not [F11an exempt agreement], [F12it] may cancel the block exemption in respect of that agreement.
- (7) A block exemption order may provide that the order is to cease to have effect at the end of a specified period.
- [F13(8) In this section—

"exempt agreement" means an agreement which is exempt from the Chapter I prohibition as a result of section 9; and

"specified" means specified in a block exemption order.

7 Block exemptions: opposition. U.K.

[F14(1) A block exemption order may provide that a party to an agreement which—

- (a) does not qualify for the block exemption created by the order, but
- (b) satisfies specified criteria,

may notify the [F15OFT] of the agreement for the purposes of subsection (2).

- (2) An agreement which is notified under any provision included in a block exemption order by virtue of subsection (1) is to be treated, as from the end of the notice period, as falling within a category specified in a block exemption order unless the [F15OFT]—
 - (a) is opposed to its being so treated; and

- (b) gives notice in writing to the party concerned of [F15its] opposition before the end of that period.
- (3) If the [F15OFT] gives notice of [F15its] opposition under subsection (2), the notification under subsection (1) is to be treated as both notification under section 14 and as a request for an individual exemption made under subsection (3) of that section.
- (4) In this section "notice period" means such period as may be specified with a view to giving the [F15OFT] sufficient time to consider whether to oppose under subsection (2).]

8 Block exemptions: procedure. U.K.

- (1) Before making a recommendation under section 6(1), the [F16OFT] must—
 - (a) publish details of [F17its] proposed recommendation in such a way as [F17it] thinks most suitable for bringing it to the attention of those likely to be affected; and
 - (b) consider any representations about it which are made to [F17it].
- (2) If the Secretary of State proposes to give effect to such a recommendation subject to modifications, he must inform the [F16OFT] of the proposed modifications and take into account any comments made by the [F16OFT].
- (3) If, in the opinion of the [F16OFT], it is appropriate to vary or revoke a block exemption order [F18it] may make a recommendation to that effect to the Secretary of State.
- (4) Subsection (1) also applies to any proposed recommendation under subsection (3).
- (5) Before exercising [F17its] power to vary or revoke a block exemption order (in a case where there has been no recommendation under subsection (3)), the Secretary of State must—
 - (a) inform the [F16OFT] of the proposed variation or revocation; and
 - (b) take into account any comments made by the [F16OFT].
- (6) A block exemption order may provide for a block exemption to have effect from a date earlier than that on which the order is made.

10 Parallel exemptions. U.K.

- (1) An agreement is exempt from the Chapter I prohibition if it is exempt from the Community prohibition—
 - (a) by virtue of a Regulation, [F24] or
 - (b) because of a decision of the Commission under Article 10 of the EC Competition Regulation.]
- (2) An agreement is exempt from the Chapter I prohibition if it does not affect trade between Member States but otherwise falls within a category of agreement which is exempt from the Community prohibition by virtue of a Regulation.
- (3) An exemption from the Chapter I prohibition under this section is referred to in this Part as a parallel exemption.
- (4) A parallel exemption—

CHAPTER III U.K.

Investigations

[F4225 Power of OFT to investigate U.K.

- (1) In any of the following cases, the OFT may conduct an investigation.
- (2) The first case is where there are reasonable grounds for suspecting that there is an agreement which—
 - (a) may affect trade within the United Kingdom; and

- (7) The sixth case is where there are reasonable grounds for suspecting that, at some time in the past, there was an agreement which at that time—
 - (a) may have affected trade between Member States; and
 - (b) had as its object or effect the prevention, restriction or distortion of competition within [F43the European Union].
- (8) Subsection (2) does not permit an investigation to be conducted in relation to an agreement if the OFT—
 - (a) considers that the agreement is exempt from the Chapter I prohibition as a result of a block exemption or a parallel exemption; and
 - (b) does not have reasonable grounds for suspecting that the circumstances may be such that it could exercise its power to cancel the exemption.

65F Power to enter business premises without a warrant U.K.

- (1) Any officer of the OFT who is authorised in writing by the OFT to do so ("an investigating officer") may enter any business premises in connection with an Article 22(1) investigation.
- (2) No investigating officer is to enter any premises in the exercise of his powers under this section unless he has given to the occupier of the premises a written notice which—

 - (c) to take possession of any documents appearing to be of the relevant kind if—
 - (i) such action appears to be necessary for preserving the documents or preventing interference with them; or
 - (ii) it is not reasonably practicable to take copies of the documents on the premises;

- (b) evidence relating to it is adduced, or a question relating to it is asked, by him or on his behalf.

65L Offences U.K.

 - (b) a recognised investment exchange, or
 - (c) a recognised clearing house,

to the extent to which the decision relates to any of that body's regulating provisions or specified practices.

- (5) The Chapter I prohibition does not apply to the specified practices of—
 - (a) a recognised self-regulating organisation, a recognised investment exchange or a recognised clearing house; or
 - (b) a person who is subject to—
 - (i) the rules of one of those bodies, or
 - (ii) the statements of principle, rules, regulations or codes of practice made by a designated agency in the exercise of functions transferred to it by a delegation order.
- (6) The Chapter I prohibition does not apply to any agreement the parties to which consist of or include—
 - (a) a recognised self-regulating organisation, a recognised investment exchange or a recognised clearing house; or
 - (b) a person who is subject to—
 - (i) the rules of one of those bodies, or
 - (ii) the statements of principle, rules, regulations or codes of practice made by a designated agency in the exercise of functions transferred to it by a delegation order,

to the extent to which the agreement consists of provisions the inclusion of which is required or contemplated by any of the body's regulating provisions or specified practices or by the statements of principle, rules, regulations or codes of practice of the agency.

- (7) The Chapter I prohibition does not apply to—
 - (a) any clearing arrangements; or
 - (b) any agreement between a recognised investment exchange and a recognised clearing house, to the extent to which the agreement consists of provisions the inclusion of which in the agreement is required or contemplated by any clearing arrangements.
- (8) If the recognition order in respect of a body of the kind mentioned in subsection (1)(a), (b) or (c) above is revoked, subsections (1) and (4) to (7) above are to have effect as if that body had continued to be recognised until the end of the period of six months beginning with the day on which the revocation took effect.
- (9) In this section—

"the Chapter I prohibition" means the prohibition imposed by section 2(1) of the Competition Act 1998;

"regulating provisions" means—

- (a) in relation to a self-regulating organisation, any rules made, or guidance issued, by the organisation;
- (b) in relation to an investment exchange, any rules made, or guidance issued, by the exchange;
- (c) in relation to a clearing house, any rules made, or guidance issued, by the clearing house;

"specified practices" means—

- (a) in the case of a recognised self-regulating organisation, the practices mentioned in section 119(2)(a)(ii) and (iii) above (read with section 119(5) and (6)(a));

EEA Regulated Markets

Chairmen of groups

The Chairman must appoint one of the members of a group to act as the chairman of the group.

Replacement of member of group



EXTENDING THE TRANSITIONAL PERIOD

TERMINATING THE TRANSITIONAL PERIOD

Circumstances in which the Director may terminate the transitional period

 - (ii) if later, the date on which the further appeal is disposed of or withdrawn.
 - (4) Otherwise, the application is not determined until the expiry of the period within which any party to the application would have been able to bring an appeal against the decision on the application had this Act not been passed.
 - (5) Any amendment made by Schedule 12 to this Act which substitutes references to a relevant Court for references to the Court is not to affect proceedings of the kind referred to in sub-paragraph (1).

Undertakings

- 43 (1) Subject to sub-paragraph (2), an undertaking accepted by the Director under section 4 or 9 of the M87Competition Act 1980 ceases to have effect on the coming into force of the repeal by this Act of that section.

Disclosure of information

- 45 (1) Section 55 of this Act applies in relation to information which, immediately before the starting date, is subject to section 41 of the RTPA as it applies in relation to information obtained under or as a result of Part I.
 - (2) But section 55 does not apply to any disclosure of information of the kind referred to in sub-paragraph (1) if the disclosure is made—
 - (a) for the purpose of facilitating the performance of functions of a designated person under the M88 Control of Misleading Advertisements Regulations 1988; or
 - (b) for the purposes of any proceedings before the Court or of any other legal proceedings under the RTPA or the M89 Fair Trading Act 1973 or the Control of Misleading Advertisements Regulations 1988.
 - (3) Section 56 applies in relation to information of the kind referred to in subparagraph (1) if particulars containing the information have been entered or filed on the special section of the register maintained by the Director under, or as a result of, section 27 of the RTPA or paragraph 10 of this Schedule.

(4) Section 55 has effect, in relation to the matters as to which section 41(2) of the RTPA had effect, as if it contained a provision similar to section 41(2).
