### *Powers to gather information*

#### **165 [F<sup>1</sup>Regulators] power to require information [F<sup>2</sup>: authorised persons etc].**

- (1) [F<sup>3</sup>Either regulator] may, by notice in writing given to an authorised person, require him—
  - (a) to provide specified information or information of a specified description; or
  - (b) to produce specified documents or documents of a specified description.
- (2) The information or documents must be provided or produced—
  - (a) before the end of such reasonable period as may be specified; and
  - (b) at such place as may be specified.
- (3) An officer who has written authorisation from the [F<sup>4</sup>regulator] to do so may require an authorised person without delay—
  - (a) to provide the officer with specified information or information of a specified description; or
  - (b) to produce to him specified documents or documents of a specified description.
- (4) This section applies only to
  - [F<sup>5</sup>(a)] information and documents reasonably required in connection with the exercise by [F<sup>6</sup>either regulator] of functions conferred on it by or under this Act [F<sup>7</sup>, and
  - (b) in relation to the exercise by the PRA of the powers conferred by subsections (1) and (3), information and documents reasonably required by the Bank of England in connection with the exercise by the Bank of its functions in pursuance of its financial stability objective.]
- (5) [F<sup>8</sup>The regulator in question] may require any information provided under this section to be provided in such form as it may reasonably require.
- (6) [F<sup>9</sup>The regulator in question] may require—
  - (a) any information provided, whether in a document or otherwise, to be verified in such manner, or
  - (b) any document produced to be authenticated in such manner,as it may reasonably require.
- (7) The powers conferred by subsections (1) and (3) may also be [F<sup>10</sup>exercised—
  - (a) by either regulator, to impose requirements on a person who is connected with an authorised person;
  - (b) by the FCA, to impose requirements on an operator, trustee or depositary of a scheme recognised under section F<sup>11</sup>... 272 who is not an authorised person;
  - (c) by the FCA, to impose requirements on a recognised investment exchange;
  - (d) by the FCA, to impose requirements on a person who is connected with a recognised investment exchange.]
  - [F<sup>12</sup>(e) by either regulator, to impose requirements on a person who provides any service to an insurance undertaking, reinsurance undertaking or third-country insurance undertaking.]
- (8) “Authorised person” includes a person who was at any time an authorised person but who has ceased to be an authorised person.

  - (b) a controller of A;
  - (c) any other member of a partnership of which A is a member; or
  - (d) in relation to A, a person mentioned in Part I of Schedule 15 [<sup>F18</sup>(reading references in that Part to the authorised person as references to A)].

### **[<sup>F19</sup>165A][<sup>F20</sup>PRA's] power to require information: financial stability**

- (1) The [<sup>F21</sup>PRA] may, by notice in writing given to a person to whom this section applies, require the person—
  - (a) to provide specified information or information of a specified description; or
  - (b) to produce specified documents or documents of a specified description.
- (2) This section applies to—
  - (a) a person who has a legal or beneficial interest in any of the assets of a relevant investment fund;
  - (b) a person who is responsible for the management of a relevant investment fund;
  - (c) a person (a “service provider”) who provides any service to an authorised person;
  - (d) a person prescribed by an order made by the Treasury or any person of a description prescribed by such an order (and see also section 165C);
  - (e) a person who is connected with a person to whom this section applies as a result of any of the above paragraphs.
- (3) This section applies only to
  - [<sup>F22</sup>(a)] information and documents that the [<sup>F21</sup>PRA] considers are, or might be, relevant to the stability of one or more aspects of the UK financial system [<sup>F23</sup>, and
  - (b) information and documents reasonably required by the Bank of England in connection with the exercise by the Bank of its functions in pursuance of its financial stability objective.]
- (4) A notice may be given to a service provider, or to a person who is connected with a service provider, only if the [<sup>F21</sup>PRA] considers that—

### 165B Safeguards etc in relation to exercise of power under section 165A

- (1) If the [<sup>F27</sup>PRA] proposes to impose a requirement on a person under section 165A, it must give the person a notice in writing warning the person that the [<sup>F27</sup>PRA] is proposing to impose the requirement.
- (2) The notice under subsection (1) must—
  - (a) give the [<sup>F28</sup>PRA's] reasons for proposing to impose the requirement; and

#### **169 Investigations etc. in support of overseas regulator.**

### *Conduct of investigations*

#### **170 Investigations: general.**

- (1) This section applies if an investigating authority appoints one or more competent persons (“investigators”) under section 167 or 168(3) or (5) to conduct an investigation on its behalf.
- (2) The investigating authority must give written notice of the appointment of an investigator to the person who is the subject of the investigation (“the person under investigation”).

- (7) The investigating authority may, by a direction to an investigator, control—
- (a) the scope of the investigation;

## 171 Powers of persons appointed under section 167.

**174 Admissibility of statements made to investigators.**

## **175 Information and documents: supplemental provisions.**

- (1) If [<sup>F91</sup>either regulator] or an investigator has power under this Part to require a person to produce a document but it appears that the document is in the possession of a third person, that power may be exercised in relation to the third person.
- (2) If a document is produced in response to a requirement imposed under this Part, the person to whom it is produced may—
  - (a) take copies or extracts from the document; or
  - (b) require the person producing the document, or any relevant person, to provide an explanation of the document.
- [<sup>F92</sup>(2A) A document so produced may be retained for so long as the person to whom it is produced considers that it is necessary to retain it (rather than copies of it) for the purposes for which the document was requested.

  - (a) he is the person under investigation or a member of that person's group;

  - (c) the person to whom the obligation of confidence is owed consents to the disclosure or production; or
  - (d) the imposing on him of a requirement with respect to such information or document has been specifically authorised by the investigating authority.

## 176 Entry of premises under warrant.

- (1) A justice of the peace may issue a warrant under this section if satisfied on information on oath given by or on behalf of the Secretary of State, [<sup>F95</sup>either regulator] or an investigator that there are reasonable grounds for believing that the first, second or third set of conditions is satisfied.
- (2) The first set of conditions is—
  - (a) that a person on whom an information requirement has been imposed has failed (wholly or in part) to comply with it; and
  - (b) that on the premises specified in the warrant—
    - (i) there are documents which have been required; or
    - (ii) there is information which has been required.
- (3) The second set of conditions is—
  - (a) that the premises specified in the warrant are premises of an authorised person or an appointed representative;
  - (b) that there are on the premises documents or information in relation to which an information requirement could be imposed; and
  - (c) that if such a requirement were to be imposed—
    - (i) it would not be complied with; or
    - (ii) the documents or information to which it related would be removed, tampered with or destroyed.

  - (a) that an offence mentioned in section 168 for which the maximum sentence on conviction on indictment is two years or more has been (or is being) committed by any person;
  - (b) that there are on the premises specified in the warrant documents or information relevant to whether that offence has been (or is being) committed;

  - (d) that if such a requirement were to be imposed—
    - (i) it would not be complied with; or
    - (ii) the documents or information to which it related would be removed, tampered with or destroyed.

  - (a) to enter the premises specified in the warrant;
  - (b) to search the premises and take possession of any documents or information appearing to be documents or information of a kind in respect of which a warrant under this section was issued (“the relevant kind”) or to take, in relation to any such documents or information, any other steps which may

## [<sup>F103</sup> 176A] Retention of documents taken under section 176

- (1) Any document of which possession is taken under section 176 (“a seized document”) may be retained so long as it is necessary to retain it (rather than copies of it) in the circumstances.
- (2) A person claiming to be the owner of a seized document may apply to a magistrates' court or (in Scotland) the sheriff for an order for the delivery of the document to the person appearing to the court or sheriff to be the owner.

## Offences

### 177 Offences.
