#### [<sup>F1</sup>204A Meaning of “relevant requirement” and “appropriate regulator”

- (1) The following definitions apply for the purposes of this Part.
- (2) “Relevant requirement” means a requirement imposed—
- (a) by or under this Act, <sup>F2</sup>...
- <sup>F3</sup>(aa) [ by regulations under section 11 of the Civil Liability Act 2018,]
- <sup>F4</sup>(ab) [ by or under the Securitisation Regulations 2024,]
- (b) by a [<sup>F5</sup>qualifying provision] specified, or of a description specified, for the purposes of this subsection by the Treasury by order [<sup>F6</sup>, <sup>F7</sup> ...

If the [<sup>F18</sup>appropriate regulator] considers that an authorised person has contravened [<sup>F19</sup>a relevant requirement imposed on the person, it may] publish a statement to that effect.

## 206 Financial penalties.

- (1) If the [<sup>F20</sup> appropriate regulator] considers that an authorised person has contravened [<sup>F21</sup>a relevant requirement imposed on the person,] it may impose on him a penalty, in respect of the contravention, of such amount as it considers appropriate.
- (2) <sup>F22</sup> . . . . .
- (3) A penalty under this section is payable to the [<sup>F23</sup>regulator that imposed the penalty].

## [<sup>F24</sup>206A] Suspending permission to carry on regulated activities etc

- (1) If the [<sup>F25</sup> appropriate regulator] considers that an authorised person has contravened a relevant requirement imposed on the person, it may—

- (a) suspend, for such period as it considers appropriate, any permission which the person has to carry on a regulated activity; or
- (b) impose, for such period as it considers appropriate, such limitations or other restrictions in relation to the carrying on of a regulated activity by the person as it considers appropriate.

[ The power conferred by subsection (1) is also exercisable by the FCA if it considers <sup>F26</sup>(1A) that an authorised person has contravened a requirement imposed on the person by—

- (a) the Payment Services Regulations [<sup>F27</sup>2017], or
- (b) the Electronic Money Regulations 2011.]

[ The power conferred by subsection (1) may not be exercised in relation to a <sup>F28</sup>(1B) contravention of a requirement imposed under section 122A, 122B, 122C, 122G, 122H, 122I, [<sup>F29</sup>122IA,] 123A or 123B.]

(2) In subsection (1)—

“ permission ” means any permission that the authorised person has, whether given (or treated as given) by [<sup>F30</sup>the FCA or the PRA] or conferred by any provision of this Act;

- (3) The period for which a suspension or restriction is to have effect may not exceed 12 months.
- (4) A suspension may relate only to the carrying on of an activity in specified circumstances.
- (5) A restriction may, in particular, be imposed so as to require the person concerned to take, or refrain from taking, specified action.
- (6) The [<sup>F32</sup>appropriate regulator] may—
  - (a) withdraw a suspension or restriction; or
  - (b) vary a suspension or restriction so as to reduce the period for which it has effect or otherwise to limit its effect.
- (7) The power under this section may (but need not) be exercised so as to have effect in relation to all the regulated activities that the person concerned carries on.
- (8) Any one or more of the powers under—
  - (a) subsection (1)(a) and (b) of this section, and
  - (b) sections 205 and 206,
 may be exercised in relation to the same contravention.]

## 211 Statements of policy: procedure.

- (1) Before [<sup>F61</sup>a regulator issues] a statement under section 210, the [<sup>F62</sup>regulator] must publish a draft of the proposed statement in the way appearing to the [<sup>F62</sup>regulator] to be best calculated to bring it to the attention of the public.
- (2) The draft must be accompanied by notice that representations about the proposal may be made to the [<sup>F63</sup>regulator] within a specified time.
- (3) Before issuing the proposed statement, the [<sup>F63</sup>regulator] must have regard to any representations made to it in accordance with subsection (2).
- (4) If the [<sup>F63</sup>regulator] issues the proposed statement it must publish an account, in general terms, of—
  - (a) the representations made to it in accordance with subsection (2); and
  - (b) its response to them.
- (5) If the statement differs from the draft published under subsection (1) in a way which is, in the opinion of the [<sup>F64</sup>regulator], significant, the [<sup>F64</sup>regulator] must (in addition to complying with subsection (4)) publish details of the difference.
- (6) [<sup>F65</sup>A regulator] may charge a reasonable fee for providing a person with a copy of a draft published under subsection (1).
- (7) This section also applies to a proposal to alter or replace a statement.
