### 115 Persons with [F1special educational needs]

- (1) The [F2Secretary of State] must, in performing [F3functions under this Part], have regard to the needs of persons with [F4special educational needs] to whom this section applies.
- (2) This section applies to—
  - (a) persons who are aged 19 or over, other than persons aged under 25 [F5 for whom an EHC plan is maintained], and
  - (b) persons who are subject to adult detention.
