POLICE AND CRIME COMMISSIONERS: ELECTIONS AND VACANCIES

Elections: further provision

75 The appropriate officer

- (1) For each police area, other than the metropolitan police district, the Secretary of State^{F1}... must by order designate a local authority.
- (2) In this Chapter, the “appropriate officer”, [^{F2}means—
 - (a) in relation to a police area in England, the head of paid service of the local authority designated for that police area;
 - (b) in relation to a police area in Wales, the chief executive of the local authority designated for that police area.]
- (3) In this section—
 - [^{F3}“chief executive” means the person appointed by a county council or county borough council in Wales under section 54 of the Local Government and Elections (Wales) Act 2021;]
 - “local authority” means—
 - (a) a district council,
 - (b) a county council in England for a county in which there are no district councils,

(c) the Council of the Isles of Scilly,

“head of paid service”, in relation to a council [^{F4}in England], means the person designated by the council under section 4(1)(a) of the Local Government Act 1989.
